



Investment Professional And Author Is Sentenced For Defrauding National Women's Sorority

A Florida woman was sentenced to 24 months in prison for her role in an investment management scheme.

Acting Assistant Attorney General Brian C. Rabbitt of the Justice Department's Criminal Division, U.S. Attorney James Douglas Overbey of the U.S. Attorney's Office for the Eastern District of Tennessee,

and Assistant Director in Charge Steven D'Antuono of the FBI's Washington Field Office made the announcement.

Cheryl Broussard, 63, of Miami, Florida, was sentenced on November 5, 2020 in the U.S. District Court for the Eastern District of Tennessee by Chief Judge Gregory N. Stivers of the Western District of Kentucky.

Judge Stivers also ordered the defendant to pay \$106,000 in restitution and \$106,000 in forfeiture. Broussard pleaded guilty on Aug. 14, 2019, to one count of wire fraud.

Veterans Day as we know it wasn't always called "Veterans Day." It began as a commemoration of Armistice Day, the day when the fighting stopped during World War I.

What was then thought to be the "war to end all wars" formally ceased on the eleventh hour of the eleventh day of the eleventh month. And in November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day. A Congressional Act in 1938 made the 11th of November a legal holiday.

On June 1, 1954, November 11th became a day to honor American Veterans of all wars. Later that year, President Dwight D. Eisenhower issued the first "Veterans Day Proclamation."

Ryan Whitlow, 34, Pathkiller Trail Loudon, was charged with DUI, and Driving on Roadway Ianed for Traffic.

According to the report, Deputy Clay Jenkins LCSO, conducted a traffic stop on a gray Volkswagen Jetta at the intersection of Hwy 11 and Poplar St after observing vehicle leave its lane of travel almost striking a vehicle head on.

Deputy then made contact with driver Ryan Whitlow and observed Mr. Whitlow to be very lethargic and disoriented but did not observe the smell of alcohol.

Deputy also observed Mr. Whitlow's windshield to be busted with damage to the front end. Mr. Whitlow advised that wood had fell off a truck and struck his ve-

hicle but did not want a report. Deputy Caleb Green responded and due to Deputy Green's certification in ARIDE he requested Mr. Whitlow to perform ARIDE and Standard Field Sobriety Testing in which Mr. Whitlow agreed.

Mr. Whitlow advised he suffered from a back injury and was unable to maintain balance. Deputy Green advised Mr. Whitlow gave several clues of impairment on HGN and gave several indications of impairment during ARIDE testing. Mr. Whitlow was then taken into custody and transported to the Fort Loudoun Medical Center for a blood draw.

After giving blood, Mr. Whitlow was then transported to the Loudon County Jail.

herself as a financial professional with over two decades of experience in investment management and fiscal independence for women. As part of her plea, Broussard admitted to entering into an investment agreement with a professional women's sorority pursuant to which she would manage \$100,000 of the sorority's funds in February 2015. Beginning in June 2015, Broussard sent regular investment portfolio reports to the sorority purporting to detail investments in securities. Unbeknownst to the sorority, Broussard had used its funds for personal expenses, and the periodic reports were fake. Broussard admitted that, when the sorority noticed inconsistencies in the periodic reports and sought to terminate the agreement,

she fabricated a termination penalty that appeared to be part of the original agreement to prevent the sorority from going forward with the termination. When the sorority eventually terminated the agreement, Broussard failed to remit any funds to the sorority.

This case was investigated by the Federal Bureau of Investigation. Trial Attorney Michelle Pascucci of the Criminal Division's Fraud Section and Assistant U.S. Attorney Frank M. Dale are prosecuting the case.

The Criminal Division's Fraud Section plays a pivotal role in the Department of Justice's fight against white collar crime around the country.
