Deputy stopped the test due to Schacher stating he has been having trouble with his leg, from a surgery. Deputy ask if he could search the vehicle. Deputy located a open glass with a alcoholic beverage smell and a unmarked bottle of pills identified as Hydrocodone. Schacher admitted to drinking and smoking marijuana. Ryan Schacher was placed

under arrest and transported to the Loudon County Jail.

As Chief Operating Officer, Gannon produced federal Form W-2s for all CPA employees. Gannon prepared her own W-2s which substantially reduced the actual compensation she took from CPA.

terminated Gannon's employment on August 17, 2019. In May 2020, the Wilson County Grand Jury indicted Emily Crabtree Gannon on one count of theft over \$250,000, two counts of forgery, and one count of criminal simulation.



Robert Perkins, 53, Popular Street Loudon, was charged with Public Intoxication, Open Container, Simple Possession x4, and Mfg/ Del/Sale or Poss. of Meth. Officer A. Bialek LCPD, was dispatched to Hwy 321 to a suspicious black vehicle with a male asleep inside. Upon arrival Officer made contact with the male identified as Robert Perkins asleep in the vehicle. Perkins had red glossy eyes, slow slurred speech, and kept falling asleep while Officer was trying to speak with him. Officer told Perkins to exit the vehicle and told him to place his hands behind his back, Perkins did not comply with Officer's commands, and began to approach Officer and tensed up. Officer was able to place Perkins into custody. The owner of the vehicle arrived on scene and gave Officer consent to search. During the search Officer located an open container of alcohol in the floorboard, and a black draw string bag with a baggy of meth, 20 yellow capsules (gabapentin), 1 orange capsule(gabapentin), white pill (gabapentin), and 3 orange pills (clonazepam) inside the black bag. Robert Perkins was transported to the Loudon County Jail.

Upon contact with the male identified Christopher Cheatham, he seemed very nervous, and shaking uncontrollably. Officer ask Cheatham if he had anything illegal on his person he stated no.

Cheatham consented to a search Officer located a syringe, yellow pill identified as clonzapam and a suboxone strip.

Cheatham stated he had shot up suboxone earlier. Cheatham was very unsteady on his feet, and had glossy eyes. Christopher Cheatham was placed under arrest and transported to the Loudon County Jail.
