
The company contacted the FBI and got to work on both restoring their data and assisting in the investigation. Fortunately, the company had a robust backup system, so employees restored the data within days.

Additionally, the company shared critical information from its network's access logs and other records,

which helped the FBI track the IP address of the hacker. After getting a search warrant based on that information, agents found overwhelming evidence against Kight in his San Clemente, California home.

"In the cyber world, it's very hard to secure a network to the point that it's never breachable, but you can make it as difficult as possible to break in," Fowler

If someone does break into a network, having strong activity logging on the network in place beforehand can help authorities track the hacker.

The cooperation from the victim company was critical in this case.

Kight December, pleaded guilty to extortion, computer fraud, and wire fraud. He was sentenced in March to more than seven years in prison.

Fowler said it was clear that Kight was perfecting his hacking skills, and there would have been more victims had he not been caught and prosecuted. Imposing consequences on hackers who do harm to companies and individuals is vital.

"I've arrested people all over the world for these types of crimes," Fowler explained. "The FBI is uniquely positioned to address these crimes almost anywhere they happen."

Houston County EMS Director Indicted After Being Paid Improperly

Director Double-Dipped on Time and Manipulated Hours Worked

The Tennessee Comptroller's Office has completed an investigation resulting in the indictment of Stephen Graybill, the director of Houston County Emergency Medical Services. The investigation began after county officials reported information to the Comptroller's Office.

The investigation focused on compensation that Graybill received from July 1, 2017 through June 30, 2019. During this time, Graybill not only served as director, but he also worked as an AEMT on ambulance shifts (re-

sponding to emergency calls) to help with staffing shortages. The former Houston County Mayor verbally authorized Graybill to receive pay for the hours he worked on ambulance shifts in addition to his monthly director salary.


Investigators determined that Graybill received \$22,230.36 in

improper payments.

Some of this money (\$7,579.46) was paid to Graybill because he claimed to have worked as the director and an AEMT as the same time – a practice of double-dipping time. Investigators reviewed time sheets showing Graybill claimed to have worked 725.5 hours as both the director and an AEMT.

The remaining improper payments (\$14,650.90) were received by Graybill after he manipulated the hours he worked between the director and AEMT positions. Graybill would manipulate his director hours by working weekends or shorter work weeks. At the same time, he worked excess hours as an AEMT. Graybill was paid a salary for his director position, so this practice allowed him to earn unnecessary and additional hourly compensation as an AEMT. Graybill also could have chosen to work ambulance shifts as part of his director duties.

Comptroller investigators also identified \$20,308.23 in questionable payments received by Graybill. Although Graybill is a licensed AEMT, he paid himself at a higher 'paramedic' pay rate. He also received questionable compensation related to unsupported hours and noncompliance with the EMS holiday pay policy.
