## CDC data show disproportionate COVID-19 impact in American Indian/Alaska Native populations

## Investigation Update On Peaches

CDC has updated its food safety alert for a Salmonella illness outbreak linked to peaches:

CDC provides more than \$200 million to address COVID-19 health disparities in Indian Country

and ethnic minority groups at highest risk from the disease. CDC found that in 23 selected states, the cumulative incidence of laboratory-confirmed COVID-19 cases among AI/AN was 3.5 times that of non-Hispanic whites.

The Centers for Disease Control and Prevention (CDC) released a new study that specifically examines how COVID-19 is affecting American Indians and Alaska Natives (AI/AN) — one of the racial

These data also showed that AI/AN who tested positive for SARS-CoV-2

Prima Wawona has expanded its recall external icon to include bulk/loose peaches sold throughout August 3. Previously, the company had recalled peaches sold in bags.

Several other companies have recalled peaches or food made with them, including Aldi, Food Lion, Hannaford, Kroger, and

affiliated retailers, Target, Walmart, and Wegmans.

Russ David Wholesale has recalled peach salsa and gift baskets made with recalled Prima Wawona peaches. Recalled peach salsa was sold under three brand names and labeled as




to conduct the test, he was commanded to follow instructions and he refused. He was then placed into custody. Upon a vehicle inventory, three cold to the touch 12oz Corona Extras were found in the trunk.

Deputy transported him to the Loudon County Jail, once we arrived Deputy gave him another opportunity to conduct field sobriety testing and he consented. He performed the testing poorly as instructed.

Mr. Guillen was then read the Implied consent form, he had no issue speaking English and understating it but he advised he did not understand English very well and was given a Spanish form. He refused consent and signed the English form. Based on my training and experience and the result of field sobriety,

Deputy believed Ruben Guillen to be intoxicated and he was charged with driving under the influence. Due to Mr. Guillen refusing to consent to blood or breath he was charged with violation of implied consent.

The white Honda Accord belonging to Mr. Guillen was inventoried and towed from the scene by Malones.



tended to be younger than white non-Hispanic individuals with COVID-19 infection. Compared to whites, a higher percentage of cases among AI/AN individuals were in people under 18 years of age (12.9 percent AI/AN; 4.3 percent white), and a smaller percentage of cases were among AI/AN 65 years or older (12.6 percent AI/AN; 28.6 percent white). Limited data were available to quantify the disparity in COVID-19 incidence, COVID-19 disease severity, and outcomes among AI/AN persons compared with those among other racial/ethnic groups, reinforcing the need to prioritize improved data collection as a key strategy to understand and improve health outcomes.

Recent CDC studies have shown that AI/AN are among the racial and ethnic minority groups at higher risk for se-


vere COVID-19 outcomes. Persisting racial inequity and historical trauma have contributed to disparities in health and socioeconomic factors between AI/AN and white populations that have adversely affected tribal communities. The elevated incidence within this population might also reflect differences in reliance on shared transportation, limited access to running water, household size, and other factors that might facilitate community transmission.

Funding to address COVID-19 disparities

CDC, using a multifaceted approach, has provided more than \$200 million in COVID-19 funding to Indian Country, which will support tribes and tribal organizations in carrying out COVID-19 preparedness and response activities, including surveillance, epidemiology, laboratory capacity, infection see COVID pg. 5





If you have loose peaches and can't tell where they're from, throw them out.

This outbreak has sickened 78 people in 12 states.

Twenty-three people have been hospitalized; no deaths have been reported.

This investigation is ongoing to identify other retailers that may have been sold contaminated peaches.

About Salmonella:

Most people infected with Salmonella develop diarrhea, fever, and stomach cramping 6 hours to 6 days after eating contaminated food.

The illness usually lasts 4 to 7 days, and most people recover without treatment.

See your healthcare provider if you are concerned about symptoms, such as high fever (temperature over 102°F), blood in your poop,

diarrhea, or frequent vomiting that prevents keeping liquid down.

“American Indian and Alaska Native people have suffered a disproportionate burden of COVID-19 illness

during the pandemic,” said mental Appropriation Act, CDC Director Robert R. 2020, and the Coronavirus Redfield, M.D. “This funding approach will broaden access to COVID-19 resources across tribal communities.”
