



and boating was no exception. The TWRA reported a noticeable increase in traffic on the state's lakes and rivers.

Preliminary numbers indicate about 30 percent of the 2020 fatal incidents had alcohol/drugs as a contributing factor. In additions to the fatalities, there were 61 serious injury incidents that injured 82 individuals and 82 additional property damage incidents.

During the year, TWRA wildlife officers made 62 boating under the influence (BUI) arrests. With the increase traffic, calls for service saw a leap. TWRA officers strive to practice social distancing to help protect the public as the pandemic continues.

As the new year is underway, TWRA wildlife officers would encourage the boating

public to help keep Tennessee waterways safe by doing things such as:

- 1) Take a boater safety course.
- 2) Wear your life jacket while out on the water.
- 3) Be aware of the water above and below.
- 4) Always boat with a sober
- 5) Report unsafe operation, boat accidents, or law violations to your nearest TWRA dispatch center.





Eric Tipton, 31, Nichols Road Lenoir City, was charged with Violation of Order of Protection x2, and Interfere with Emergency Call.

Deputy W. Jenkins LCSO, responded to a domestic disturbance at Nichols Rd.

When Deputy arrived on scene he made contact with complainant, victim 1, and victim 2, on the porch. They advised Deputy that Eric Tipton, offender, was inside high on meth and acting crazy. The victims also advised Deputy that the offender had a pocket knife.

Victim one also advised Deputy that when she picked up the landline to call 911 the offender picked up the other landline and made the line

busy in an attempt to interfere with the victim calling to report the emergency. Victim one had to physically remove the phone from the offender in order to call. Deputy entered the house where he made contact with the offender, detained him. and took his pocket knife away. The offender was profusely sweating despite the cool temperature, and had mannerisms consistent with meth intoxication.



The COVID19.tn.gov website provides a simple tool for Tennesseans to find their phase in Tennessee's COVID-19 Vaccination Plan. Updates to this tool make it easier for eligible users to request a vaccination appointment with their county health department. Find the tool at https://covid19. tn.gov/covid-19-vaccines/eligibility/.

The website also offers an interactive map where Tennesseans can select their county to learn the risk-based and age-based phases currently eligible for COVID-19 vaccination and how to request a vaccination appointment.
