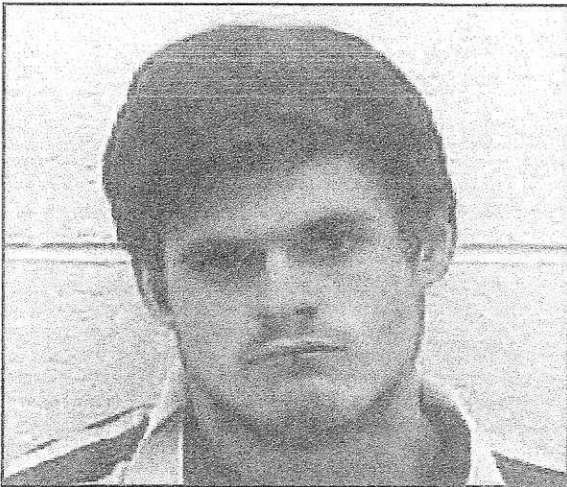

Two Former Knoxville Utilities Board Employees Cheated on Time

Employees were paid more than \$10,000 for time they did not work

An investigation by the Tennessee Comptroller's Office found that two former employees of the Knoxville Utilities Board (KUB) received compensation totaling at least \$10,595 for time they did not work.

The investigation began after KUB reported questionable compensation pay-

ments to the Comptroller's Office. Investigators were able to use time sheets, schedules, calendars, electronic badge records, and other documentation to review the employees' actual time worked.

Investigators found that a former engineering associate was paid at least \$7,854

by falsely reporting at least 365 hours he did not work between February 2016 and November 2018 — when he resigned from his employment. In July 2019, the former employee reimbursed KUB for the amount he was paid but did not work.

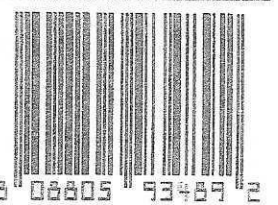
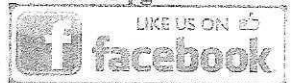

Jordan Frank, 21, Gibson Road Madisonville, was charged with DUI, Simple Possession, and Possession of Drug Para.

Deputy Rogers LCSO, observed a truck pass me at a high rate of speed while on Hwy 72. Deputy confirmed the speed of the vehicle to be 76mph in a 55mph zone by RADAR. Deputy initiated a traffic stop in the area of Grove Street and made contact with the driver/offender Mr. Jordan Frank.

Mr. Frank had exaggerated movements, a clinched jaw and would not make eye contact with this Deputy. Deputy had the offender exit the vehicle and while speaking with him he advised he might have meth on his person. Deputy did recover a small black container that concealed crystalized residue. Deputy also recovered a blue

straw and pipe with crystalized residue within both. Mr. Frank did admit to snorting meth within the hour and was in route to a friends house. The offender did consent to S.F.S.T and A.R.I.D.E testing and performed poorly. A second employee, who worked as a student worker, was paid at least \$2,741 by falsely reporting at least 196 hours he did not work between November 2018 and May 2019. KUB terminated his employment in May 2019, and he subsequently reimbursed KUB for the amount he was paid but did not work.

The results of the investigation have been communicated with the Office of the District Attorney General of the 6th Judicial District.

“While KUB supervisors took the appropriate step of signing the time sheets for these employees, they should have also reviewed for accuracy,” said Comptroller Jason Mumpower. “Time sheets should only reflect the actual time worked. By not performing a careful review,

a risk of improper payments is created.”



Jacob Brewington, 18, Whitewing Road Lenoir City, was charged with Aggravated Burglary, Vandalism, Violation of Alcoholic Beverage Law, and Poss. Of Drug Para.

Deputy E. Brown LCSO, was dispatched to Woodlawn Road to a report of breaking and entering of a fifth wheel camper and vandalism to the interior.

Upon arrival Deputy was advised by the owner/victim, that someone had pried open the door and screen door to his camper and had been living in it. Someone had also broken the vent in the bathroom ceiling, the DVD player, and the master bed. He stated that a male had permission to stay in a small camper parked next to his fifth wheel camper and

that the male and a friend had made entry into the fifth wheel camper. He also stated that the friend had left his truck parked at his camper and the two were gone but on their way back.
