## Medical Equipment Packaging Company Hacker Sentenced

Disgruntled Former Employee Disrupted Shipments of Needed PPE During Pandemic

When the COVID-19 pandemic reached the United States last spring, a Georgia-based medical equipment packaging company worked to get personal protective equipment (PPE) to medical workers treating sick patients.

But a disgruntled former employee thwarted those efforts at a time when protective equipment was desperately needed.

Christopher Dobbins, a vice-president in the company who'd been fired a few weeks earlier, still had a secret account on the company's computer system that he'd created

before he was fired. Although the employer revoked his access, Dobbins used this secret account to get back into the company's computer system from his home in late March. Once in the network, he changed or deleted critical data

Brittney Byrge, 25, Medford Lane Rocky Top, was charged with Man/Sell/Del/Resale Sch. I, and Poss. Of Drug Para.

Elizabeth Baird, 19, Deer Ridge Norris, was charged with DUI, Man/Sell/Del/Resale Sch. I, and Violation of Implied Consent.

Deputy L. Hawkins LCSO, was dispatched to Oak Chase Boulevard in reference to a suspicious vehicle. The caller advised it was a white passenger car. Deputy arrived in the area and observed a vehicle fitting the description turning off of Oak Chase Boulevard onto Highway 70 East, heading toward Highway 321. The vehicle was a White Chevrolet Impala, it was traveling 15 miles under the speed limit, an indication of an impaired driver.

Once we reached Old

Hickory Lane, the vehicle drove past the turn lane and immediately turned left onto Old Hickory Lane. Deputy conducted a traffic stop when the vehicle pulled into Old Hickory Lane.

Deputy made contact with the driver, Elizabeth Baird, her speech was slurred and she had glossy eyes, when she was asked to step out of the vehicle she had trouble keeping her balance and was swaying. Deputy asked Mrs. Baird if she had drank anything or if she had taken any prescription medication/narcotics and she advised she had not. She also advised she did not live at the residence she had pulled into, that she

was lost. She consented to S.F.S.T. and it was unsatisfactory. She also consented to A.R.I.D.E. conducted by Dep. B. Persterfield, he advised me it was also unsatisfactory. Mrs. Baird refused to give a blood sample for testing when she was read the Implied Consent form. Deputy then made contact with the passenger, Brittney Byrge. Deputy and Dep. C. Rogers noticed she was attempting to place something inside the front of her pants to conceal it. She was asked to step out of the vehicle, she then advised she was hiding a needle and a dime bag of "blue powder". Mrs. Byrge stated it was given to her as "Xanax", she then stated there

was several more needles in the vehicle. Approximately .61 Grams of a Blue Power substance was taken from Mrs. Byrge's person. Upon searching the vehicle a silver spoon, burnt on the bottom was found in Mrs. Byrge's bag along with several needles. In the pocket on the back side of the drivers seat, a unmarked pill bottle was found with .88 Grams of a blue powder substance inside. Mrs. Byrge stated it was not hers but it was the same substance found on her person. Elizabeth Baird was asked if the substance belonged to her and she also stated it was not hers. Both subjects stated it was a male's who had left it in the car. Officer

R. Miller 447 with Lenoir City Police Department arrived on scene to conduct a field test kit on the blue substance, it showed as Heroin. Based on the driving, S.F.S.T., A.R.I.D.E., and my training and experience, Deputy believed Elizabeth Baird to be under the influence of narcotics and she was taken into

custody for DUI, Violation of Implied Consent, and Possession of Schedule 1. Based on evidence recovered from Brittney Byrge's person and her property on the vehicle, she was taken into custody for Possession of Schedule 1 and Possession of Drug Paraphernalia. This did occur in Loudon County, Tennessee.

## Gun



Upon arrival, Officer Pistole and Deland made contact with the female standing outside the residence. As they approached her, She appeared to be intoxicated and unsteady. On the ground at her feet were several 40.cal bullets and broken parts to a pistol magazine. She was detained until further investigation. Officer went inside and spoke with the complainant/victim. 
When she gets drunk, she becomes very violent. She stated punching victim and

that the company needed to function, such as shipping information. It delayed the company's ability to send out shipments of PPE.

"It was both a chance for the company to contribute to the national response and a business opportunity," said Special Agent Roderick Coffin, who investigated the case out of the FBI's Atlanta Field Office.

The company quickly figured out its systems had been breached and alerted the FBI. The company's operations ground to a halt briefly, and disruptions continued for months.

The FBI Atlanta Cyber Task Force gathered evidence that showed Dobbins was behind the hack. He pleaded guilty to computer intrusion charges in July 2020 and was sentenced to one year in prison in October 2020.

"Given the pandemic, it was especially urgent that we figure out what happened and ensure there was no continuing compromise," Coffin said. "We also wanted to make a statement that the FBI and the U.S. Attorney's Office are going to investigate and prosecute these types of crimes."

In this case, like so many cyber cases the FBI investigates, a collaborative relationship with the victim company was key to success.

"In computer intrusion cases, the crime scenes are the systems in these companies' offices, and we need their assistance to process that in a way it's admissible in court," Coffin said. "The FBI works very hard to proactively establish trust with companies,

so when these types of things occur, we can quickly figure out what happened, and they can move forward."


