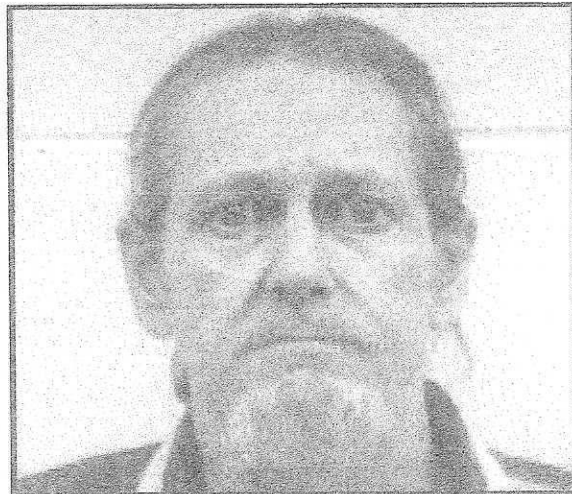

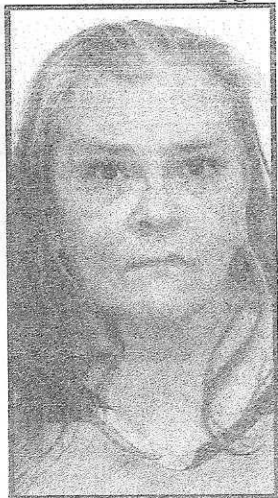

Knoxville Man Pleads Guilty To Murder-For-Hire Charge

Nelson Paul Replogle, 59, of Knoxville, Tennessee, entered a guilty plea to one count of Murder-For-Hire in violation of Title 18, United States Code, Section 1595. Replogle pleaded guilty before Senior United States District Judge Leon Jordan of the U.S. District Court for the Eastern

District of Tennessee. Sentencing has been set for February 22, 2022, at 10:15 a.m., in U.S. District Court at Knoxville, Tennessee.

As a result of his guilty plea, Replogle faces a term of up to ten years imprisonment, a fine of up to \$250,000, and supervised release for a period of three years.

As part of the written plea agreement, Replogle waived indictment by a federal grand jury and agreed to plead guilty to an information. According to documents filed in the case, Replogle admitted to using the Internet to contact a dark web entity that purported to arrange

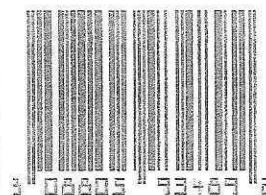

Vandalism

Ebony Hudson, 30, Cedar Street Loudon, was charged with Vandalism, Disorderly Conduct, and Assault.

Dep D Slemple LCSO, was dispatched by Loudon Co 911 to Tellico Village Wellness Center, Dohi Dr, for a report of a subject vandalizing the business. On my arrival Deputy made contact with the manager of the facility. He reported the offender Ebony Hudson is an employee who entered the facility and destroyed two ceramic planters in the vestibule. She then moved to the front desk and began pulling computers, monitors and other items from the desk and threw them to the floor. Hudson then picked up a computer monitor and threw it, striking victim and employee victim in her back. Hudson then left the front desk area and returned

with a full pot of coffee, then poured it over electronic and paper items still on the desk, then threw the glass coffee pot to the ground. Hudson then left the building on foot. Witnesses of the event provided written statements. Video surveillance footage from the wellness center was obtained from the Tellico Village POA. With body camera active, the video footage was viewed with manager and he identified/confirmed Ebony Hudson as the individual damaging the property. Complainant reported the estimate of damage to computer and electronic equipment is \$2934.00. The immediate area was searched by Dep M. Stanley - 921 with no success in finding Hudson. CID Sgt A Parton 905 was contacted and advised. Ebony Hudson was arrested at the Loudon County Sheriff Office.

murders for hire. Replogle provided the would-be killer with the intended victim's name and address, a description of the victim's vehicle, and a specific date, time, and place where the victim could be found and murdered. In addition, Replogle asked that the killing appear as "road rage or [a] carjacking gone wrong." In exchange for the anticipated murder, Replogle used the Internet to transmit a payment of 0.2924549 Bitcoin which, on the day of payment, had the approximate value of \$17,853.49. Agents with the Federal Bureau of Investigation ("FBI") learned of the plot and intervened and arrested the defendant. The victim was not harmed as a result of the defendant's attempt to have the victim murdered.

This prosecution is the result of an investigation by the FBI.

Assistant United States Attorney Frank M. Dale Jr. represents the United States *Man Found Under Tree at Dollar General by LPD* Truman Chapman, 45, Steekee Creek Road Loudon, was charged with Public Intoxication.

Officer Finch LPD, was dispatched to the Dollar General for a suspicious person. Upon arrival Officer

made contact with a male, whom was later identified as Truman Chapman, sleeping under a tree. As Officer began speaking with Mr. Chapman he could smell a strong order of an alcoholic beverage coming from his breath and person. Mr. Chapman also had very watery eyes and stated he has drank a couple of beers. The clerk at the store did find several 24 ounces beer cans in a shopping cart. Mr. Chapman was placed into custody and transported to the Loudon

County Jail. All of the above did happen in the City of Loudon..

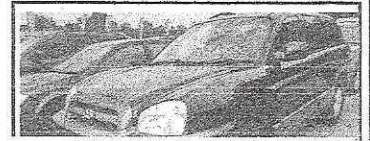

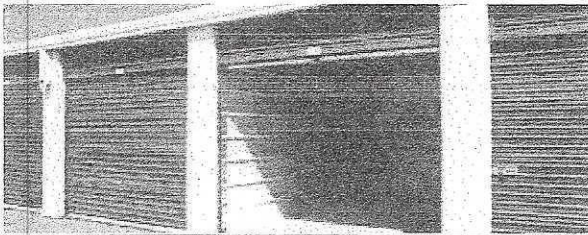

Timothy Presley, 55, Vonore Road Loudon, was charged with DUI, Violation of Implied Consent, Driving on Roadway Laned for Traffic, Mfg/Del/Sale or Possession of Meth, and Poss. Of Drug Para.

Deputy Rogers LCSO, observed a minivan stationary on Watkins Rd at Hwy 72 for a prolonged period of time. Deputy followed the vehicle as it turned on to Hwy 72 and noted it was traveling 40mph in a 55mph zone and crossed the center line. Deputy initiated a traffic stop at Wade Rd W. and made contact with the driver, Mr. Tim Presley. The driver had a flushed complexion, constricted pupils and Deputy observed Crown Royal liquor in the back seat. Deputy asked Mr. Presley to exit the vehicle and upon further conversation he did consent to SFST/ARIDE testing. Mr. Presley did fail the test, see

Mr. Presley did refuse a blood draw and was transported to the Loudon County Jail.
