

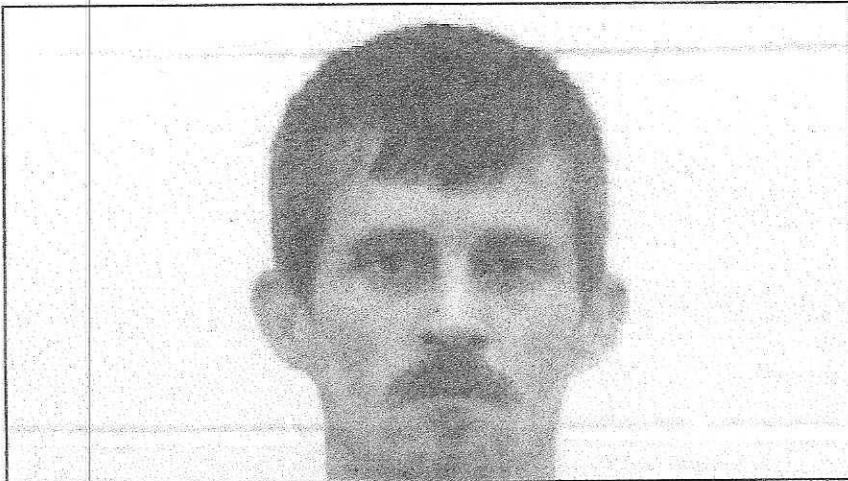

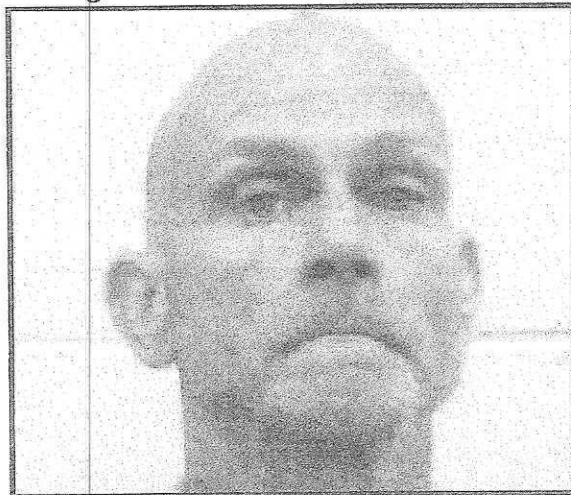

88 Million Americans at Risk for Type 2 Diabetes Can Change Their Outcome

When detected early, prediabetes can be reversed.

Prediabetes can be reversed – and the American Medical Association (AMA), the Centers for Disease Control and Prevention (CDC), and the Ad Council want people to know it.

Type 2 diabetes is one of the chronic health conditions that poses a significant risk for complications to those who contract COVID-19. A recent study external icon showed type 2 diabetes is one of the top

comorbidities associated with COVID-19 severity and deaths.[1]

That's why the AMA, the CDC, and the Ad Council have launched a series of new public service announcements (PSAs) taking a serious look at prediabetes – a condition that if left unchecked often leads to type 2 diabetes.

As part of the "Do I Have Prediabetes?" external icon campaign, the new "Change the

Outcome" PSAs, created pro bono by creative agencies Grey and Wordsworth+Booth, raise awareness that prediabetes shouldn't be taken lightly – and that it can be reversed. The "Change the Outcome" campaign includes a complementary suite of new print, radio, out-of-home, and digital banner assets that compare the risk of prediabetes to much less

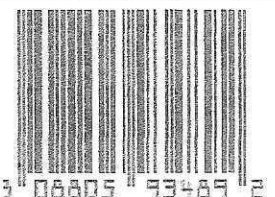

Justin Boggess, 28, Watson Road Maryville, was charged with Man/Sell/Del/Resale Sch. VI, and Poss. of Drug Para.

Officer R. Miller LCPD, was conducting a patrol south bound on Highway 321 in Lenoir City. While observing traffic Officer noticed a black in color Chevy Cobalt in the center lane of traffic. While observing the vehicle Officer noticed the window tint on the vehicle was dark to the point that you could not see into the vehicle. As Officer got behind the vehicle it made a sudden lane change at which time Officer followed. The vehicle again changed lanes and then pulled into a parking lot where Officer conducted a traffic stop for a window tint violation (windows registered at 2% and 3%). Upon

traffic stop Officer made contact with, Justin Boggess, driver and, female passenger. Officer had BOGGESS step out of the vehicle to speak with him about a citation. While speaking with BOGGESS Officer noticed that he appeared nervous due to his body language and short answers. Located inside of the center console of the vehicle were two large bags containing a green leafy substance believed to be marijuana, and a digital scale that had marijuana residue located on it. Also located in BOGGESS'S pocket was around \$400 in US Currency. The total amount of marijuana located was 32.44 Grams. Based on Of-

ficer training and experience the amount of marijuana, the digital scale, and cash all showed indicators that BOGGESS was gaining illegal proceeds by selling SCH VI marijuana. BOGGESS was arrested and transported to the Loudon County Jail.

"Life sometimes grants us an opportunity to make small changes that can have profound effects on the trajectory of our health and our lives," said Christopher Holliday, PhD, MPH, director of the Division of Diabetes Translation at the Centers for Disease Control and Prevention. "Diabetes affects every part of the body and can lead to a cascade of negative health outcomes, significantly impacting a person's quality of life. A prediabetes diagnosis sounds the alarm, letting people know that they need to change course and take the opportunity to prevent this devastating disease before it's too late."

In the United States, some 88 million Americans — more than 1 in 3 — are living with prediabetes, and more than 84% don't even know they have it. Prediabetes can increase a person's risk of developing type 2 diabetes, heart disease, and stroke. Research shows that once people are made aware of their condition, they are more likely to


make the necessary long-term lifestyle changes, such as eating healthier, managing weight, and being active, that can help prevent or delay the onset of type 2 diabetes.

"Raising awareness of prediabetes and stressing the importance of people knowing their risk is critical, particularly now as the COVID-19 pandemic amplifies the negative health risks associated with chronic health conditions," said AMA President Gerald E. Harmon, MD. "Through our latest campaign, we aim to help more of the millions of Americans living with prediabetes find out whether they have the condition. Anyone who learns through the online test that they may be at risk for prediabetes should consult their physician right away to confirm a prediabetes diagnosis and learn how making lifestyle changes can help them keep type 2 diabetes at bay."

The new multiplatform communications campaign shows how prediabetes can be reversed through individual lifestyle changes and encourages audiences to visit [DoIHavePre-](http://DoIHavePre-diabetes.org)

diabetes.org/external/icon — PodriaTenerPrediabetes.com — where they can take a one-minute risk test to determine if they are at risk for prediabetes. If someone receives a high-risk score, the campaign encourages them to speak with their doctor to first confirm a diagnosis of prediabetes, then enroll in CDC's National Diabetes Prevention Program.


"In light of the COVID-19 pandemic, this new phase of our type 2 diabetes awareness work takes a more serious tone than past efforts to emphasize the importance of an early prediabetes diagnosis," said Heidi Arthur, chief campaign development officer at the Ad Council. "Our aim remains the same as we equip people with the tools to both find out where they stand and take steps towards a healthier lifestyle."

Christopher Meir, 36, Old Midway Road Lenoir City, was charged with DUI, and Violation of Implied Consent.

Deputy Stanley LCSO, responded to a call regarding a reckless driver traveling on I75 South near the 72 mile marker. Deputy was advised by dispatch that multiple callers on the interstate were calling in advising the vehicle in question was all over the roadway, and ended up in the median. A short time later, Deputy was advised that the vehicle then ended up in the northbound lanes, and ended up striking a guard rail.

Upon my arrival to the scene Deputy observed the vehicle (08 Mitsubishi Eclipse) wrecked out in the middle of both lanes. Money-makers Wrecker Service was already on scene about to load the vehicle. Deputy observed the driver (Christopher Meier) standing around the vehicle. Meier advised that he was traveling North bound when his vehicle malfunctioned causing him to lose control and crashing into the guardrail. Deputy observed Meier to be very anxious and his eyes to be bloodshot. Based on call information relayed to Deputy whilst en-route and observing Meier's demeanor, Deputy asked Meier if he had used any intoxicating substances prior to driving. Meier advised he did not use any sub-

stances, and advised he had a prior history of narcotic use. Deputy then asked Meier if he would agree to perform field sobriety, in which he agreed.

The first test conducted was the Horizontal Gaze Nystagmus test. Deputy observed all 6 clues of impairment from HGN including Lack of Smooth Pursuit, Distinct and Sustained Nystagmus at Maximum Deviation, and Onset of Nystagmus prior to 45 degrees.

The second test conducted was the Walk and Turn. During the test Deputy observed Meier miss multiple heel to toe steps. Meier also Stepped off of the line and made an improper turn after the first set of 9 steps.

The third test conducted was the One Leg Stand. Meier showed all four clues during the test. First one by putting his foot down before being instructed to do so, using his arms for balance, swaying and hopping.

Based on the totality of circumstances, Deputy determined Christopher Meier to be under the influence of an unknown intoxicant, and a danger to himself and the motoring public by means of operating a motor vehicle while impaired. Meier was then placed into custody and read his implied consent rights. Meier refused providing a blood sample, stating that he "pleads the fifth." Meier was then transported to the Loudon County Jail
