Federal Jury Convicts Pharmacy Owner Of Conspiracy, Mail Fraud, And Misbranding For Role In Multi-Million Dollar Telemedicine Pharmacy Fraud Scheme

Following a month-long trial, a federal jury convicted Peter Bolos, 44, of Tampa, Florida, of conspiracy to commit health care fraud, 22 counts of mail fraud, and felony misbranding of a medication. Sentencing for Bolos has been set for May 19, 2022 at 10:30 am, before the Honorable J. Ronnie Greer, in the United States District Court for the Eastern District of Tennessee at Greeneville.

According to court documents and evidence presented at trial, Bolos, Andrew Assad, Michael Palso, Maikel Bolos, Larry Smith, Scott Roix, HealthRight LLC, Mihir Taneja, Arun Kapoor, and Sterling Knight Pharmaceuticals, as well as various other companies owned by them, conspired to defraud pharmacy benefit managers (PBMs), such as Express Scripts and CVS Caremark out of millions of dollars. PBMs pay

pharmacies for prescription claims on behalf of public insurance programs, such as Medicare and Tricare as well as private insurance companies like Blue Cross Blue Shield of Tennessee.

Court documents and evidence at trial further proved that Bolos, Assad, and Palso – who owned Synergy Pharmacy in Palm Harbor, Florida – purchased pre-

Randy Pride, 44, Coachman Drive Clinton, was charged with Mfg/Del/Sale or Poss. Of Meth, Poss. Of Drug Para., and Driving while in Poss. Of Meth.

Officer R. Miller LCPD, was conducting a routine patrol in the area of Highway 321 near Interstate 75 in Lenoir City, TN. During patrol duties, Officer observed a blue in color Ford Mustang exit the parking lot of the Econo Lodge at a high rate of speed disregarding traffic on Highway 321. Officer then observed the mustang pull into the left inside lane of Highway 321 North where it abruptly engaged its brakes to make left turn which resulted into a u-turn. The mustang did so without using a turn signal causing the vehicle located directly behind it

to engage its brakes which almost resulted in a traffic accident. Violation of TCA 55-8-142. Officer then initiated a traffic stop on the said vehicle in the parking lot of Bimbos. Upon traffic stop Officer made contact with the driver of the vehicle, Randy Pride. PRIDE initially appeared nervous where he was making several fidgety movements inside of the vehicle along with not being able to answer rational questions. Officer had PRIDE step out of the vehicle due to his deceptive behavior and to speak with him about a citation. While speaking with PRIDE about the citation Officer requested for a K9 to conduct an open air sniff of the vehicle. Sgt. Chris Hutchens and K9 Dante with the LSCO conducted a open air sniff of

the vehicle at which point Sgt. Hutchens indicated that K9 dante positively alerted to an odor of narcotics from inside the vehicle. A search of the vehicle revealed a large zip-lock bag containing a crystal-like substance along with a regular size zip-lock bag containing the same crystal-like substance, which both tested positive for methamphetamine through TRU

NARC. The methamphetamine was located inside of a McDonalds bag which was sitting in the passengers seat of the vehicle. Total weight of the methamphetamine was 14.1 oz. Also located inside of the vehicle was a digital scale with crystal-like residue on it, a drug ledger that had different weights written out along with the prices of the weights and two glass pipes.

Brandon McGrail, 29, Sunset Drive Sweetwater, was charged with Man/Sell/Del/Resale Sch. II x2, DUI, and Simple Possession.

Officer Clemmer LPD, observed a vehicle in one of the parking spots, wrongly parked, with the vehicle still running and it keys in the ignition. Officer Clemmer observed the driver and it looked to be under the influence, driver could not keep his eyes open while eating Officer Clemmer stated. Driver of the vehicle was later identify as Brandon McGrail. Upon Officer Luna arrival, Mr. McGrail stated just getting off work at approximately 1900. Mr. McGrail was asked to perform field sobriety test, which he agree to. Officer Luna and Officer Houser perform the Sobriety test on Mr. McGrail. Mr. McGrail could not follow instructions properly and

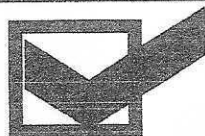
DUI Charge for Ldn Man

scriptions from Scott Roix for \$500 apiece. Bolos and Roix disguised these prescriptions' purchases with bogus marketing agreements. To obtain these prescriptions, Roix used HealthRight's telemedicine platform to deceive patients into providing HealthRight with their insurance information. Roix then steered doctors to issue prescriptions through HealthRight's telemedicine platform by falsely telling the doctors the patients had requested the medications. In fact, the medications were selected by Bolos because they were highly profitable.

During the conspiracy, which lasted from May 26, 2015 through April 1, 2018, Bolos paid Roix more than \$30,000,000 to buy not fewer than 60,000 prescriptions. Nearly all these prescriptions were issued through HealthRight's telemedicine platform. The doctors who issued the prescriptions did not know, never met, and never spoke to the patients.

According to court docu-

ments, Roix, Assad, Palso, Smith, Maikel Bolos and various associated business entities previously pleaded guilty to their role in the conspiracy. Taneja, Kapoor, and Sterling Knight pleaded guilty to felony misbranding in a conspiracy with Bolos. Sentencings for all the defendants will be set for dates in 2022.

The trial and plea agreements resulted from a multi-year investigation conducted by the U.S. Department of Health & Human Services Office of Inspector General (Nashville); Food and Drug Administration Office of Criminal Investigations (Nashville); U.S. Postal Service, Office of Inspector General (Buffalo, New York); Federal Bureau of Investigation (Knoxville and Johnson City, Tennessee); Office of Personnel Management Office of Inspector General (Atlanta); and the Department of Homeland Security, Homeland Security Investigations (Tampa). The U.S. Marshals Service also assisted in the investigation and the forfeiture of assets.
