Against Children Unit (KPD-ICAC) concerning images of child pornography being produced in Knoxville. According to court documents, image and video files located during the investigation depicted the sexual victimization of an infant and a toddler by Sluder.

This case was investigated by KPD-ICAC and the Department of Homeland Security, Homeland Security Investigations. Assistant United States Attorney Jennifer Kolman prosecuted the case.

This case was brought as part of Project Safe Childhood, a nationwide initiative to combat the growing epidemic of child sexual exploitation and abuse launched in May 2006 by the Department of Justice. Led

by U.S. Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state, and local resources to better locate, apprehend and prosecute individuals who exploit children via the Internet, as well as to identify and rescue victims. 

#### Domestic Charge

Katelyn Walden, 18, Bat Creek Road Loudon, was charged with Domestic Assault x2.

Deputy Harrison and Deputy Bengel LCSO, were approached by a female in the parking lot of the Justice Center wishing to file a report for an assault that occurred at Bat Creek Road East. While speaking with the victim/complainant, She stated Katelynn Walden attacked her after she attempted to break up a fight between Katelynn and her boyfriend. Victim 1 stated when she attempted to break up the fight Katelynn grabbed her by the hair and began punching her several times. Deputy did observe her to have multiple scratches and cuts on her neck, arms, face, and blood coming from her mouth. Dep-

uty then spoke with victim 2 who stated he and Katelynn had been in an argument over what clothes he had dressed their baby in to go to a clinic. He stated Katelynn then punched him in the face and side of the head because she did not like the outfit he had picked out for the baby. Deputy did observe a red mark on the right side of the victim's head next to his eye. All parties live at Bat Creek Road East. Based on the physical injuries to both parties and the statements gathered, Deputy is charging Katelynn Walden with two counts of domestic assault TCA 39-13-111. Deputies responded to the address and placed the offender in custody without incident on 11-7-2021 at approximately 15:51, and Deputy Pesterfield transported her to the Loudon County Jail..





Brian Maynard, 38, Wade Road West Loudon, was charged

with Domestic Assault.

Deputy Stanley LCSO, responded to a call regarding a domestic assault at Wade Road West. Upon arrival, Deputy made contact with the complaianat/victim who advised her son (Brian Maynard) had pushed her. She advised that Brian had been talking out of his head, and not making sense. Victim advised the altercation was verbal but escalated when Brian pushed her into a chair in her room, she described it by him pushing her by her neck with his forearm. She advised he then went into the living room after she told him she was calling 911. Deputy then made contact with Brian in the living room. He advised he did not put his hands on victim, but he did state that he "nudged" her out of his face during the argument. While speaking with Brian, he continuously made abnormal comments about hearing voices, and making statements about his deceased father being poisoned, talking with TBI, and about him previously dying and throwing up a "Black mass". Brian continued making abnormal statements to us while on scene.

Domestic in LC

Based on statements during investigation, Derputy determined Brian Maynard to be a primary aggressor. Deputy placed him into custody on the charge of Domestic Assault. Deputy transported him to the Loudon County Jail without incident. All occurred in Loudon County.

Manfred Villatoro-Herrera, 24, C Street Lenoir City, was

charged with Domestic Assault.


Officer R. Miller LCPD, responded to C Street in Lenoir City, TN, in reference to a 911 open line/ possible domestic. On scene Officer made contact with two male subjects standing on the sidewalk in front of C Street who appeared to be arguing. The two subjects were identified as, Manfred Villantoro, and, victim, two brothers and both of Lenoir City. Victim, stated that MANFRED had called him to see if he would take him to get some food, where victim agreed to. Victim noticed that MANFRED had gone into his house without permission at some point and had also broken glass bowls on the sidewalk and roadway. Victim stated to MANFRED that he was not going to take him to get food due to him acting the way he was. MANFRED then became upset and approached victim in a aggressive manner and stated that he was going to beat his face in until he was dead or kill him. Victim stated that he was in fear of his life at the time of the incident. At the time of the incident MANFRED, intentionally or knowingly caused his brother to reasonably fear imminent bodily injury. MANFRED was placed under arrest and transported to the Loudon County Jail.


