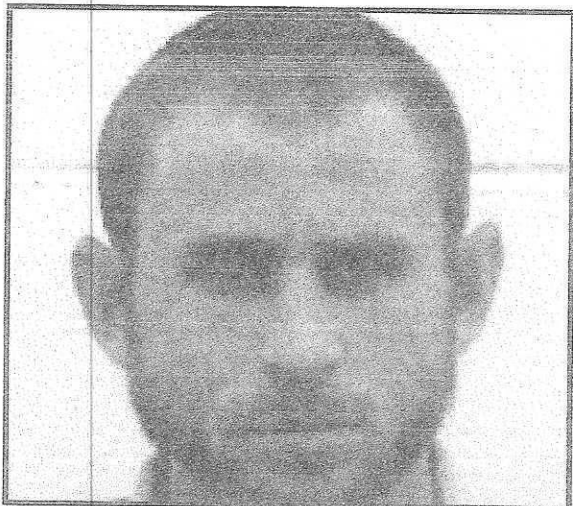

Michael Thacker Stole at Least \$7,000

An investigation by the Tennessee Comptroller's Office has found that Michael William Thacker misappropriated at least \$7,076.50 from the Hawkins County Emergency Response Team (HCERT).

The HCERT is a nonprofit corporation that responds to hazardous materials and

other emergencies. It is funded by a combination of donations and contributions, primarily from Hawkins County government and individual residents.

Beginning in 2003, Thacker was elected to various HCERT leadership roles including chief and assistant chief. He had unofficially served as HCERT's treasurer

since 2007.

Investigators determined that Thacker stole money between January 2017 and January 2021. The misappropriation included unauthorized ATM cash withdrawals, personal fuel purchases, cash back from purchases, jewelry purchased for a family member, and a HCERT

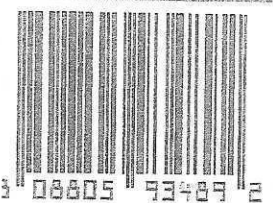

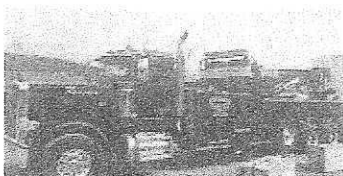

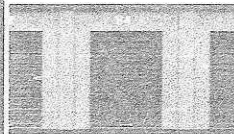

Shelby Baker, 36, Dixie Lee Circle Lenoir City, was charged with Domestic Assault.

Dep. L. Hawkins LCSO, was dispatched to Dixie Lee Circle in reference to a physical domestic. While in route, The Loudon County Dispatch could hear the caller/victim, yelling "ouch." Deputy arrived on the scene shortly after and found victim in the carport, she was out of breath and appeared upset. The offender, Shelby Baker, is her boyfriend and was not in sight when Deputy arrived. Victim stated Shelby had been helping her friend move all day and arrived home at approximately 6:00 PM. When he came inside he was talking out of his head and appeared to be intoxicated to her. He kept asking, "Where do I stand?" She was confused by this and asked him to leave due

to his intoxicated state, this made him angry. He began yelling in her face and throwing objects around the basement living room. Victim than when upstairs in fear he was going to hurt her, he followed behind. He continued to yell in her face and call her names. Once again she attempted to get away from him by going outside and calling 911, he followed her. While she was in the rear doorway he pushed her, nearly knocking her down. She states he pushed her two more times while she was on the phone with The Loudon County Dispatch. Victim retreated to the back door trying to get away from Mr. Baker when he swung his backpack, striking her in the right shoulder and neck. Deputy and Sgt. Hutchens made entry into the home to locate Mr. Baker and he was nowhere to be found. Deputy then noticed a gate door was

open that lead to a shed in the back yard of Dixie Lee Circle. Mr. Baker was found under the shed attempting to hide. Mr. Baker denied all allegations and stated victim was angry with him because of his "tone" and that nothing physical occurred. A witness was on the scene and witnessed the entire altercation. She confirmed victim story and stated she was afraid Mr. Baker was going to hurt victim. Based on the victim and witness statements, Shelby Baker was found to be the

primary aggressor. All the above did occur in Loudon County, Tennessee.

check transacted by Thacker for his personal benefit. Thacker also signed another person's name to that check without their knowledge or consent.

Thacker told investigators that he used HCERT funds for his personal benefit due to personal and financial issues. He left the HCERT board in August 2021.

On December 10, Michael William Thacker pled guilty in the Criminal Court of Hawkins County to a criminal information charging him with one count of theft over \$2,500, one count of fraudulent use of a debit card, and one count of forgery. As a condition of his sentence, he was also ordered to pay restitution to the HCERT.

"Our investigators also discovered a number of deficiencies within the financial operations of HCERT that

allowed theft to go undetected," said Comptroller Jason Mumpower. "HCERT must do a better job of keeping receipts, establishing controls over fuel purchases, maintaining its accounting records, and reconciling bank accounts. We also found that HCERT did not require two signatures on checks and did not adequately track fundraiser collections. I'm pleased to note that HCERT is taking steps to correct these problems."

She stated that she made multiple attempts to exit the vehicle but he kept pushing the door shut on her and she began screaming for help hoping someone would hear. Victim did have scratches below her right eye and cuts to her right elbow. SGT Hutchens spoke with the 7-year-old, Child who gave the same statement as his mother stating the fathers driving and actions placed him in fear for his safety. This did occur in Loudon County Tennessee.







Officer Parmer LCPD, was checking businesses on the east end of Lenoir City when he observed a blue Dodge Caliber bearing TN tag 6E12R9 backed in to a parking spot at Cracker Barrel. Upon closer inspection of the vehicle, Officer observed trash bags covering all windows and the bottom of the rear windows were fogged up. Officer knocked on the window of the vehicle and made contact with a Ms. Virginia Lee who stated she had been living in her car. Ms. Lee appeared very nervous and failed to make consistent eye contact with Officer while he was speaking with her. While conversing with Ms. Lee, Officer could smell a strong odor
