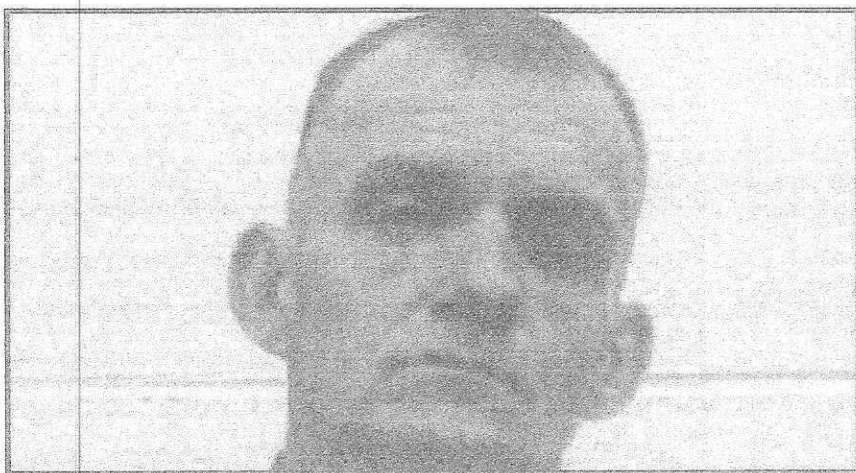

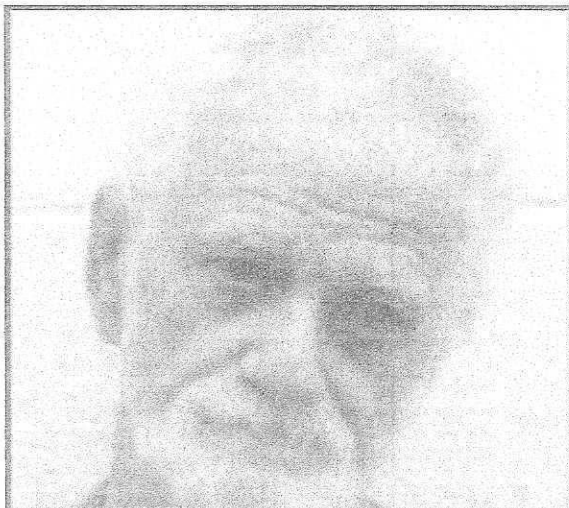

CDC Launches Two Global Networks, Awards \$22 Million to Combat Antimicrobial Resistance and Infectious Diseases

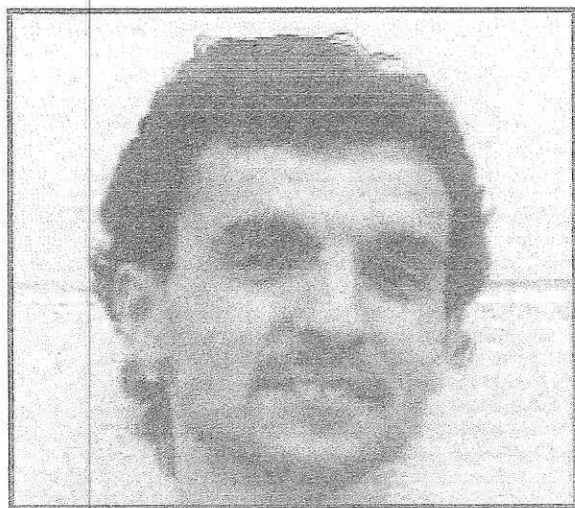
The Centers for Disease Control and Prevention (CDC) announced today that it has awarded \$22 million to nearly 30 organizations around the world to combat antimicrobial resistance (AR) and other healthcare threats through the establishment of two new networks—the Global Action in Healthcare Network (GAHN) and the Global AR Laboratory and Response Network (Global AR Lab & Response Network).

These two new networks, paired with additional short-term research projects, will span more than 50 countries worldwide and build programs that focus on preventing infections in health care through proven infection control; build laboratory capacity to detect antimicrobial-resistant organisms in healthcare, the community, and environment; and develop new and innovative ways to more rapidly detect and re-

spond to threats like AR and COVID-19.

This work builds on successful U.S. efforts launched through CDC's AR Solutions Initiative since 2016 and will complement ongoing, effective global work underway by CDC and public health partners worldwide. These networks and research projects will tackle threats covered in CDC's Antibiotic

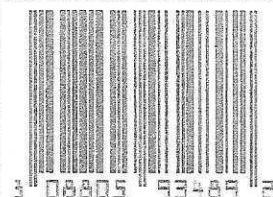

Waylon Ackerman, 40, Carding Machine Road Loudon, was charged with DUI, Leaving the Scene of Accident Property Damage, Violation of Implied Consent, Driving on Revoked/Suspended License, and Financial Responsibility Law.

Officers with LPD, were dispatched to Carding Machine for an unwanted guest. While in route, dispatched advised the subject had hit a car, and was attempting to leaving in a white Ford. Upon Officer Nix arrival he made contact with the Ford and it was driving through the parking lot. Officer was able to stop it and identify the driver as Mr. Waylon Ackerman. As Officer was speaking with Ackerman he could smell a

strong odor of an alcoholic beverage coming from his breath and person. He also had bloodshot watery eyes. When asked, Ackerman advised he had approximately 1 pint to drink. 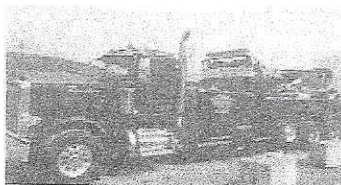



Ion Pynzaru, 28, Hearthfire Way Lenoir City, was charged with Domestic Assault, and Resisting Arrest.

Deputy Pesterfield LCSO, responded to Hearthfire Way Lenoir City for a physical domestic. Upon arrival, Deputy spoke with the victim who stated she told her son he needed to go to the hospital to get evaluated for his mental health issues. The offender Mr. Ion Pynzaru became very upset and slapped the victim multiple times across the left cheek and threatened to kill her. Deputy did observe the offender's left cheek to be very red consistent with this story. The victim also stated he has threatened to kill multiple family members in the past. Deputy attempted to contact the offender inside the residence, but he was not inside. Deputy walked outside and contacted the offender in the driveway. Deputy told

the offender to walk to his vehicle, to which he started to and then stopped. Deputy told him to walk to his car again, to which he refused. Deputy grabbed the offender's wrist and told him to put his hands behind his back.

The offender then began pulling away from Deputy, telling him not to touch him. Deputy continued to give the offender the command to put his hands behind his back, and he continued to resist. Deputy then took the offender to the ground and gave orders for him to put his hands behind his back, to which he continued to resist trying to get up and then finally gave up, placing his hands behind his back. The offender was then taken into custody without further incident. Deputy is charging the offender with domestic assault and resisting arrest. All the above actions did occur in Loudon County, TN.

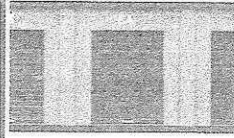

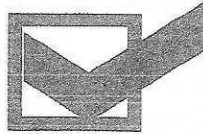

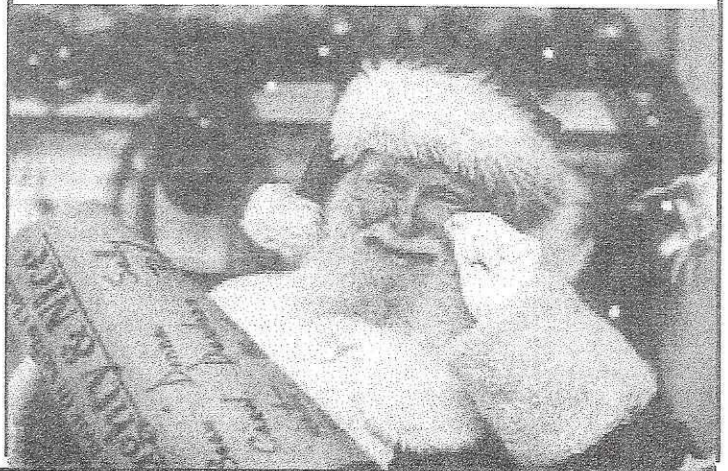
"Antimicrobial resistance is not going away and new AR threats will continue to emerge. CDC's domestic AR Lab Network is an established model for detecting emerging antimicrobial resistance threats. Today, these new investments will build on this model and span much of the globe, leveraging proven expertise to fill critical gaps and inform data-driven responses before threats can spread in communities, across borders, or around the world," said Denise Cardo, MD, Director of CDC's Division of Healthcare Quality Promotion. "We also know that evidence-based prevention in health care stops AR threats and other infectious diseases. These new programs will fill infection control gaps to keep patients safe and contain threats immediately when they do inevitably emerge."

The 28 organizations receiving funding include: American Society for Microbiology

(ASM); American Type Culture Collection (ATCC); American University of Beirut; Association of Public Health Laboratories (APHL); Columbia University; Duke University; Family Health International (FHI360); FIOTEC; Global Scientific Solutions for Health; Health Security Partners; icdr;b; Johns Hopkins University; Koperasi Jasa Institut Riset Eijkman; Northwestern University; Pakistan National Institute of Health; Pan American Health Organization (PAHO); The Ohio State University; U.S. Civilian Research & Development Foundation (CRDF); Universidad de Desarrollo; University of Campinas; University of Cantabria; University of Nairobi; University of Oxford; University of Pennsylvania; Vanderbilt University; Washington State University; Washington University in St. Louis; and World Health Organization (WHO).

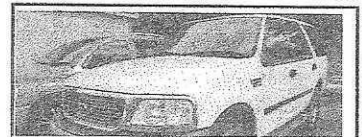

Joseph Eyster, 56, Forest Heights Circle Lenoir City, was charged with Domestic Assault, and Simple Possession.

Deputy Eric Curtis and Deputy R Fleming LCSO, responded to Forest Heights Circle in Lenoir City, TN for a possible domestic in progress. While en route to the residence, dispatch advised that they actively heard screaming coming over the phone and a male yelling, "You have 5 seconds to open this door!" and "I'm ready to die!". Upon arrival, Deputy made contact with the suspect, Joseph Eyster. He was shirtless, had slurred speech, and was tottering on his feet. When Deputy asked him what had occurred, he stated that he just wanted to go to his room and be left alone. He admitted to having an argument with the victim and complainant. Deputy spoke with the victim and she stated that the suspect had gotten in her face and accused her of cheat-

ing, physically imposing upon her and putting her in fear for her safety. During the investigation for the domestic, Deputy Fleming noticed a bright light coming from the closet in Eyster's room. He alerted Deputy to this and he opened the closet door with consent from both the victim and the suspect, and located three pots with three juvenile plants growing in them, believed to be marijuana. Deputy contacted Lt. S Ezell, who responded to the scene. During further investigation and interview, the victim also admitted to having three jars of marijuana, weighing out at roughly 3 oz. The victim filled out a victim statement in reference to the domestic, and a citation was issued for possession of the Marijuana. A property receipt was issued to both individuals in reference to the marijuana and the lights used for growing the marijuana, and Deputy placed Eyster under arrest for Domestic Assault. (1) (A) Four (4) months from the date of the first publication (or posting, as the case may be) of this notice if the creditor received an actual copy of this notice to creditors at least sixty (60) days before the date that is four (4) months from the date of the first publication (or posting); or
