

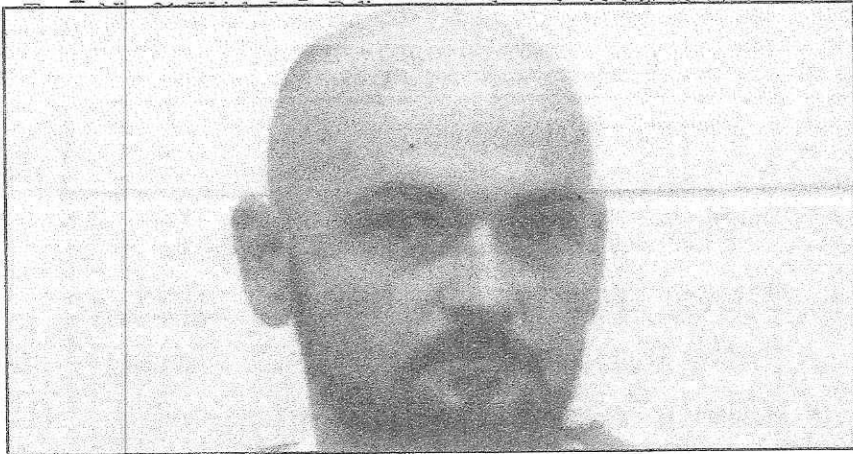

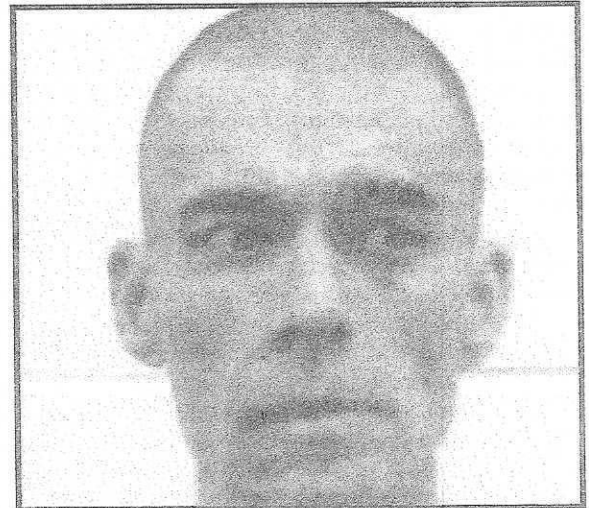

## Listeria Outbreak Linked to Packaged Salads

CDC is currently investigating two separate Listeria outbreaks, both of which are linked to packaged salads. One outbreak is linked to packaged salads produced by Fresh Express. The other outbreak is linked to packaged salads produced by Dole.

Listeria Outbreak Linked to Packaged Salads Produced by

Fresh Express

Key points:

Ten people infected with the outbreak strain of Listeria have been reported from eight states. Ten people have been hospitalized. One death has been reported.

Interviews with ill people and laboratory data show that Fresh Express packaged salads may be contaminated with Listeria and

may be making people sick.

On December 20, 2021, Fresh Express recalled external icon several brands of packaged salad products. The recall includes all Use-By Dates with product codes Z324 through Z350.

Brands include Fresh Express, Bowl & Basket, Giant Eagle, Lit-

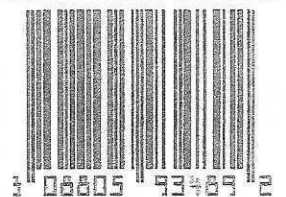

## Stop

Of Meth, Simple Possession, Driving on Revoked/Suspended License, and Requirements for Stop Sign Vehicle.

Deputy Green LCSO, observed a Gray Mazda traveling on I-75 North Bound at mile marker 68. Deputy observed suspicious driving behavior from this vehicle. Deputy observed this vehicle traveling at a slow rate of speed in the slow lane behind a semi truck with no traffic in the left lane. As the vehicle passed him Deputy observed the driver reposition himself behind the "B Post" of the vehicle in attempt to conceal himself from my view. Deputy followed behind this vehicle to further investigate. As the driver noticed me he tapped the brakes. This vehicle exited the interstate at exit 72 and failed to come to complete stop at the visible white stop line at the stop sign located at Highway 72. I conducted a traffic stop and made contact with the driver, Trevor Nix, and requested his driver's license. Mr. Nix stated his driver's li-

cense was currently suspended. Deputy verified this through dispatch which advised Mr. Nix Drivers License was suspended for failure to file insurance certification out of Spring City Court on 10/09/2021. While awaiting return of Mr. Nix warrant checks Deputy asked him if there was anything illegal inside of his vehicle in which he immediately looked away from and stated no. Deputy requested consent to conduct a search of the vehicle in which Mr. Nix refused. Deputy requested Sgt. Hutchens respond to his location in order to have his K9 conduct a sniff of the vehicle for the presence of narcotics. While awaiting Sgt. Hutchens Deputy began on his citations for the traffic offenses and provided Mr. Nix with a Driver's License receipt for his suspended driver's license. Sgt. Hutchens arrived on scene and performed a K9 sniff of the exterior of the vehicle and advised his K9 indicated a positive alert on the vehicle. Prior to beginning his search Deputy asked Mr. Nix what was inside the ve-

hicle in which he stated "Dope and a little bit of weed". In an attempt to clarify the term dope Deputy asked if he was referring to Meth which he confirmed. Deputy conducted a probable cause search of the vehicle and located inside of a small green bag in the front passenger seat Deputy recovered a clear baggie containing 1.9 grams of a white crystal-like substance believed to be methamphetamine. Located in a separate pocket of the same green bag Deputy recovered a small clear case contain-

ing two and a half white round pills with the imprint of 54 411. Mr. Nix stated these were Subutex. A loaded syringe was located beside the subutex which Mr. Nix advised was also Subutex. Mr. Nix was taken into custody. James Wrecker service responded and impounded the vehicle. Deputy transported Mr. Nix to Loudon County Jail without incident where he was charged with Possession of Methamphetamine, Possession of Subutex, Driving on a suspended Drivers License and Stop Sign violation.

**Gun**

Matthew McCreedy, 37, Glenlock Road Sweetwater, was charged with Dui, Violation of Implied Consent, Poss. Of Handgun while under the influence, Imitation of Controlled Substance.

Deputy L. Hawkins LCSO, was dispatched to the area of Interstate 75 South in reference to a possible intoxicated driver. The caller, was traveling on I-75 south at the 81 MM when he noticed a silver Pontiac Vibe driving across both lanes of traffic, the vehicle was driving at slow speeds of approximately 50 mph and then would accelerate to speeds of approximately 80mph. Deputy entered I-75 south at the 76 MM to attempt to catch up to the vehicle. As Deputy was passing the 72 MM the caller advised the vehicle pulled over to the shoulder at the 71 MM and a male exited the vehicle looking around. Deputy arrived on scene with the vehicle and made contact with the driver, Matthew McCreedy.

He had glossy/bloodshot eyes and was slurring his words. He appeared disoriented and had unusual behavior. When Deputy asked him for his license he was delayed and grabbed all the money from his wallet, then he retrieved his drivers license. When Deputy asked him for his registration and insurance he opened the center console and placed his hand on the top of a firearm. He immediately put his hand up as Deputy requested and exited his vehicle. The firearm was a Taurus G3C .9MM semi-automatic handgun it was secured after he exited the vehicle. He consented to S.F.S.T and preformed unsatisfactory. Dep. C. Green arrived on scene to conduct A.R.I.D.E. that Mr. McCreedy also consented to. Dep. Green advised he preformed unsatisfactory and showed indicators of impairment. Mr. McCreedy advised he was heading home from work in Knoxville and that his driving behavior was due to the fact he was tired and just worked a 12 hour shift. Later, he advised it was be-

cause he was on his phone and was attempting to place it into the dash because multiple people were trying to contact him at once.

Deputy asked for consent to search his vehicle and he agreed. Upon the search a 30ml bottle of "Flubormazolam" was found. This substance is a triazole analogue of the designer benzodiazepine which causes central nervous system depression. "Flubormazolam" is not a controlled substance. The substance would fall under the category of imitation controlled substance due to the

drugs mimicking the effects of a central nervous system depressant. Mr. McCreedy advised he took this drug the day prior to our encounter and had not used any drugs or alcohol on this day. Based on the totality of the circumstances, S.F.S.T., A.R.I.D.E., and the behavior of Mr. McCreedy Deputy believed he was under the influence. Deputy read the Tennessee blood and/or breath consent advisement and he refused to provide a sample for testing. He was taken into custody and transported to the Loudon County Jail.

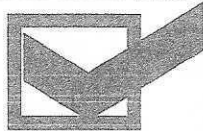

**Listeria Outbreak Linked to Packaged Salads Produced by Dole**

Key points:

Sixteen people infected with the outbreak strain of Listeria have been reported from thirteen states. Twelve people have been hospitalized. Two deaths have been reported.

Epidemiologic and recent laboratory data show that packaged salads produced by Dole may be contaminated with Listeria and making people sick.

Investigators found the outbreak strain of Listeria in two different packaged salads produced by Dole.

On December 22, 2021, Dole recalled several brands of packaged salads. The recall includes "best if used by" dates from 11/30/21 through 01/08/22.

Brands include Ahold, Dole, Kroger, Lidl, Little Salad Bar, Marketside, Naturally Better, Nature's Promise, and Simply Nature.

CDC is advising people not to eat, sell, or serve any recalled products. Investigators are working to determine if additional products may be contaminated.

**What You Should Do:**

Do not eat any recalled packaged salads. Throw them away or return them to where you bought them.

Follow these five steps to clean your refrigerator, containers, and surfaces that may have touched the recalled packaged salads. Listeria can survive in the refrigerator and can easily spread to other foods and surfaces.

Call your healthcare pro-

vider right away if you have these symptoms of Listeria infection after eating packaged salads.

Pregnant people usually experience only fever, fatigue, and muscle aches. However, Listeria can cause pregnancy loss or premature birth. It can also cause serious illness or death in newborns.

People who are not pregnant may experience headache, stiff neck, confusion, loss of balance, and convulsions, in addition to fever and muscle aches.

**About Listeria:**

Listeria bacteria can cause severe illness (known as invasive listeriosis) when the bacteria spread beyond the gut to other parts of the body.

Pregnant people typically experience only fever, fatigue, and muscle aches. However, Listeria infection during pregnancy can lead to miscarriage, stillbirth, premature delivery, or life-threatening infection of the newborn.

People who are not pregnant may experience headache, stiff neck, confusion, loss of balance, and convulsions, in addition to fever and muscle aches.

Symptoms of severe illness usually start 1 to 4 weeks after eating food contaminated with Listeria, but may start as early as the same day or as late as 70 days after.

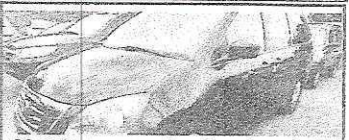

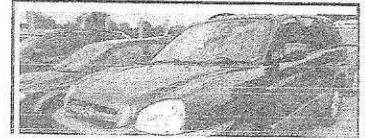

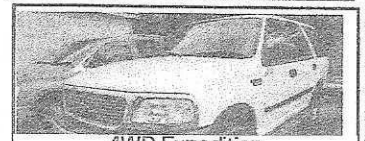

Anthony Bosworth, 43, Main Street Loudon, was charged with DUI, Violation of Implied Consent, Legend Drug, and Misuse of 911 Emergency System.

Deputy M Rodriguez LCSO, observed a black sedan traveling North on Hwy 444 without a tag light. While Deputy Rodriguez was observing the sedan it suspiciously pulled over on the shoulder at which time Deputy Rodriguez initiated a traffic stop. Upon contact with the driver Mr. Anthony Bosworth, Deputy Rodriguez smelled a strong odor of an alcoholic beverage coming from his person. Deputy Rodriguez checked Mr. Bosworth with Loudon E911 and it was confirmed Mr. Bosworth had an active warrant for Misuse of 911. Deputy Rodriguez did recover a pill bottle without a script containing approximately 15 Xa-

nax and believed Bosworth to be under the influence of the narcotic due to him falling asleep mid conversation. Deputy Rodriguez transported the offender to the Loudon County Jail where Deputy C Rogers, met them. Mr. Bosworth was read his Miranda warning and stated he understood. While Deputy spoke with Mr. Bosworth he stated he had drank half a pint of vodka, taken Xanax and "had death-amphetamine" (meth) in his system. Mr. Bosworth did consent to SFST/ARIDE and did not perform satisfactory, see case notes. Deputy informed Mr. Bosworth that he was also charging him with DUI based on the totality of the circumstances. Deputy then supplied and explained TN Implied consent to the offender and Mr. Bosworth did refuse a blood draw. Mr. Bosworth was also charged with Legend Drugs and cited with Violation of Implied Consent.
