CDC Releases Emergency Guidance for Healthcare Facilities to Prepare for Potential Omicron Surge

With the growing number of COVID-19 cases from the Omicron variant, and consistent with current understanding of the disease trajectory, CDC is releasing updated guidance for isolation and quarantine for healthcare workers, decreasing their isolation time after infection with COVID-19. Addition-

ally, CDC is releasing an update to guidance for contingency and crisis management in the setting of significant healthcare worker shortages. These updates provide healthcare facilities with the strategies to limit the effects of staff shortages caused by COVID-19 on patient care and note that:

Healthcare workers with COVID-19 who

are asymptomatic can return to work after 7 days with a negative test, and that isolation time can be cut further if there are staffing shortages.

Healthcare workers who have received all recommended COVID-19 vaccine doses, including a booster, do not need to quarantine at home

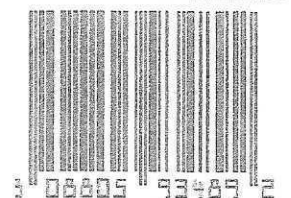

Catherine Steele, 45, Spring Dale Road Mount Olive, was charged with Man/Sell/Del/Resale Sch. II, and Mfg/Del/Sale or Poss. Of Meth.

Officer R. Miller LCPD, was conducting a routine patrol in the area of 1111 Highway 321 (Exxon) in Lenoir City, TN. During his routine patrol duties Officer observed a purple in color Honda SUV parked on the side of the building. While observing the vehicle Officer noticed a female individual slumped over the center console while the vehicle was running. Officer then preceded by knocking on the window of the vehicle three to four times to make sure the female had not possibly overdosed or was having a medical issue. The female inside of the vehicle finally responded and appeared lethargic. Officer made contact with, Catherine Steele, of Alabama. While speak-

ing with STEELE she stated that she was traveling from Birmingham, AL to Virginia and stated that she pulled over to take a nap due to her being tired. During my conversation with STEELE Officer noticed a green in color "dime bag" containing a crystal-like substance believed to be methamphetamine laying in the drivers side floorboard of where STEELE was sitting. Officer had STEELE step out of the vehicle where she stated that she was given what she stated was "ice" which is a term commonly used for methamphetamine. Officer then conducted a probable cause search of the vehicle where Officer located; (4) individually wrapped baggies containing a brown rock/powder like substance that tested positive for Heroin (1.3 Grams) through TRU NARC, (1) baggie containing the same crystal-like residue that was located in the floorboard of the vehicle both in which tested posi-

tive for methamphetamine (0.44 Grams) through TRU NARC and one digital scale. Also located in the vehicle were numerous hypodermic needles and several bottle caps which are both used for injecting narcotics into the human body. STEELE was mirandized where she admitted to using heroin earlier throughout the day. STEELE was placed under arrest and transported to the Loudon County Jail

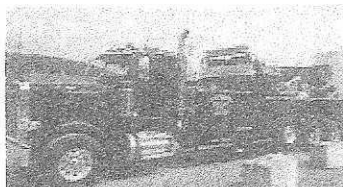

Isolation relates to behavior after a confirmed infection, and quarantine is following exposure to the virus but without a confirmed infection.

These guidelines apply only to the healthcare workforce and may be revised to continue to protect both healthcare workers and patients as additional information on the Omicron variant becomes available to inform recommended actions. Additional information will be published as guidance on CDC's website soon and shared with healthcare organizations and provider groups. CDC continues to evaluate isolation and quarantine recommendations for the broader population as we learn about the Omicron variant and will update the public as appropriate. CDC strongly

encourages COVID-19 vaccination for everyone 5 and older and boosters for everyone 16 and older – vaccination is the best way to protect yourself and our healthcare system from the impact of COVID-19.
