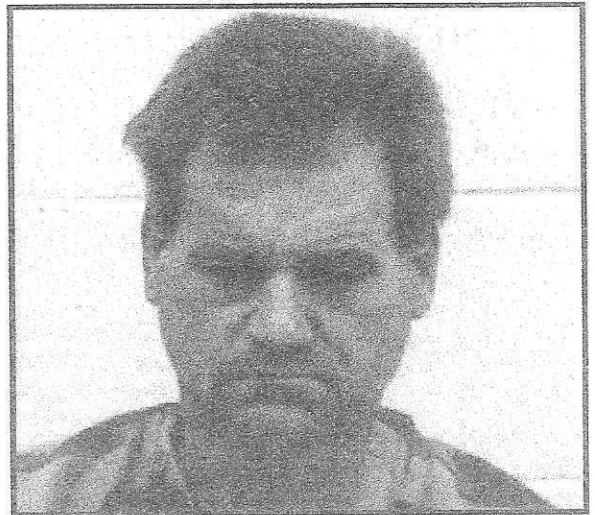

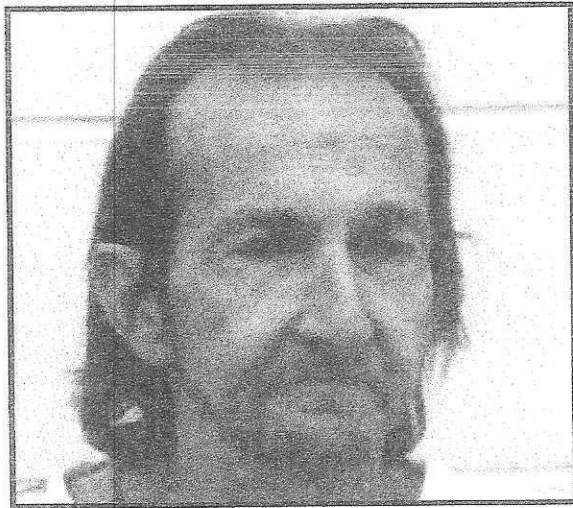

Listeria Outbreak Linked to Packaged Salads

CDC is currently investigating two separate Listeria outbreaks, both of which are linked to packaged salads. One outbreak is linked to packaged salads produced by Fresh Express. The other outbreak is linked to packaged salads produced by Dole.

Listeria Outbreak Linked to Packaged

Salads Produced by Fresh Express

Key points:

Ten people infected with the outbreak strain of Listeria have been reported from eight states. Ten people have been hospitalized. One death has been reported.

Interviews with ill people and laboratory data show that Fresh Express packaged salads may be contami-

nated with Listeria and may be making people sick.

On December 20, 2021, Fresh Express recalled external icon several brands of packaged salad products. The recall includes all Use-By Dates with product codes Z324 through Z350.

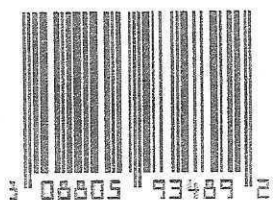

Tessa Hines, 28, Rich Avenue Mt. Vernon, was charged with Theft of Property, and Financial Exploitation of Elderly Adult.

Deputy B. McCall, along with Deputy M. Longmire LCSO, came in contact with Tessa Gay Hines within the Essex County Correctional Facility in Newark, New Jersey. Ms. Hines had two active warrants out of Loudon County General Sessions Court for Facilitation of financial exploitation of an elderly adult and facilitation of theft of property over \$60k (2021-CR-1897 C1,C2). After verification of Identity Deputy did take her into custody and transported her to the Loudon County Detention Center and served her with the aforementioned warrant. This did occur within the Loudon County Detention Center, Loudon County, TN.

Theft Charge

Michael Goldberg, 38, Casey Road Harriman, was charged with Theft of Property.

Officer A. Lee LCPD, was dispatched to Home Depot in reference to theft. While enroute dispatched advised the male suspect had fled after being confronted by AP, and left in a white Nissan Altima. Upon arrival Officer located the vehicle and conducted a traffic stop. The passenger, Michael Goldberg, admitted to being confronted by AP associates. Goldberg was transported back to Home Depot where AP advised Goldberg placed several tools into a shopping cart, passed all points of sale, and exited the store through the main doors. 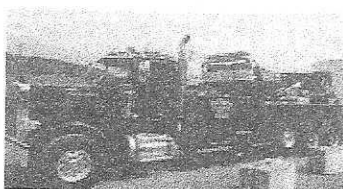

Arnold Presley, 62, Summer Street Loudon, was charged with DUI.

Deputy Marshall Lynn LCSO, was notified via Loudon County E911 dispatchers, of a reckless driver in the area of Sugar Limb Road near Hotchkiss Valley Road East. While en route, Deputy observed a vehicle matching the description in the ditch near 9990 Hotchkiss Valley Road East. Additionally, the vehicle appeared to have ran through a barbwire fence and destroyed several fence posts. Deputy made contact with Arnold Presley who, upon initial observation, appeared tired, lethargic, displayed slurred speech, and had constricted pupils. Furthermore, Arnold Presley appeared to have difficulties holding his eyes open. Deputy asked Arnold Presley if he was driving the vehicle that crashed and he stated "yes."

Deputy then asked to see his driver's license at which time he took out his wallet and began to ramble on with convoluted nonsense before falling asleep in the standing position. Arnold Presley then consented to standardized field sobriety and ARIDE testing which he performed poorly on. He was arrested, searched, and transported to the Loudon County Jail for further processing where he told the jail medical staff that he took one Klonopin.
