Local Man indicted in 2016 Murder of Coalfield's Pete McCarroll

The almost five-year-old case involving the April 18, 2016 murder of beloved, life-long Coalfield resident, Jerry Lynn "Pete" McCarroll was presented to the Morgan County Grand Jury this month by District Attorney General Russell Johnson with testimony from the current TBI

agent investigator, who took the lead on the investigation of the case in 2019. After hearing testimony from the TBI agent, the members of the grand jury returned an indictment against Timothy Giles (51 YOM), also of Coalfield [who is currently in the custody of the Tennessee De-

partment of Corrections].

Pete McCarroll's body was found in the early morning hours of April 18th by co-workers arriving at Allied Metals on Gouge Hollow Road where they are McCarroll worked, with McCarroll being the first to arrive that day. It appeared that Mc-

Five New Guilty Pleas In Nationwide Telemedicine Pharmacy Health Care Fraud Conspiracy

Larry Everett Smith, 50, of Tampa, Florida, pleaded guilty before Senior District Judge Ronnie Greer to one count of conspiracy to commit health care fraud. Sentencing has been set for October 25, 2021 at 3:00 p.m., in United States District Court in Greenville. Smith faces a term of up to 10 years in prison.

The First Superseding Indictment, returned De-

cember 1, 2020, charged Smith and others with a nationwide conspiracy to defraud pharmacy benefit managers out of \$174,202,105 by submitting \$931,356,936 in bills to the pharmacy benefit managers for fraudulent prescriptions purchased from a telemarketing company. The indictment alleges the conspiracy began in mid-2015 and lasted through the first months of 2018.

In a written plea agreement, Smith admitted to conspiring with Scott Roix, Mihir Taneja, Arun Kapoor, Sterling-Knight Pharmaceuticals LLC, HealthRight LLC, Alpha-Omega Pharmacy LLC, Germaine Pharmacy Inc., Zoetic Pharmacy, and Tanith Enterprises, and others to defraud pharmacy benefit managers into paying for fraudulent prescriptions see Fraud pg. 4

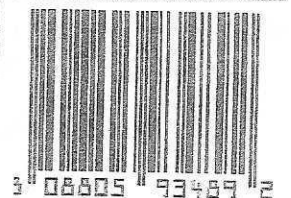
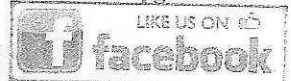

Carroll had been beaten and an autopsy confirmed one gunshot to the head. Morgan County Sheriff's Office (at that time under then Sheriff Glenn Frey-

tag initially had the lead in the investigation) with assistance from other agencies. There were many interviews conducted, including of Tim Giles, but no clear suspect was pro-

duced by the initial investigation.

The Tennessee Bureau of Investigation was eventually requested by District Attorney Johnson to take control of the investigation and it was not until late last year that prosecutors felt like, with the additional work of the TBI investigation and an investigator from the DAG's Office, that enough evidence had been developed to present to case to the Morgan County Grand Jury. General Johnson also pointed to Sheriff Wayne Potter's cooperation with TBI and his assistance in keeping the investigation in the forefront as a priority as being a key component in bringing the case before the grand jury.

\$500,000 and has recently been served with a capias for his arrest on the indictment. A hold has been placed by Morgan County Sheriff Wayne Potter and he will be transported to Morgan County upon his impending release from TDOC.

Prosecutors are working with TDOC to arrange his arraignment and appointment of counsel, due to his current incarceration in Northwest Tennessee and the COVID-19 restrictions he has not yet been arraigned.

Assistant District Attorneys Bob Edwards and Jonathan Edwards (no relation) have been assigned by District Attorney Johnson to handle the prosecution for the State.

tions for topical pain creams, vitamins, and other products. Smith agreed to pay restitution of \$24,919,254 and forfeit approximately \$3,052,215.

On September 26, 2018, Roix and HealthRight pleaded guilty to conspiracy to commit health care fraud for their roles in the scheme and agreed to pay restitution of \$5,000,000. Roix faces a term of up to 10 years in prison. Sentencing for Roix is set for October 25, 2021.

Smith's guilty plea follows pleas by Mihir Taneja, Arun Kapoor, Maikel Bolos, and Sterling-Knight Pharmaceuticals in December 2020. In those plea agreements, Taneja, 46, of Tampa, Florida, and Kapoor, 47, of Temple Terrace, Florida, pleaded guilty to felony mis-branding. Maikel Bolos, 35, of Tampa, Florida, pleaded guilty to conspiracy to commit health care fraud and mail fraud, and Sterling-Knight Pharmaceuticals, a Nevada company operated out of Tampa, Florida, pleaded guilty to conspiracy to commit health

care fraud. Taneja, Kapoor, and Sterling-Knight agreed to pay restitution of \$20,981,786. Sterling-Knight also agreed to forfeit \$6,168,398. Taneja and Kapoor, each, face a term of up to 3 years in prison. Bolos faces a term of up to 5 years in prison. Sentencing for Taneja, Kapoor, Bolos, and Sterling-Knight is set for October 18, 2021.

"The protection and integrity of our health care programs are vital to the citizens they serve. Many Tennesseans rely on these health care programs to maintain a healthy quality of life, and it is critical we protect the viability of these programs," said U.S. Attorney J. Douglas Overbey.

"Telemarketing fraud is a major threat to the integrity of government and commercial insurance programs," said Derrick L. Jackson, Special Agent in Charge at the U.S. Department of Health and Human Services, Office of Inspector General in Atlanta. "After improperly soliciting patient information, these marketing companies obtained approvals through contracted telemedicine prescribers,

then sold those costly prescriptions to pharmacies in exchange for kickbacks."

"Health care fraud can affect everyone, and Homeland Security Investigations (HSI) is committed to stopping these criminals in their tracks," said HSI Tampa acting Special Agent in Charge Kevin Sibley. "This investigation highlights the importance of law enforcement partnerships across the nation and around the world."

"The U.S. Office of Personnel Management Office of the Inspector General is committed to protecting the federal health care programs from schemes that undermine the integrity of the program," said Norbert E. Vint, Deputy Inspector General Performing the Duties of the Inspector General. "I am very proud of our investigative staff and partners at the Department of Justice for their hard work on behalf of American taxpayer."

"Today's announcement demonstrates that companies and individuals who place profits above patient safety will be held accountable for their ac-


tions," said Special Agent in Charge Justin C. Fielder, FDA Office of Criminal Investigations Miami Field Office. "We will continue to work with the Department of Justice and our law enforcement partners to bring to justice those who jeopardize the U.S. public health."

"Health care fraud is a severe crime problem that impacts every American. The FBI, with its law enforcement partners, will continue to allocate resources to investigate these crimes and prosecute those that are intent on defrauding the health care system," said Special Agent in Charge Joseph Carrico of the FBI Knoxville Field Office.

The trial of the remaining defendants will commence July 13, 2021, in the district court in Knoxville, Tennessee.

The prosecution and plea agreements were coordinated by Assistant U.S. Attorneys TJ Harker, Mac Heavener, Anne-Marie Svolto, and Gretchen Mohr of the U.S. Attorney's Office for the Eastern District of Tennessee, and Tri-

These plea agreements resulted from a multi-year investigation conducted by the

U.S. Department of Health & Human Services Office of Inspector General (Nashville); Food and Drug Administration Office of Criminal Investigations (Nashville); U.S. Postal Service, Office of Inspector General (Buffalo, New York); Federal Bureau of Investigation (Knoxville and Johnson City, Tennessee); Office of Personnel Management Office of the Inspector General (Atlanta); and the Department of Homeland Security, Homeland Security Investigations (Tampa). The U.S. Marshals Service also assisted in the investigation and the forfeiture of assets.
