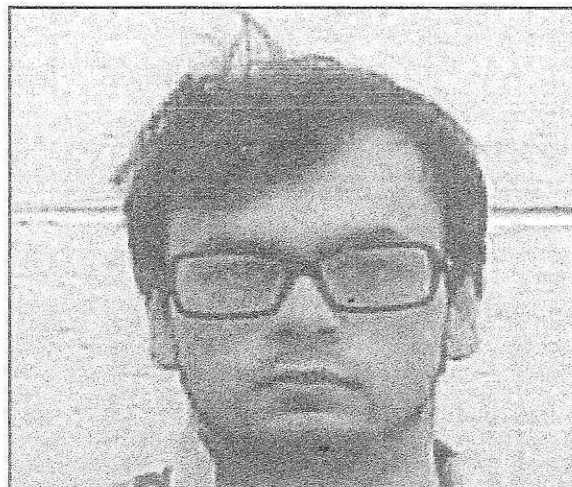

## Federal Pharmacy Partnership Expands Access to COVID-19 Vaccination in Tennessee

### Walmart Pharmacy Locations Selected as Tennessee Partner

Tennessee will see expanding access to COVID-19 vaccination with the launch of a new federal retail pharmacy program. The first phase of the Federal Retail Pharmacy Program for COVID-19 Vaccination will launch in Tennessee Febru-

ary 12, with select pharmacies offering vaccinations in accordance with the state's COVID-19 Vaccination Plan. These vaccinations will be provided at no cost to patients and will be available by appointment only.

"We continue to advocate for Tennesseans by maximizing every dose of COVID-19

vaccine made available for people in our state. We are eager to collaborate with our federal partners to expand access to this vital resource for Tennesseans in the communities where they live and work," said Tennessee Health Commissioner Lisa Piercey, MD, MBA.

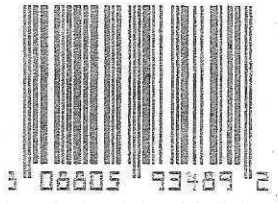

Kelsey Heath, 28, Ponder Road Knoxville, was charged with DUI, Leaving the Scene of Accident with Property Damage, and Failure to show proof of INS.

Deputy D. Slemp LCSO, responded to Foster Road for a crash. Upon arrival, Deputy observed a red Chrysler Van which had backed into a ditch and barbed-wire fence in front of the caller's

address. The vehicle was abandoned by the driver per witness on the scene. Witness acquired the offender's name and identified her as Kelsey Heath. Witness stated a vehicle picked her up in a silver four door sedan and travelled around the curve from the scene, which was located at Foster Road. Witness provided video from his phone identifying the offender in the driver's seat and her lack of ability to follow simple directions, including the inability of placing the vehicle in park, leaving the vehicle in neutral and revving the motor. Witness ultimately had to assist the offender in placing it in park. The offender was located at Foster Road by Cpl. L. Anderson. After the vehicle was towed from the original scene by Mon-eymaker's, Deputy met Cpl.

Anderson and made contact with the offender, who was identified from the video provided by the witness. Upon interview, the offender exhibited possible signs of being under the influence including a noticeable lack of balance and dilated pupils. The offender was asked if she would submit to SFST/ARIDE, which she agreed to. SFST was performed by Dep. A. Parton. Dep. A. Parton indicated that she performed poorly. The offender was subsequently placed under arrest. The offender was asked if she would submit to blood draw and she agreed. The offender was transported to Fort Loudon Medical Center Emergency Department and a blood sample was drawn. The offender was then transported to the Loudon County Jail without incident.

In addition to the almost 400 vaccination sites currently offered by county health departments, hospitals, federally-qualified and faith-based health centers and community pharmacies, Tennesseans eligible to receive COVID-19 vaccination per Tennessee's COVID-19 Vaccination Plan will have access to vaccinations at additional pharmacies across the state through this new program. The Federal Retail Pharmacy Program for COVID-19 Vaccination is a public-private partnership with national pharmacy partners and networks of independent pharmacies.

As of Feb. 11, TDH has been notified of 121 Walmart pharmacy locations across Tennessee that will offer COVID-19 vaccination through this program. These pharmacies will follow the

vaccination plan phasing of the counties in which they are located. For details on participating locations and to schedule an appointment online, visit [www.walmart.com/covidvaccine](http://www.walmart.com/covidvaccine).

The Centers for Disease Control and Prevention worked with states to select initial pharmacy partners based on several factors including their ability to reach some of the populations most at risk for severe illness from COVID-19. A total of one million total doses of Moderna vaccine are being provided for the first week of the program nationwide, and additional doses will be allocated to the program weekly, based on the available supply of COVID-19 vaccines. Vaccine allocations provided for this program are in addition to the weekly allocation going to states and may initially be limited in quantity.
