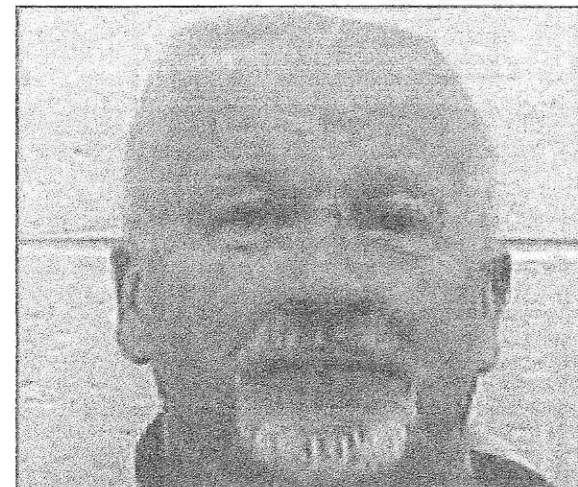

## Tennessee State Parks Respond To Surge in Visitors With Arrive Outdoors To Deliver Affordable Gear Rentals

In response to a surge of visitors to Tennessee State Parks last year, the parks today announced a new partnership with Arrive Outdoors to make gear more affordable for park visitors. The plan is to offer gear that visitors can rent as opposed to buying expensive gear outright.

Arrive Outdoors

provides equipment for hiking, backpacking, camping, winter recreation and other outdoor activities. The company offers high-quality, sturdy equipment for rent — either individual items or complete sets. A two-person tent rents for as little as \$12 per day. Camping sets that include a tent, sleeping pad, cooler, camp

stoves, and more, rent for as little as \$60 per day.

“Many people want more of the outdoors but are not prepared for it because it requires a lot of gear, and the gear can be expensive,” Jim Bryson, deputy commissioner of the Tennessee Department of Environ-

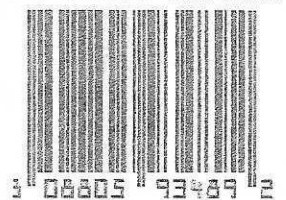

tor Vehicle.

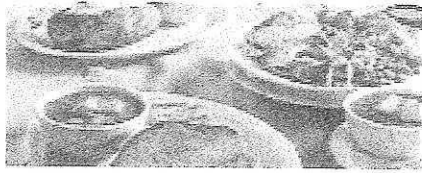
Deputy Rogers LCSO, observed a Ford Explorer with a bright white tag light visible from the rear obstructing a portion of the vehicle's registration. Deputy initiated a

traffic stop on Adesa Blvd at Hwy 321 and made contact with the driver/offender, Mr. Devin Kelley. The offender had a sweaty flushed complexion and his pupils were dilate so much Deputy could barely determine his eye color. Deputy also observed an opened beer bottle in the driver side cup holder along with numerous throughout the floorboard. Upon further investigation Mr. Kelley stated he had consumed a few twisted teas, smoked marijuana and used meth this said evening. He further stated that there was a marijuana grinder and bowl in his backpack in the backseat. The offender did consent to S.F.S.T and A.R.I.D.E testing and performed poorly. Deputy then performed a probable cause search of the vehicle and recovered a marijuana grinder & bowl along

with a scale with crystalized residue. Upon searching the offender's person Deputy also recovered a small black container with crystalized residue within it. Deputy then took the offender into custody for Driving Under the Influence and Possession of Drug Paraphernalia. I supplied and read Mr. Kelley the TN Implied Consent Advisement to which he did consent to a blood draw. 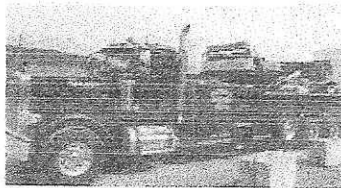

Deputy Chance Gray LCSO, was dispatched to the area of Highway 11 near Muddy Creek Road in reference to a report of someone driving down the road with a flat tire. Upon arrival into the area Deputy observed a white dodge ram driving in the lane of travel with a flat passenger side front tire. Upon stopping the vehicle, Deputy made contact with the driver a Mr. Leonard D Bean who exited his vehicle as Deputy was exiting his vehicle. equipment, people simply use the packaging the gear arrives in, adhere the free return label and tape provided, and drop off at any FedEx or Walgreens location.

Deputy S. Gaumer LCSO, observed a possibly intoxicated female at Waffle House in Lenoir City, TN.

Deputy observed a white female leave the Waffle House in Lenoir City. This female was unsteady on her feet, slurred her speech when speaking, and walked past her car as if she had forgotten where she parked it. Due to these behaviors, Deputy exited Waffle House and proceeded to his car. The female got in to her black Nissan Maxima and exited the parking lot ahead of him. Deputy was able to get behind the car at Highway 321 near Adesa Boulevard. At this point, the vehicle turned right on Adesa, came to a


stop in the road, and turned around back towards Highway 321. The vehicle came to a stop partially in the left turn lane and and partially in the lane to that continues straight. his vehicle. While walking towards my vehicle, Deputy could see that she was unsteady on her feet. Ms. Donnelly was asked if she would participate in voluntary standard field sobriety tests (SFST's) and she said yes. Ms. Donnelly completed all three tests and performed


