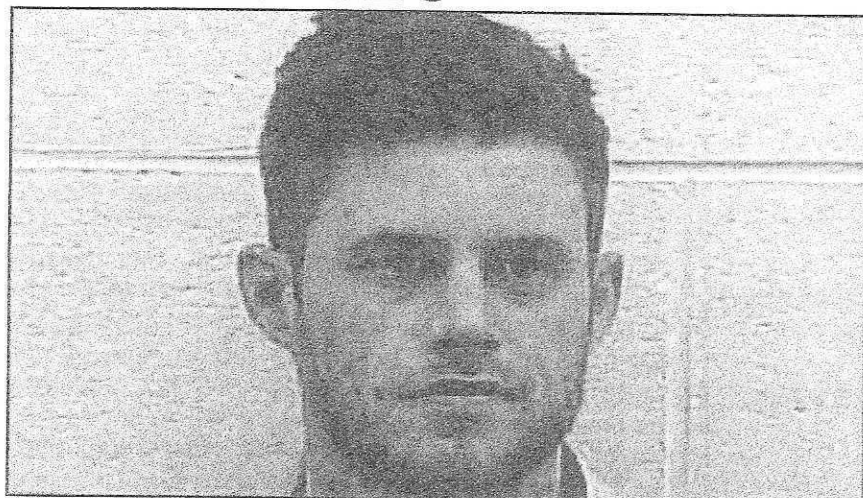

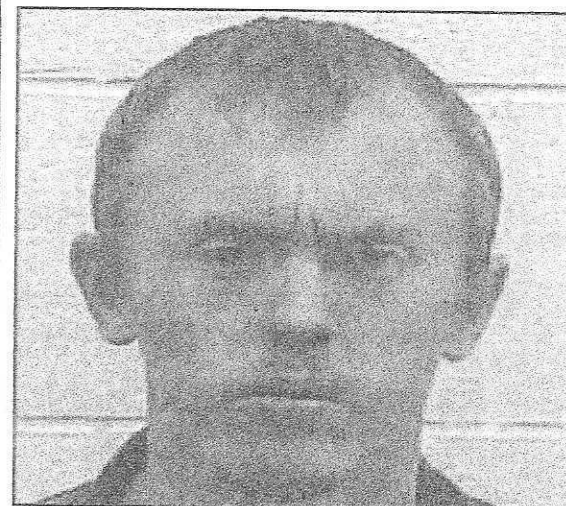

Two Mexican Citizens Sentenced For Robbery Spree

On February 3, 2021, Juan Sanchez, 24, a citizen of Mexico, was sentenced by the Honorable Thomas A. Varlan, in the United States District Court for the Eastern District of Tennessee at Knoxville. Emanuel Trejo, 22, also of Mexico, Sanchez's co-defendant, was sentenced on November 12, 2020 by the

Honorable Thomas A. Varlan.

As part of their plea agreements, Juan Sanchez and Emmanuel Trejo agreed to plead guilty to an indictment charging them with three counts of Hobbs Act Robbery and three counts of brandishing and discharging a firearm in relation to those robberies. Juan Sanchez was sen-

tenced to 288 months in prison. Emmanuel Trejo was sentenced to 192 months in prison. Both Sanchez and Trejo are subject to deportation following their terms of incarceration.

The federal Hobbs Act Robbery statute encompasses robberies of businesses or people engaged in in-

Bradley Christian, 32, Hwy 11 E Lenoir City, was charged with Violation of Order of Protection, Domestic Assault x2, and Joyriding. Deputy Bengel LCSO, re-

sponded to Hwy 11 E about a Domestic. Upon arrival, it was discovered that the Offender, Bradley Christian, had fled in a 2018 Ford Fusion that belongs to one of the Victims.

Deputy spoke to victim, who stated that Bradley was upset that she would not give him any money, got into her face and started to scream at her. Bradley began punching and kicking holes in the wall within his bedroom and at some point, he forcefully tore an interior door off of the hinges.

While on the scene Deputy observed the door, with hinges hanging off of it, leaned up on a wall within the living room. Christian continued to yell and began making threats to break belongings in the residence in retaliation for not providing him currency.

The brother of the offender, tried to stop the altercation to no avail. Victim currently has an active Order of Protection against Christian and he is not to be around her. Christian demanded the

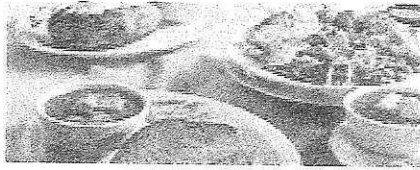
keys to victim car and she told him he couldn't take it.

Christian ripped the keys from victim hand and fled into the vehicle. While gathering statements from victims and witness, son and nephew to Christian stated that he was present for the incident and was in fear. Witness also stated that Christian has threatened to kill him in the past and frequently assaults him.

All 4 subjects live in the same residence. The homeowner called and stated that Christian had shown up at the residence. Deputy arrived back on the scene and Christian was taken into custody and transported to the Loudon County Jail.

Christian is being charged with 2 counts of Domestic Assault, Violation of an Order of Protection, and Joyriding.

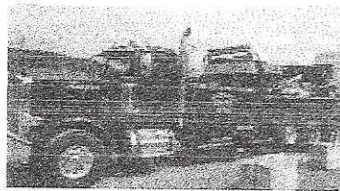

Jennifer Bennett, 45, Vonnore Road Loudon, was charged with Driving under the Influence.

Deputy Green LCSO, observed a white Lexus traveling South on Hwy 11. Deputy observed this vehicle drift into the opposite lane of travel several times.

Deputy initiated traffic stop on this vehicle at the Grizzly Pig. Deputy made contact with the driver, Jennifer Bennett, and observed Ms. Bennett was lethargic and took an unusually long time to respond to basic questions.

Deputy requested Ms. Bennett to perform SFST and ARIDE testing in which she consented. Prior to testing Ms. Bennett stated she ingested a Percocet

at approximately 10:00am on this date. Ms. Bennett gave several clues and indications of impairment during testing and during testing Deputy observed a white substance inside her left nostril.

Deputy took Ms. Bennett into custody for driving under the influence of drugs. Ms. Bennett was transported to Fort Loudon Medical Center where she consented to a blood draw. After Ms. Bennett provided a blood sample Deputy issued Miranda Warning. Ms. Bennett stated she did wish to answer questions.

Ms. Bennett stated she ingested alprazolam and oxycodone via nasal inhalation but was unsure of the time.

terstate commerce. Sanchez and Trejo committed three armed robberies of three businesses in Knox, Loudon and Blount Counties in 2019.

One of those robberies was of the La Lupita store in Maryville, Tennessee. During that robbery, Sanchez fired multiple shots from his firearm. Fortunately, no one was injured.

"The lengthy sentence in this case strongly reflects the continued positive impact our federal, state, and local law enforcement partnerships have on stopping and prosecuting armed robberies within our communities. Our office will continue to aggressively prosecute those who commit armed robbery," said U.S. Attorney J. Douglas Overbey.

This robbery had a major impact on the family who owns La Lupita as well as the customers who shop there,

"Sheriff James Lee Berrong said. "Mr. Sanchez and Mr. Trejo committed a violent crime against citizen of our community, and our investigators took that to heart and worked extremely hard to solve this case. We are grateful to the FBI for taking the case to the federal level, equating to stiffer penalties. We are also proud of our working relationships with law enforcement agencies at all levels of government, and thankful our partnership worked so well in this case."

The criminal indictment was the result of an investigation by the Blount County Sheriff's Department and Federal Bureau of Investigation's Safe Streets Task Force. This investigation was led by FBI Special Agent Wesley Latham.

Assistant United States Attorney Cynthia F. Davidson represented the United States.

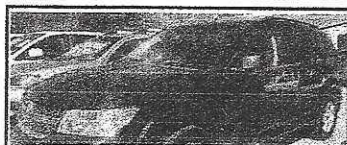
Whittney Hunter, 30, Lakeside Drive Kingston, was charged with Simple Possession x2, and Contraband in a Penal Institution.

Upon arriving at the jail Ms. Hunter was asked if she had any contraband in or on her person. While conducting a strip search of the offender Corrections Deputy Slattery recovered approximately 0.3

grams of Heroin and approximately 0.5 grams of Marijuana in the offenders privates. Ms. Hunter was also charged with Simple Possession of Schedule I and Schedule VI along with Contraband in a Penal Facility. Said did occur in Loudon County, TN.

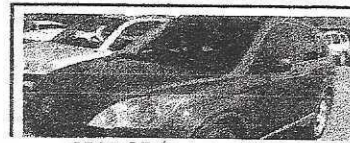

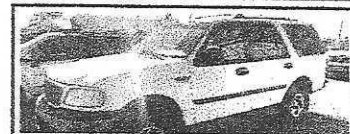

Deputy Bengel LCSO, responded to Whitney Drive in reference to a Welfare Check and a suspicious male. Dispatch advised that the complainant sounded intoxicated and requested extra patrol for the area at his ex wife's house.
