Telford Man Sentenced For Being A Felon In Possession Of A Firearm

On February 8, 2021, Lyle Vernon Tarlton, 30, of Telford, was sentenced by the Honorable J. Ronnie Greer, in the United States District Court for the Eastern District of Tennessee at Greenville.

Tarlton plead guilty to possessing a firearm after having been convicted of an offense punishable by

imprisonment exceeding one year. Tarlton was sentenced to 63 month's imprisonment followed by three years on supervised release.

On August 13, 2019, deputies with the Washington County Sheriff's Office found Tarlton asleep in a vehicle parked on the side of

a road in Telford, Tennessee. Tarlton, who was sitting in the driver's seat with the keys in the ignition, was asked to step out of the vehicle. Deputies observed a short barrel shotgun laying between the driver's seat and the driver's door. Tarlton, who had pre-

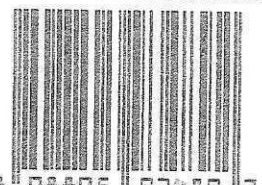
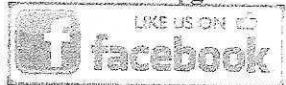

had taken a xanax prior in the evening.

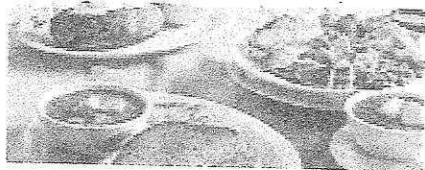

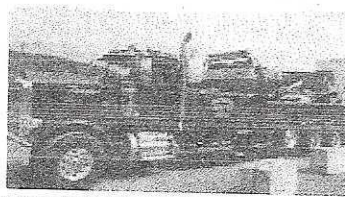

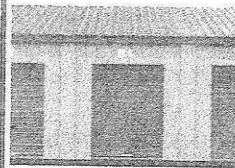
one alcoholic drink and ingested meth. The vehicle was released from the

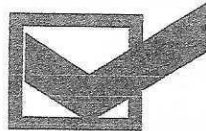

viously been convicted of a felony, was prohibited from possession of a firearm. Additionally, it is a violation of federal law to possess a shotgun with a barrel shorter than 18 inches that has not been registered in the National Firearms Registration and Transfer Record.

The criminal indictment was the result of a joint investigation by the Washington County Sheriff's Office and Bureau of Alcohol, Tobacco, Firearms, and Explosives.

Assistant United States Attorney J. Gregory Bowman represented the United States.

This case was brought as part of Project Safe Neighborhoods (PSN), a comprehensive national strategy that creates local partnerships with law enforcement

agencies to effectively enforce existing gun laws. It provides more options to prosecutors, allowing them to utilize local, state, and federal laws to ensure that criminals who commit gun crime face tough sentences. PSN gives each federal district the flexibility it needs to focus on individual challenges that a specific community faces.

LaFollette Man Sentenced For Distribution Of Child Pornography

On February 18, 2021, Timothy Wayne Turben, 40, of LaFollette, Tennessee, was sentenced by the Honorable R. Leon Jordan, U.S. District Judge, to serve 97 months in federal prison for knowingly distributing child pornography in interstate commerce.

Following his imprisonment, Turben will be super-

vised by the U.S. Probation Office for five years and will be required to register with the state sex offender registry in any state in which he lives, works, or attends school.


The investigation began after a social media company notified the National Center for Missing and Exploited Children that the defendant's social media account was utilized to send child pornography to others through the internet. In October 2018, the FBI executed a federal search warrant and seized computer devices containing 75 digital videos and over 1000 images of child pornography from Turben's residence. Turben confessed that he had sent child pornography to others with his social media account.

The case was investigated


by the Federal Bureau of Investigation.

Assistant U.S. Attorney Matthew T. Morris represented the United States in court.


This case was brought as part of Project Safe Childhood (PSC), a nationwide initiative to combat the growing epidemic of child sexual exploitation and abuse launched in May 2006 by the Department of Justice. Led by U.S. Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity Section, PSC marshals federal, state and local resources to better locate, apprehend and prosecute individuals who exploit children via the Internet, as well as to identify and rescue victims. 



Knox County Public Library and Mayor Jacobs congratulate Erin Nguyen

On January 25, 2021, the American Library Association announced the winner of the coveted Caldecott Medal, which honors the artist of the most distinguished American picture book for children published in the previous year. We Are Water Protectors, illustrated by Michaela Goade, written by Carole Lindstrom, earned the prestigious award and takes its place next to other classic titles including Where the Wild Things Are by Maruice Sendak, The Snowy Day by Ezra Jack Keats, and The Polar Express by Chris Van Allsburg.

Behind the prestigious award is a committee that reads hundreds of books and selects the medalist and honors. Erin Nguyen, Children's Services Manager at the Knox County Public Library, served on the 2020-21 selection committee.

A Knoxville native, Nguyen attended Farragut High School and UTK. She earned her Master's in Library and Information Science (MLIS) at the University of South Carolina. She has been the Children's Services Manager at the Knox County Public Library since 2010 after working in the field at the Charlotte-Mecklenburg Public Library.

"Serving on a book award committee has been a dream of mine since becoming a librarian. It was a real honor to be chosen to serve," said Nguyen. "I've developed an even deeper love for children's books and the artistry and creativity that authors and illustrators bring to these works. Picture books are a child's first introduction to literature and art, and I'm

glad that this award gives us a chance to shine a spotlight on some of the best books published each year."

"It is a great reflection on our community that we have such dedicated professionals who rise in their fields and contribute to their industry," said Knox County Mayor Glenn Jacobs. "We are very proud of Erin for her role in selecting the 2021 Caldecott winners."

Wiley Cash, Frank X Walker to Present Virtual Lecture on March 9

Novelist, Poet Will Present Wilma Dykeman Stokely Memorial Lecture

Authors Wiley Cash and Frank X Walker will present the 2021 Wilma Dykeman Stokely Memorial Lecture on Tuesday, March 9, at 6:30 p.m. This virtual event is free and open to the public. Registration for the event is now open.

Frank X Walker was the first African American writer to be named Kentucky Poet Laureate and currently heads the MFA program at the University of Kentucky. A founding member of the Affrilachian Poets, he has published ten collections of poetry, including Last Will, Last Testament, winner of the 2020 Judy Gaines Young Book Award, and Turn Me Loose: The Unghosting of Medgar Evers, which was awarded the 2014 NAACP Image Award for Poetry. His newest collection, Masked Man, Black: Pandemic & Protest Poems, gathers poems Walker began writing and posting on Facebook in April 2020 and is a remarkably timely response to this

extraordinary, still-unfolding era.

Wiley Cash is the New York Times bestselling author of the novels A Land More Kind Than Home and This Dark Road to Mercy. The founder of the Open Canon Book Club and co-founder of the Land More Kind Appalachian Artists Residency, he has been a fellow at the MacDowell Colony, Yaddo, and the Weymouth Center. He serves as the writer-in-residence at the University of North Carolina-Asheville. His most recent novel is The Last Ballad, which recounts the struggle of the labor movement in early twentieth-century America through the story of North Carolina mill worker Ella Mae Wiggins.
