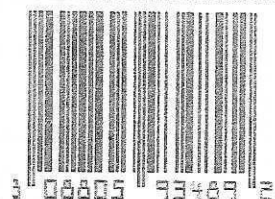
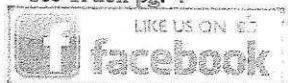

Eric Tipton, 31, Nichols Road Lenoir City, was charged with Domestic Assault, and Violation of Order of Protection x2.

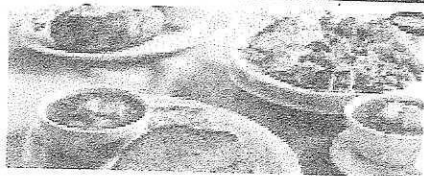
Dep. A. Parton LCSO, responded to Nichols Road in

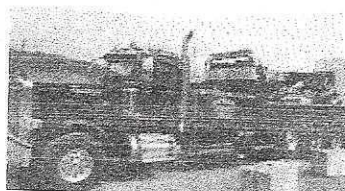

Jacob Cook, 27, N. Cedar Bluff Road Knoxville, was charged with DUI, Driving on Revoked/Suspended, and Violation of Implied Consent.

Deputy Clay Jenkins LCSO, responded to a wreck on I-75 SB around the 76 MM. Upon arrival, Deputy observed a wrecked GMC truck OH registration HGU1743 with the driver Jacob Cook standing beside his vehicle. Deputy then made contact with Mr. Cook who advised he wrecked his truck and believed to be in Knoxville. Deputy then observed the strong odor of an alcoholic beverage coming from Mr. Cook's person along with him to be lethargic in which he advised that he had drank three Dos Equis beers. Mr. Cook then agreed to perform

Standardized Field Sobriety Testing in which he performed poorly. Mr. Cook then refused to provide a blood or breath sample. It was then found that Mr. Cook's license out of Ohio was suspended, confirmed through Loudon County dispatch. Investigators determined that Winter misappropriated at least \$1,695.70 by using system funds to outfit and clean his personal pickup truck.

Winter used the system's charge accounts at auto stores and a system credit card to make purchases for his vehicle. These purchases included:

\$725 for a truck bed cover;

\$371.70 for two new tires; and

\$599 for a monthly car wash subscription.

Winter told investigators that he purchased the truck bed cover to protect system files when they were being transported. He explained the tires and car washes were purchased to repair

damage or clean off mud debris that occurred during his trips to the county landfill. Winter received a \$650 per month vehicle allowance payment; however, he told investigators that he did not consider the mud to be normal wear and tear on his vehicle.

In January 2021, Dan Winter was indicted on one count of theft over \$1,000 and one count of official misconduct.

"In addition to the problems noted above, the system's board of directors should ensure they are providing adequate oversight over the director's time on the job," said Comptroller Jason Mumpower. "The director was not required to complete a time sheet. Those records should be produced, reviewed, and approved. System officials

have indicated they are addressing this deficiency."
