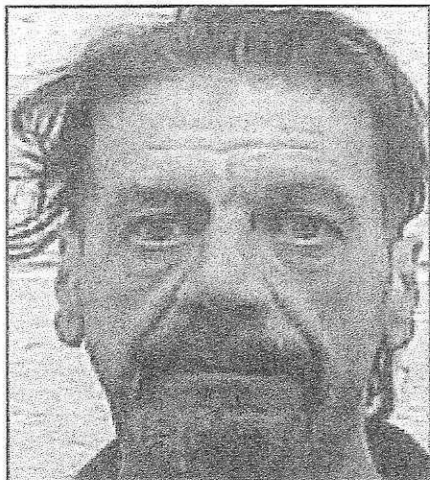

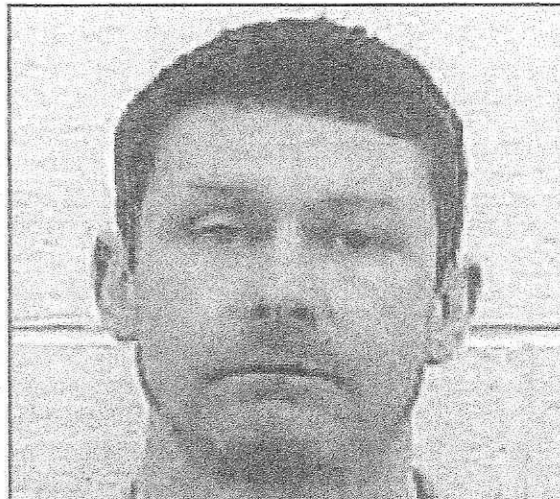

Comptroller's Office Reviews State Veterans' Benefits

The Tennessee Comptroller's Office has released a report detailing more than 40 benefits, services, and protections for veterans and their families that are provided by state agencies.

For each benefit or service, the Comptroller's Office of Research and Edu-

cation Accountability included data, when available, on the number of veterans receiving the benefit, and the state expenditures to provide the benefit or the state revenue forgone when state fees are waived or discounted for veterans.

A number of Tennessee agencies pro-

vide benefits to veterans including the Tennessee Departments of Veterans Services, Revenue, Mental Health and Substance Abuse Services, Treasury, Safety and Homeland Security, and Environment and Conservation, as well as

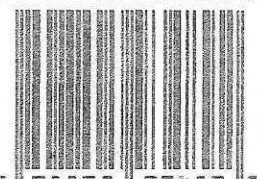
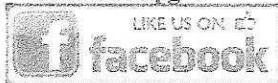

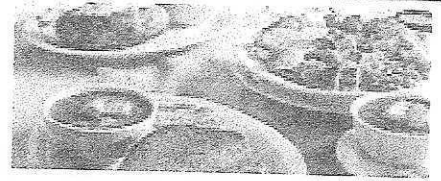

Deputy Clay Jenkins LCSO, conducted a traffic stop at Grove St on a black Jeep Grand Cherokee TN registration 9X94H7 after the vehicle almost struck his patrol vehicle at the intersection of Grove St and Clyde St. Deputy then made contact with the driver Ronald Gleaton and observed there to be a needle in the cup holder which Mr. Gleaton advised it was used for narcotic use. Deputy then asked Mr. Gleaton if he could search his person in which he agreed. Deputy then found 1.5 grams of a clear crystal like substance (methamphetamine) on Mr. Gleaton's person. Deputy then made contact with the passenger and owner of the vehicle Jennifer Gleaton who then agreed to a search of her vehicle. Upon search of the vehicle, Deputy then located .8 grams of a crystal like substance (methamphetamine) in a small black box in the passenger side door. Mrs. Gleaton advised that it was not hers but her boyfriends. Mr. Gleaton advised he did not know about the black box. Both were then taken into custody and transported to the Loudon County Jail without incident. Once at the jail, Lt. Shane Ezell then tested both substances with TruNarc which both tested positive for methamphetamine scan numbers 406 and 408. All of this did occur in Loudon County, TN.

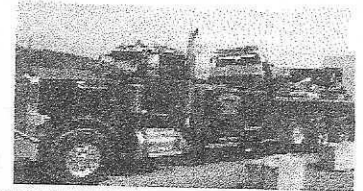

Melanie Robertson, 43, Clinch Ave Knoxville, was charged with Legend Drugs, Public Intoxication, Simple Possession, and Poss. of Drug Para.

Deputy Bengel LCSO, responded to the TA on Watt Rd. in reference to an Unwanted Guest call that involved a male that committed a theft within the TA. Upon arrival Deputy made contact with the Offender, who was in the passenger seat of a Dodge Durango. Deputy spoke with male earlier in the morning regarding a possible overdose on a separate call for service. Male checked to be ok and refused EMS. When Deputy made contact with the male for the 2nd time, he appeared to be under the influence. Deputy spoke to male about the theft and after originally denying

it, he admitted to it. Deputy also made contact with the 2nd Offender, Melanie Robertson, who was in the driver seat of the Durango. Robertson also appeared to be under the influence. Both parties consented to HGN and performed poorly. The male stated that he was having chest pains and EMS responded. The male stated to Deputy Lewis that there was Heroin in the vehicle. Robertson consented to a search of the vehicle. In the glovebox Deputy located a plastic box with what was later discovered to be .8 grams of Fentanyl and a broken pipe with residue inside. Pipes such as the one found are commonly used to smoke illicit narcotics. In a duffle bag in the back seat Deputy Lewis located 5 baggies with residue inside and a scale. Attached to the duf-

file bag Deputy located a silver pill bottle keychain and located a 1 yellow capsule pill with 102 IP imprinted on it, later identified to be 300 mg Gabapentin. Both male and Robertson were read Miranda and denied ownership of the contraband. The male was transported to the Tennova in Turkey Creek by EMS and Robertson was transported to the Loudon County Jail. This did occur

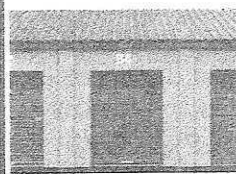

the Tennessee Wildlife Resources Agency, Tennessee State Veterans' Homes, and the Tennessee Comptroller's Office, among others.

In fiscal year 2019-20, recurring state-funded veterans benefits and services of at least \$30.3 million and nonrecurring benefit costs of at least \$1.1 million were identified for veterans services for which costs could be calculated.

The largest recurring state cost that year was the state's expenditure for disabled veterans' property tax relief. At \$20.9 million, it had a larger state fiscal impact than the remaining recurring benefits and services combined. The next largest cost was the approximately \$6.2 million in state appropriations for

the Tennessee Department of Veterans Services. The main duties of the department are to provide information and assistance to veterans through its local offices and to maintain and operate the state's veterans cemeteries.

Other veteran-related state expenditures are non-recurring, such as capital appropriations used as matching funds to qualify for federal nursing home construction grants or for land acquisition for nursing homes or state veterans cemeteries.

All states offer a variety of benefits and services to their veterans. At least three-fourths of other states offer benefits similar to many of those offered by Tennessee, including: a state-level department for veterans services; ceme-

teries and nursing homes for veterans; property tax relief; veteran specialty license plates and designations on driver licenses; state job hiring preferences; out-of-state tuition exemptions; and discounted rates on hunting and fishing licenses and camping fees.
