

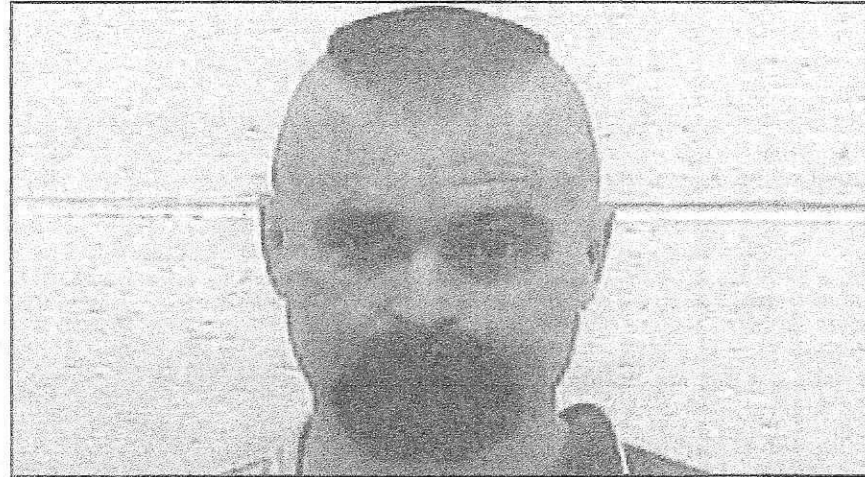

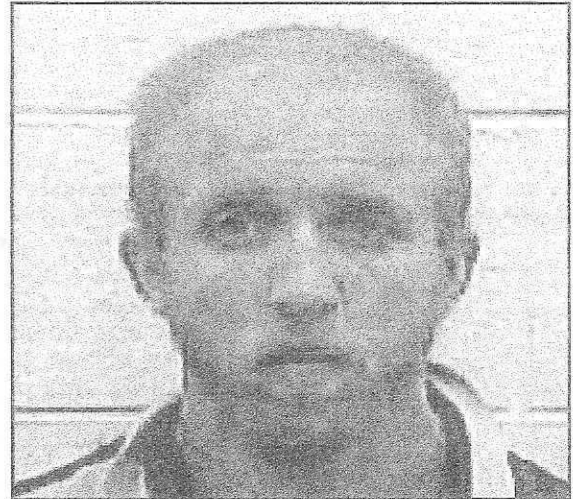

## CDC Issues First Set of Guidelines on How Fully Vaccinated People Can Visit Safely with Others

The Centers for Disease Control and Prevention (CDC) issued its first set of recommendations on activities that people who are fully vaccinated against COVID-19 can safely resume.

The new guidance — which is based on the latest science — includes recommendations for how and when a fully vaccinated individual can visit

with other people who are fully vaccinated and with other people who are not vaccinated. This guidance represents a first step toward returning to everyday activities in our communities. CDC will update these recommendations as more people are vaccinated, rates of COVID-19 in the community change, and additional

scientific evidence becomes available.

“We know that people want to get vaccinated so they can get back to doing the things they enjoy with the people they love,” said CDC Director Rochelle P. Walensky, MD, MPH. “There are some activities that fully vaccinated

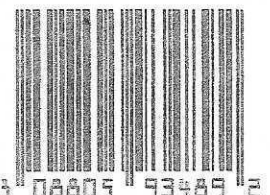

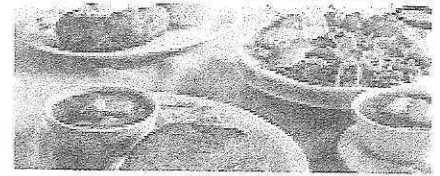

Barrett Britt, 47, Jacksonian Way Lenoir City, was charged with Resisting Arrest, Vandalism, and Public Intoxication.

Deputy B. Dishner LCSO, along with Deputy C. Gray responded to Jacksonian Way to a call of a male subject trying to enter the residence. Upon arriving on scene Deputy observed a male subject standing in front of the garage to the residence. The male subject was given verbal commands to remove his hands from his pockets, and step toward his patrol vehicle to which he complied. The male was very unsteady on his feet, and Deputy noticed he had urinated himself. While performing a pat down for weapons Deputy could smell a strong odor of alcohol admitting from his person. During this time the subject stated he was at his residence Jacksonian Way. The subject refused to leave his hands on Deputy patrol vehicle during the pat down, and continued to attempt to turn around on Deputy Dishner, and Deputy Gray. At that time Deputy attempted to place the subjects hands behind his back, and to detain him. He began to actively resist, and pull away from deputies. He was then taken to the ground where he continued to actively resist, refusing to place his hands behind his back, and attempting to get away from deputies. After using empty hand techniques, and deploying a drive stun by a X-26 taser deputies were able to take the subject into custody. During the time of him resisting he continued to grab at Deputy arm breaking the band off of my watch. Once the subject was in custody he was identified as Barrett Britt. He was then transported to the Loudon County Jail. This did occur in Loudon County Tennessee.

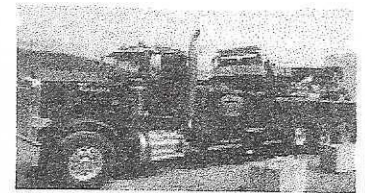

people can begin to resume now in their own homes. Everyone – even those who are vaccinated – should continue with all mitigation strategies when in public settings. As the science evolves and more people get vaccinated, we will continue to provide more guidance to help fully vaccinated people safely resume more activities.”

Visit with other fully vaccinated people indoors without wearing masks or staying 6 feet apart.

Visit with unvaccinated people from one other household indoors without wearing masks or staying 6 feet apart if everyone in the other household is at low risk for severe disease.

Refrain from quarantine and testing if they do not have symptoms of COVID-19 after contact with someone who has COVID-19.

A person is considered fully

ly vaccinated two weeks after receiving the last required dose of vaccine. Although vaccinations are accelerating, CDC estimates that just 9.2% of the U.S. population has been fully vaccinated with a COVID-19 vaccine that the FDA has authorized for emergency use.

While the new guidance is a positive step, the vast majority of people need to be fully vaccinated before COVID-19 precautions can be lifted broadly. Until then, it is important that everyone continues to adhere to public health mitigation measures to protect the large number of people who remain unvaccinated.

CDC recommends that fully vaccinated people continue to take these COVID-19 precautions when in public, when visiting with unvaccinated people from multiple other households, and when around unvaccinated people who are at high risk

of getting severely ill from COVID-19:

Wear a well-fitted mask.

Stay at least 6 feet from people you do not live with.

Avoid medium- and large-sized in-person gatherings.

Get tested if experiencing COVID-19 symptoms.

Follow guidance issued by individual employers.

Follow CDC and health department travel requirements and recommendations.
