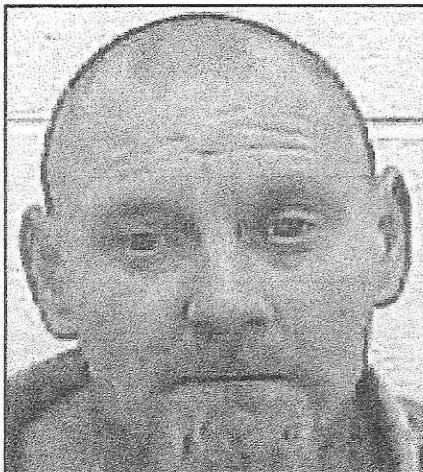

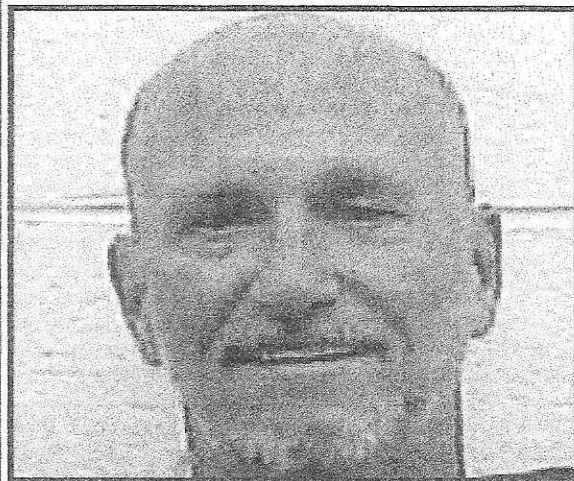

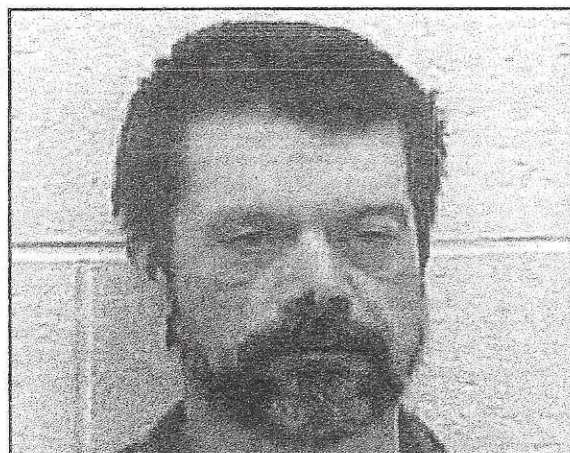

Former Lincoln County School Bookkeeper Indicted for Theft

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Angela Osborne, the former bookkeeper at the Highland Rim School in Fayetteville, Tennessee. The investigation began after school officials discovered and reported low balances in Highland Rim's accounts and a

general disarray of records in the bookkeeper's office.

Osborne served as Highland Rim's bookkeeper from January 2018 through June 2019. During this time, she was also Lincoln County High School's (LCHS) color guard sponsor.

Investigators determined that Osborne

stole money and made unauthorized purchases with Highland Rim School funds totaling at least \$6,127.34. This includes:

\$2,417 that was never deposited to the Highland Rim School's bank account;

\$3,479.35 of High-

land Rim School money that Osborne used to purchase LCHS color guard equipment. For example, Osborne ordered shirts for the LCHS color guard but paid for the shirts from the Highland Rim School volleyball account; and A \$230.99 personal purchase of a drum practice pad using Highland Rim School funds.

Osborne misused the school's accounting software to conceal her activity and left the school's records in disarray. Due to the condition of the records, investigators could not determine that all of Highland Rim School's funds were properly accounted for.

In April 2021, Angela Osborne was indicted on one count of theft over \$2,500, and one count of destruction and tampering with govern-

mental records.

"School officials must ensure that checks and balances are built into their financial operations," said Comptroller Jason Mumpower. "One person should not be given too much control of the money without adequate oversight."

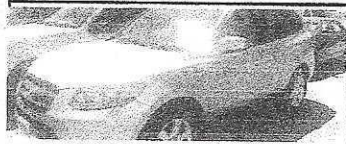
"We created this series to encourage the reading of poetry and to highlight KCPL's outstanding poetry collection," commented May.

Deputy Green LCSO, responded to the area of Interstate 75 South Bound near the 79 Mile Marker in reference to a reckless driver. Dispatch stated two separate caller's stated this vehicle was all over the roadway and had struck several street signs near the 81 mile marker. Complainants also advised this vehicle had lost the front bumper and was driving on a flat tire. Deputy arrived on scene and made contact with the driver, Wallace Cowan. Deputy observed Mr. Cowan to be very unsteady on his feet. Deputy requested Mr. Cowan to perform Standard Field Sobriety and ARIDE testing in which he consented. Mr. Cowan was unable to follow instructions on HGN. While attempting walk and turn Mr. Cowan lost his balance, nearly falling to the ground on his 12th step so Deputy stopped testing due to safety concerns. Mr. Cowan did perform poorly on One Leg Stand and could

not follow instructions on ARIDE testing. Deputy took Mr. Cowan into custody for driving under the influence. Deputy read Mr. Cowan TN Implied Consent in which he consented to provide a blood sample for testing. Mr. Cowan was transported to Fort Loudon Medical Center for a blood draw, where Mr. Cowan made a voluntary statement that he consumed half of a "totem pole". Deputy issued Mr. Cowan Miranda Warning and asked him to clarify in which he stated he consumed a partial Xanax tablet approximately 40 minutes prior to our encounter. Deputy then transported him to Loudon County Jail without incident. Once Mr. Cowan entered Loudon County Jail, he was searched by a corrections officer on scene which revealed Mr. Cowan possessed approximately "11" 2mg Alprazolam tablets in his sock and a strip of Suboxone. It was determined Mr. Cowan did commit the offenses of driving under the influence, simple possession x2, introduction of contraband into a penal facility, and due care. All the above did occur in Loudon County, TN.

he did not use drugs. Ms. Murphy appeared extremely impaired and had a green substance coating the inside of her nostril. More baggies with residue were found in Ms. Murphy's possession. After searching the vehicle Deputy recovered a meth pipe, marijuana pipe and scales with drug residue. Mr. Besenfelter consented to SFST/ARIDE testing and showed clues being extremely impaired. 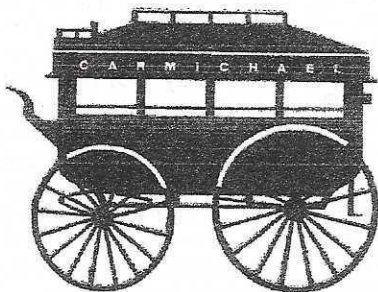

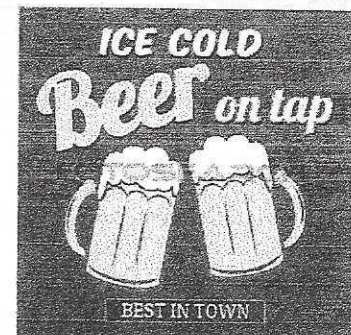
