



Teen Charged With Child Abuse or Bristol Realtor Sentenced To 10 Years For Ponzi Scheme

Tammy Lynn Hawk, 47, of Bristol, was sentenced by Honorable Clifton L. Corker, in the United States District Court for the Eastern District of Tennessee at Greeneville.

As part of a negotiated plea agreement, Hawk pled guilty to an information in January 2021. The information charged Hawk with one count each of

wire fraud, aggravated identity theft, money laundering, and making a false tax return. Hawk was sentenced to 10 years in prison, followed by three years' supervised re-lease. Hawk will be required to make restitution of \$658,838 to her unpaid victims and \$71,062 in unpaid taxes to the United States.

According to court

records, Hawk was a well-established real estate agent in the Bristol, Tennessee area. Despite the success she enjoyed as a realtor, she ultimately used her knowledge, skills, and clientele to devise and operate a Ponzi-type scheme. Under her scheme, she would notify victim

Leaving Scene

Christopher Wheat, 32, Stallcup Road Philadelphia, was charged with Leaving the Scene of Accident with Property Damage, DUI, Violation of Implied Consent, Resisting Arrest, Vandalism, Poss. Of a Handgun while Under the Influence, and Driving on Roadways Laned for Traffic.

Deputy C. Lane LCSO, was dispatched to the area of Stallcup Rd in reference to a wreck no-injury. Caller advised dispatch that they heard a vehicle strike a power pole and saw the vehicle leave the scene. On scene Deputy observed a power pole with heavy damage. After further investigation a vehicle sitting in the driveway on Stallcup Rd, had

extreme driver side damage and all airbags deployed. At the scene of the crash there was glass and several articles of clothing on the roadway, along with grev vehicle parts. Upon making contact with the grey vehicle it was found that the back windows were shattered with fresh grass and mud consistent with the evidence at the scene. Also found was a loaded handgun on the center console. Deputies made contact with a male at the residence, when asked who owns the vehicle with all the damage he stated his friend Christopher Wheat owns the truck and that he was inside the residence. 

clients of large profits to be made with quick-flip properties, take cash from the victims, and ultimately repay earlier victims with funds she swindled from newer victims. Hawk defrauded at least 24 victims and, by the time her scheme was discovered, 12 victims remained unpaid and had lost over \$500,000.

Hawk took extensive steps to hide and conceal her scheme as well, including false statements, sham real estate contracts, the use of electronic signing services, and forgery. Hawk also failed to disclose any of these matters in connection with a filed bankruptcy case. In addition to repaying earlier victims with funds she swindled, Hawk used proceeds from her offenses to fund her own lifestyle.

"Tammy Hawk's fraudulent scheme not only be-

trayed her clients' trust, but also caused them devasting financial harm," said Acting United States Attorney Francis M. Hamilton III. "The Court's sentence demonstrates that there will be serious consequences to criminals who : perpetrate this brand of Ponzi scheme. This office values the collaboration among the numerous law enforcement agencies that supported this prosecution.

"The Secret Service is proud to partner with the Bristol Police Department. overwhelming success of this investigation is a testament to our belief that building strong, trusted partnerships across the law enforcement community is a proven model for success," said Resident Agent in Charge Jason Brown, Secret Service - Knoxville Resident Office. "The Secret Service is committed to combatting

financial crime, especially in cases where fraudsters take advantage of the trust and confidence of American citizens. The Secret Service, along with our local and federal partners, remain committed to aggressively protecting the nation from criminal opportunists who choose to exploit the American public."

"This corruption ploy -which destroyed the lives of many hard-working individuals -- ended today. This plea is the result of collaboration between the Sullivan County District Attorney's Office and the U.S. Attorney's Office," said Second Judicial District Attorney Barry P. Staubus.


"The joint collaboration between these law enforcement agencies in a complex case such as this, is what ensures accountability brought to Tammy Hawk for victimizing those who trust-

ed her," said Bristol Police Chief Blaine Wade.

The sentence was announced by Acting United States Attorney for the Eastern District of Tennessee Francis M. Hamilton III.





Rex Hawkins, 38, Hwy 411 South Greenback, was charged with Evading Arrest, DUI, Sch. II Drug, Poss. Of Drug Para., Reckless Driving, Lights Required on Motor Vehicle, Driving on Roadway Laned for Traffic, and Requirements for Stop Signs Vehicle.

Deputy S. Gaumer LCSO, was sitting stationary at the intersection of National Campground Road and East Coast Tellico Parkway in Greenback when I observed a white Saturn without any running lights on the rear of

the vehicle.

The vehicle turned left from National Campground on the East Coast Tellico. Deputy observed that the vehicle had no operating running rear lights, so Deputy attempted to make a traffic stop. The vehicle drove away from Deputy at a high rate of speed and he was unable to catch up to it until Morganton Cemetery Road, where Deputy activated his overhead lights and sirens. The Saturn did not stop, but instead accelerated away from him at a high rate of speed. Deputy notified dispatch that he was in active pursuit and gave them updates as it went on. The pursuit continued across Highway 411, where the driver did not stop at the stop sign, and down Highway 72 E. They continued on that road until Tomotely Road, where the vehicle turned left. Near Big Elm. the vehicle lost control and wrecked in to the ditch line of the oncoming traffic lane. It should be noted that during the pursuit, the driver went in to oncoming traffic on multiple occasions and could not maintain its lane. Deputy exited his vehicle and found Rex-Allen Hawkins, the offender, behind the wheel. Deputy ordered Mr. Hawkins out of the vehicle

and detained him without incident. Mr. Hawkins admitted that he didn't know why he ran from Deputy. He was also sweating profusely, even though it was quite chilly outside. In Deputy training and experience, that observation is often found in people who have used methamphetamine recently. Deputy asked him how long ago he had used meth, and he stated that it was "yesterday". Before placing him in the back of his patrol vehicle, Deputy searched his person and found a clear, glass pipe with approximately .5 grams of methamphetamine inside in the left, inside pocket of his jacket. Deputy also found a vape pen with a loaded THC cartridge in his left, pants pocket.


While looking in the vehicle, Deputy noticed a THC vape cartridge laying on without incident. All oc the drivers seat as well as a in Loudon County, TN.

Mr. Hawkins was complaining about pain in his left side, so Monroe County EMS transported him to Fort Loudon Hospital to be examined. Monroe County Deputy Cameron Foister took the crash report for the vehicle, due to the accident occurring in their county. Their crash report number is 2021-018016. The vehicle was towed by Martin's Wrecker Service.

Deputy met Mr. Hawkins at the hospital where he consented to a blood draw for the purpose of a DUI. He was then medically released from the hospital and I transported him to the Loudon County Jail without incident. All occurred in Loudon County, TN.


