

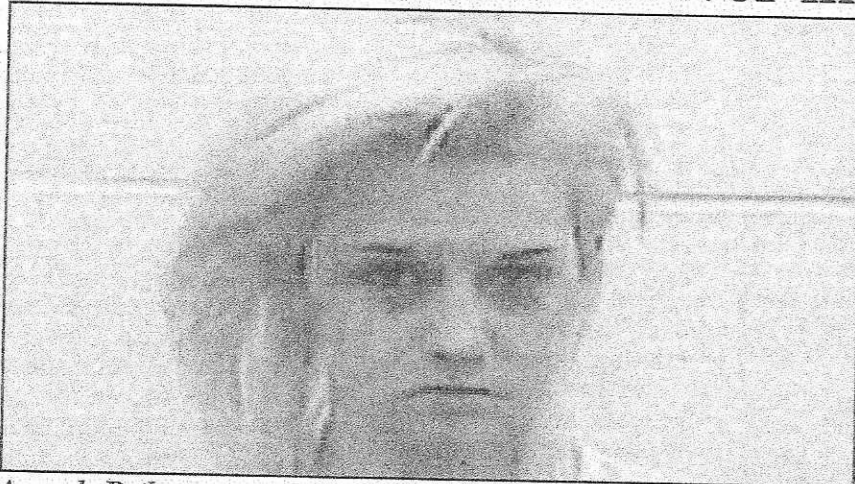

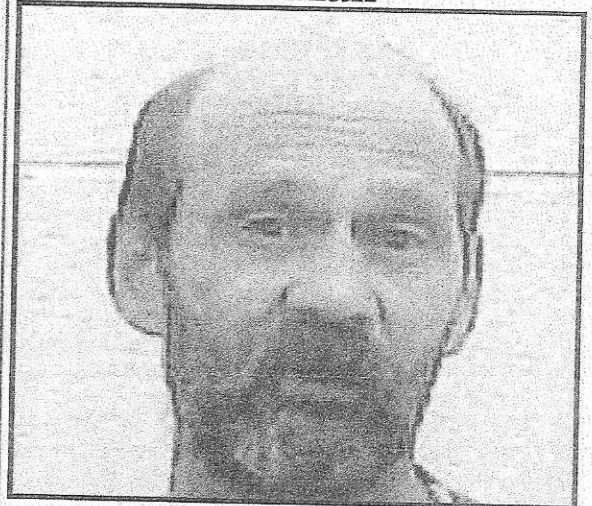

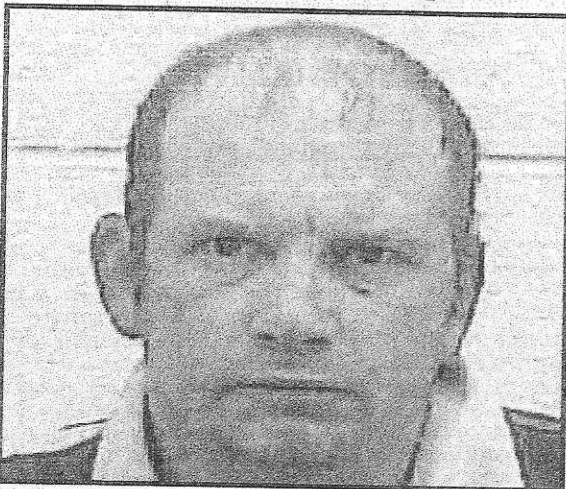

## Find Out Where the Money Goes in Your County with Online Tool Comptroller's Office Relaunches Transparency Website

The Tennessee Comptroller's Office is bringing even more transparency and accountability to local government finances with the relaunch of its Where the Money Goes website.

The online tool, also known as Transparency and Accountability for Governments (TAG), provides an easy-to-use platform

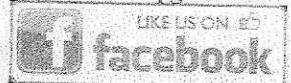
where users can track revenue, expenditure, and debt information over time for Tennessee's 95 county governments. The information is pulled from annual financial and compliance audits.

The Comptroller's division of Local Government Audit worked with the state's Strategic Technology Solu-

tions team to update the data visualization tool using Tableau.

The revamped site includes an interactive map of Tennessee and user-friendly dashboards that can be explored for more detailed information on sources of revenue, expenditures, and types

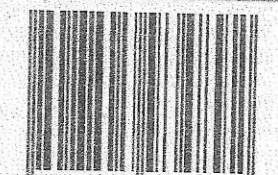

Amanda Rothman, 30, Deck Valley Road Bristol, was charged with Man/Sell/Del/Resale SchII x2 & VI, Contraband in a Penal Institution, Poss. Of Drug Para., and Mfg/Del/Sale or Poss. Of Meth.

Dep. L. Hawkins LCSO, was contacted by Sgt. Fagiana to assist him at a traffic stop. Deputy arrived on the scene and made contact with Amanda Rothman, she advised there was Marijuana in the vehicle she was riding in. During a probable cause search of the vehicle, marijuana was found in her luggage and purse, along with a blue pill and a white pill and two glass pipes used to smoke methamphetamine. She advised me that the marijuana was hers along with two pills, the blue one be-

ing Adderall and the white one being Xanax but had never seen the two pipes. She then advised she had Marijuana inside her bra, it was recovered as well. 5.51g of Marijuana was recovered. Deputy could confirm the blue pill being Adderall but not the Xanax. She was placed into custody and transported to the Loudon County Jail. Once she was brought into jail, .58g of Heroin, 1.11g of Methamphetamine, and one orange pill being Buprenorphine was found in her bra.

Mrs. Rothman confirmed the white powder substance to be Heroin but did not confirm the crystal-like substance to be meth. Amanda Rothman was charged with Contraband in a penal institution as well. This did occur in Loudon County, Tennessee.

Edward Poffenberger, 50, Turman Drive Lenoir City, was charged with Resisting Arrest, General Session Capias, Illegal Possession/ Fraudulent Use of Credit Card, Assault, Public Intoxication, Disorderly Conduct, and Aggravated Arson.

Corporal Smith LCSO, did respond to Turman Drive in Loudon County for a call of attempted arson. The victim said Edward Poffinberger had made threats to burn her house down and the police came and arrested him. The victim said when she came outside this morning she found burn marks on the back of her mobile home. Deputy also made contact with a witness, that said around the same time last night he overheard people making noise outside. He said he heard and saw a person telling Edward Poffenberger "you can't do that" and saw Edward walk down the road toward victim home with a torch in his hands. Deputy did advise INV. Chris Bowen of the call.

Deputy S. Mills LCSO, responded to a report of a possible assault taking place at Turman Drive. This was his third call for service at this residence during his tour of duty tonight. Deputy was informed that an offender, later identified as Mr. Edward Poffenberger, went over to Turman Drive with a gas can and threatened to burn victim house down. While and Deputy L. Hawkins and Mills were investigating the crime they observed a male that matched Ed's description running in the adjacent yard. Deputy had prior knowledge of

Ed's description due to him having numerous calls about him throughout the night. L. Hawkins identified himself as a law enforcement officer and instructed Ed to stop and he looked back and continued running. Deputy then identified himself as a law enforcement official and instructed Ed to stop and he failed to do so. Deputy had to jump over two fences and chased Ed into the rear neighbor's flowerbed where Deputy apprehended him. Deputy immediately noticed he had red watery eyes, spoke with a slur, walked uneasy on his feet, and had the odor of an alcoholic beverage emitting from his person. A search of his person produced a Tennessee identification card with an address of Highway 72 North. When Deputy asked Ed if he still lived here he told me that he moved about 6 months ago. After Deputy apprehended Ed, L. Hawkins investigated the alleged assault. Victim told L. Hawkins that Ed did come to her house with a gas can to her house and threatened to burn it down. Victim also told Deputy that Ed's actions put her in fear for her safety and well-being. Deputy then placed Ed in the rear of his patrol vehicle and transported him to Loudon County Detention Facility without further incident.

While in custody Ed spontaneously uttered how he wanted to fight his neighbors. He stated that "I'd f\$ck him up. I'd f\$ck both of them up." Ed also mentioned numerous times how he had to take the law into his own hands.
