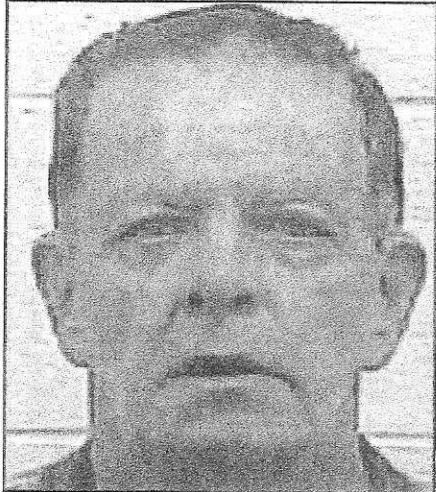

## CDC Statement on President's Fiscal Year 2022 Budget

The Biden Administration released the President's FY 2022 budget. The Centers for Disease Control and Prevention (CDC) budget request for FY 2022 is the largest budget authority increase for CDC in nearly two decades, which will enable the Agency to invest in the core infrastructure

of our country's public health system.

"This budget request begins to address the critical needs to improve the public health system for America," said CDC Director Rochelle P. Walensky, MD, MPH. "The nation, and the world, faced incredible challenges responding to the COVID-19 pan-

demic. Investing in long-term, sustainable programs and systems to address deficits in the public health system – equitably for all Americans – will put the nation on better footing to confront future threats."

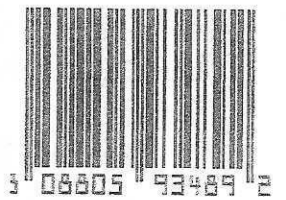

**Update**

Terry Highfield, 65, Hilltop Drive Rossville, was charged with Evading Arrest, DUI, Driving on Revoked/Suspended License, Misuse of Evidence, Theft of Property x2, Poss. Of Burglary Tools, and Violation of Implied Consent.

Vanessa Starcher, 42, Old Chattanooga Pike Cleveland, was charged with Possession of Meth, Burglary Tools, and 2 active warrants out of Bradley Co.

Cpl Frye LCSO, advised Deputy Rogers, responded to a call that an attempted Break-in at the Weigel's at Hwy 321/ Hwy 70 had occurred. Shortly after, Loudon E911 advised a witness called in stating the offender's vehicle was a black SUV displaying TN registration E4053J and it was travel-

ing South on I75. Deputy then observed a black Kia Soul displaying that registration in the area of the 68mm SB. Loudon E911 confirmed the TN tag to be stolen out of Cleveland, TN (NIC#P247514236). Deputy initiated a traffic stop with my emergency lights and siren when the vehicle exited the 62 exit. The vehicle failed to stop leading a pursuit through Sweetwater City and re-entering Loudon County on Steekee Rd. Loudon PD Officer Nix was able to deploy spike strips in the area of Roberts Rd and effectively disable the vehicle which came to a stop in the area of Carter Street. Terry Highfield the driver, and Vanessa Starcher the passenger, were taken into custody without incident. Ms. Starcher stated she did have meth (2 grams) in her vagina that

was seized once at the jail. Ms. Starcher was also confirmed to have 2 felony warrants out of Bradley Co., TN. Mr. Highfield consented to SFST, failed, and was then read TN Implied Consent to which he stated "I'm admitting I'm high on Meth I don't want to be poked with a needle". The vehicle with VIN#KND-JT2A59C7745181 also came back stolen out of Walker Co., Georgia (NIC# V792932622). Two crowbars, black masks, gloves, and a used meth pipe

were found in the vehicle. Mr. Highfield was charged with Theft of a Motor Vehicle, Theft of Registration Plate, Evading, DUI, Misuse of Registration, Possession of Burglary Tools, and Driving on a Revoked License and Violation of Implied Consent. Ms. Starcher was arrested for Possession of Meth, Burglary Tools, and 2 active warrants. Both were transported to the Loudon County Jail. Said occurred in Loudon County, TN.

**CDC**

Substances and Disease Registry (ATSDR) includes a total funding level of \$9.6 billion in discretionary budget authority, Public Health Service (PHS) Evaluation funds, and the Prevention and Public Health Fund (PPHF). This is an increase of \$1.7 billion above the FY 2021 Enacted. These amounts include \$81.75 million for ATSDR—an increase of \$3.75 million over FY 2021 Enacted. When accounting for all resources, including mandatory programs, the budget includes a total program levels of \$15.4 billion for CDC.

Specifically, the budget request includes funding for:

Improving readiness for future public health crises

CDC will continue to build on initial investments and lessons learned from COVID-19 by investing in public health infrastructure, including public health data

modernization, public health workforce, buildings and facilities, and global health protection.

Funding is also requested for several other activities including modernization of quarantine, migration, and vessel sanitation programs, and enhancements of surveillance systems that monitor emerging threats to mothers and babies.

Reducing racial disparities in public health

CDC's budget request includes increases to key programs, including maternal mortality, HIV, and childhood lead poisoning prevention, that work to improve health equity and reduce health disparities in racial and ethnic minority communities and other disproportionately affected communities around the country.

CDC also will significantly expand efforts to address the social determinants of

health, conditions in the places where people live, learn, work, and play that affect their health.

Building public health approaches to reduce violence

CDC's budget request includes increases in injury and violence prevention

programs that will help to address the growing crisis of domestic, sexual, and gun violence.

The request includes a new evidence-based community violence intervention initiative.
