

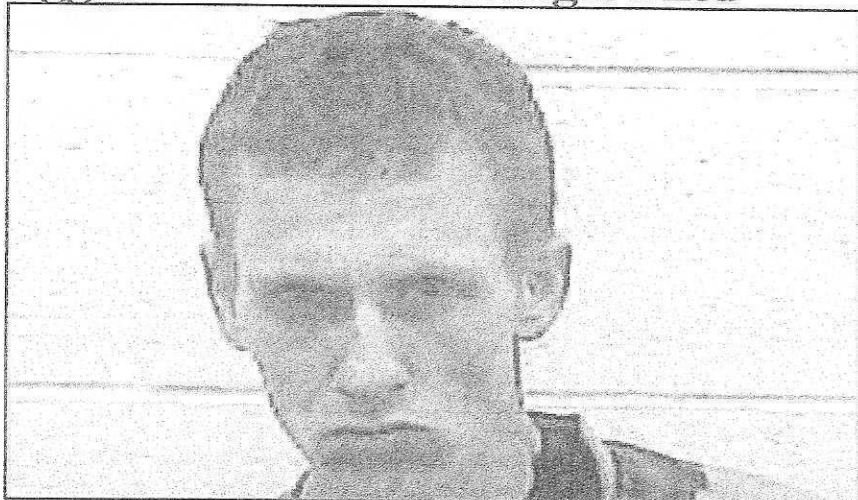

Former Marion County UT Extension Office Assistant Indicted for Theft

Courtney Conley Stole More than \$39,000

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Courtney Conley, a former administrative support assistant in Monroe County's UT Extension Office. The office serves citizens with educa-

tional programs, and it receives cash and checks as payment for its services.

Investigators determined that Conley stole at least \$39,109 between November 2018 and March 2020. Conley admitted to investigators that she was experiencing finan-

cial difficulties when she stole Extension Office funds to pay her personal expenses.

Conley employed two schemes to misappropriate the money. She issued and cashed 18 checks payable to herself

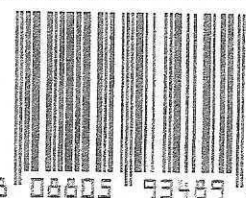

Paul Dailey, 39, Hines Valley Road Lenoir City, was charged with Aggravated Assault x2, DUI, and Aggravated Child Abuse/Neglect.

Deputy Rogers LCSO, was made aware of a silver Toyota Corolla with Texas registration driven by Paul Dailey, who was the offender in a Aggravated Domestic at Hines Valley Rd.

Deputy located said vehicle at the Bimbos Gas Station on Hwy 321 at I75 and made contact with Mr. Dailey, who was inside the store. Mr. Dailey possessed the key to the vehicle and stated he had driven from his residence to the gas station to get away from the scene.

Mr. Dailey had extremely rigid, exaggerated reflexes, his pupils did not react with light and admitted to using meth and prescription narcotics early in the evening. Mr. Dailey did consent to SFST

and ARIDE testing and showed clues of being highly impaired.

Along with failing all 3 Field Sobriety test, Mr. Dailey had the presence of VGN and estimated 30 seconds to be 14 seconds during Modified Rhomberg test. Deputy also spoke to the attendant inside the convenience store who stated he observed the vehicle arrive at the gas pump, the offender exit the driver seat and walk in the store.

Deputy took Mr. Dailey into custody for Driving Under the Influence and read him Tennessee Implied Consent to which he did consent to a blood draw. The offender was transported to the Fort Loudoun ER, where the blood draw was conducted and then to the Loudon County Jail. Deputy C Gray issued warrants in connection to the domestic incident. Said did occur in Loudon County, TN.

Theft

totaling at least \$15,411, and she also kept at least \$23,698 in cash that she should have deposited in the Extension Office account.

In order to conceal her theft, Conley falsified signatures on checks, altered bank statements, and made false entries in the office's accounting system. The investigation began after UT Extension Office officials reported questionable transactions in its accounting and bank records.

The Extension Office terminated Conley's employment on March 31, 2020.

In June 2021, Courtney Conley was indicted by the Marion County Grand Jury on one count of theft over \$10,000, one count of

official misconduct, one count of tampering with evidence, and 18 counts of forgery.

"There were several weaknesses within this office that allowed these schemes to go undetected for more than a year before the bank notified the Extension Office that its account was overdrawn," said Comptroller Jason Mumpower.

"Most importantly, one person was given too much authority over the financial processes within the office, and not enough oversight was provided to ensure money was being used properly."

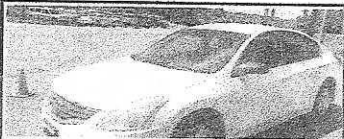

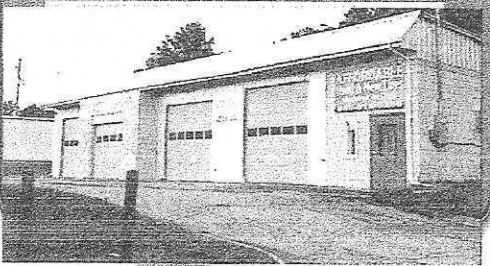

Bartlett High School Choir Teacher Indicted for Theft

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Paul Whited, the choral teacher at Bartlett High School in Bartlett, Tennessee. The investigation began after school officials reported discrepancies related to choir funds.

Whited was responsible for collecting choral fees and money associated with choir travel and remitting the funds to the school finance office.

Investigators determined that Whited collected at least \$25,845.53 from students between August 2018 and September 2019. Whited failed to remit or otherwise account for at least \$6,952 of those collections.

For example, investigators reviewed a receipt from February 2019 showing that Whited collected \$600 in cash from a student for choir trip fees. Whited did not remit this collection to the school finance office.

Investigators reviewed 139 receipts provided by school officials and found discrepancies with 46 of them. The majority (41 of 46) of receipts associated with unaccounted funds represented cash collections that Whited received but failed to remit to the school finance office. An analysis of the Record of Daily Cash Receipts showed that most remittances Whited submitted to the school finance office were checks and rarely cash.

Whited told investigators that he did not take any money, and he did not know what happened to the missing funds. Whited also said that he had a student or a teacher's assistant help with collections, and due to different people coming in and out of the choir room, anyone could have taken the money.

In May 2021, the Shelby County Grand Jury indicted Paul Whited on one count of theft over \$2,500.

"School officials should take appropriate steps to account for money collected from students," said Comptroller Jason Mum-power. "A few of these steps include reconciling individual receipts with collections logs, using official pre-numbered receipts, ensuring that funds are deposited within three days of collection, and maintaining adequate documentation."
