## Former Finance Director of Northeast TN Nonprofit Indicted

Julie Beale worked for Appalachian Regional Coalition on Homelessness (ARCH)

The former finance director for a non-profit that provides support to homeless citizens in Northeast Tennessee is now facing a multi-count indictment after Comptroller investigators, working in conjunction with the U.S. Department of Housing and Urban Development Office of Inspector General,

found she stole at least \$119,582.

Julie Beale was the finance director for the Appalachian Regional Coalition on Homelessness (ARCH) located in Johnson City. Beale misappropriated the nonprofit's funds between November 2013 and March 2018 in the following ways:

Julie Beale and her husband, Sam Beale, misappropriated

\$75,630.06 by making 150 ARCH payments to Sam Beale for work he did not perform. Sam Beale worked as ARCH's intermittent maintenance provider during the duration of his wife's tenure at ARCH. Sometimes Julie Beale paid him at his request and at oth-

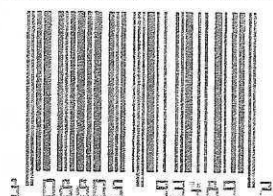

Jesse Ivey, 24, Brooks Landing Way Pigeon Forge, was charged with Reckless Driving, Evading Arrest x2, Driving Unregistered Vehicle, Traffic Control Signals, and Speeding

Deputy Rodriguez LCSO, advised Loudon County Dispatch to run a license plate of TN 0X6-4J4 through NCIC to which it came back not on file. The license plate was displayed on a blue Cadillac CTS and conducted a traffic stop on it using his emergency equipment on Highway 321 at Creekwood Park Blvd. The vehicle stopped then exhilarated which started a vehicle pursuit. The vehicle pursuit ended at Dunnview Lane in Knoxville TN. Jesse Ivey, arrestee and driver, took off running on foot and after a short foot pursuit, Mr. Ivey was placed in custody without further incident. Alyssa Wallen, arrestee and passenger, was asked if she had any narcotics on her person to which she pulled a small baggie with a white powdery substance out of her bra. She advised me that

the substance is heroin. Mrs. Wallen was also placed in custody. A TruNarc test was administered at the Loudon County Justice Center on the substance and the result came back as .09 g of fentanyl (Scan #887). This occurred in Loudon County.

## LENOIR CITY POLICE DEPARTMENT INCREASES IMPAIRED-DRIVING ENFORCEMENT

Lenoir City Police Department is partnering with the Tennessee Highway Safety Office (THSO) to increase impaired-driving enforcement nationwide.

The Lenoir City Police Department will be conducting a sobriety checkpoint on U.S. Hwy. 11/S.R. 2-Broadway in Lenoir City from 8 p.m. to 10 p.m. on Friday, July 23, 2021.

"Sobriety checkpoints are a valuable tool to combat impaired driving. It increases public awareness of impaired driving and allows officers to detect and apprehend impaired drivers that may otherwise not be detected," says Chief Don White.

Increased state and national messaging about the dangers of drunk driving, coupled with increased sobriety checkpoints and high visibility enforcement, aim to drastically reduce the number of drunk-driving crashes, injuries, and fatalities this

year.

The consequences of a single DUI conviction for a first-time offender in the state of Tennessee may include costly fines, court costs, legal fees, jail time, mandatory drug and alcohol treatment, and/or the installation of an ignition interlock device in his/her vehicle.

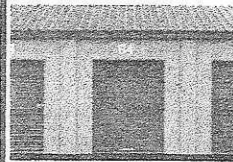

**DUI**

Crystal Carter, 38, Possum Trot Road Sweetwater, was charged with DUI, and Driving on Revoked/Suspended License.

Dep. A. Parton LCSO, responded to a possible impaired driver in the area of Pond Creek Road and Highway 11. As Deputy approached the area he was advised by Loudon County Dispatch that the vehicle was a red sedan and it had stopped in the middle of Pond Creek Road. Upon arrival, Deputy observed the vehicle sitting in the lane of travel and activated his emergency equipment. Deputy identified the driver as Crystal Carter and asked her what she was doing and she stated that she stopped to text her husband. While speaking with her she seemed lethargic, disoriented, and her pupils were constricted. Deputy checked her

information through Loudon County Dispatch and was advised that she was revoked for failure to appear on 11-6-2015. Deputy asked Ms. Carter to exit the vehicle and preform field sobriety and she stated that she was going to move her vehicle and started to drive toward the shoulder. Deputy told Ms. Carter to stop her vehicle and then exit the car to which she did. Upon exiting the vehicle she stumbled and regained her balance. Deputy asked Ms. Carter if she would preform field sobriety and she stated that she would. During the horizontal gauze nystagmus test, Deputy observed clues of lack of smooth pursuit in both eyes, distinct and sustained nystagmus in both eyes and lack of smooth pursuit in the right eye. Ms. Carter was unable to preform the other two test due to her stating that she was injured. Deputy then had her pre-

formed the ARIDE tests to which she preformed poorly on. Ms. Carter was then read the implied consent form and she agreed to provide a sample of blood for testing. She then requested for an ambulance to be called to the scene for her heart problems. Priority Ambulance arrived on scene and transported Ms. Carter to Fort Loudon Medical Center. As EMS was pulling into the ER, Ms. Carter attempted to jump out of the ambulance. Deputy

then placed Ms. Carter back in hand cuffs and transported her the rest of the way to the ER. Once on scene Ms. Carter provided a sample of blood and was seen by the hospital for heart related issues. After being cleared, she was transported to Loudon County Justice Center with no further incident. Seeing the above facts, Crystal Carter is being charged with DUI and driving on revoked. This did occur in Loudon County, Tennessee.

er times, she issued checks to him on her own initiative.

Julie Beale issued fraudulent ARCH payments to herself totaling \$32,937.43.

Julie Beale made fraudulent ARCH payments to another family member totaling \$5,081.69.

Julie Beale used ARCH money to pay rent on her personal residence totaling \$3,375.

Julie Beale used the ARCH debit card to make a total of \$2,183.47 in unauthorized and personal charges.

Julie Beale issued a fraudulent ARCH check to pay a personal \$375 debt.

Investigators identified numerous instances when Beale concealed her scheme by applying false signatures on checks, making false entries into ARCH's accounting records, and creating false invoices.

Julie Beale resigned her

position with ARCH on March 2, 2018. In July 2021, the Washington County Grand Jury indicted Julie Beale on one count of theft over \$60,000, one count of conspiracy to commit theft over \$60,000, and money laundering. Sam Beale was indicted on one count of theft over \$60,000, one count of conspiracy to commit theft over \$60,000, one count of financial exploitation of an elderly or vulnerable person, and one count of theft over \$2,500.

"This case underscores the importance of not giving sole control of financial operations to one person," said Comptroller Jason Mum-power. "Separating key financial duties and providing increased oversight helps to reduce the risk that fraud will go undetected."
