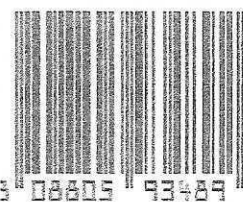

Deputy **Craig Brewer** LCSO, responded to Highway 444 in Loudon Tennessee to a report of a stolen vehicle being followed by Lt. Ezell. On catching up to the vehicle Deputy tried to initiate a traffic stop by activating his emergency equipment and the started to pull over.

The driver then excited the vehicle and took off at a high rate of speed, speeds of approximately 90 miles per hour reached on Highway 444. We continued down Highway 444 through traffic with the Chevrolet truck, Tennessee registration number 5R81N5, continued to flee from Officers.

The vehicle passed through traffic at Highway 444 and

mined that Spry stole \$3,306.78 from the fire department between November 2016 and July 2018.

Most of the stolen money (\$3,201) came from fundraiser collections. Spry failed to deposit some of the cash that was received during a door-to-door fundraising effort in 2017 and 2018. Instead, he kept the cash for his personal benefit.

Spry also used the department's debit card to purchase a \$105.78 fuel pump for a 2004 Ford Ranger. County records indicate that Spry owned a 2004 Ford Ranger at the time of the fuel pump purchase.

Spry admitted to investigators that he withheld cash from fundraiser collections and used the department's debit card to purchase a fuel pump for his personal vehicle. He resigned as treasurer effective July 5, 2018.

In May 2021, the Coffee County Grand Jury indicted

Kenneth David Spry on one count of theft over \$2,500.

Investigators have also questioned \$2,524.07 of fire department disbursements that included ATM withdrawals and debit card charges at retailers such as Home Depot and local restaurants. Investigators could not determine who was responsible for the disbursements or whether the department received any benefit.

Additionally, investigators found the fire department chief charged \$105.81 to the department's O'Reilly Auto Parts account. The chief told investigators that he made two purchases from the store to repair a personal vehicle that was used for "department errands."

"Our investigators identified several shortcomings in the way the fire department handled its finances," said Comptroller Jason Mumpower. "We have recommended the department improve its controls by

taking steps such as requiring two signatures on checks, requiring and retaining documentation for disbursements, and carefully reviewing bank statements."

Aaron Fitzgibbons, 28, Park Edgeway Road Knoxville, was charged with Aggravated Burglary, Domestic Assault, DUI, and Resisting Arrest.

Deputy Harrison LCSO, was dispatched to Wilson Road in reference to a break in-in progress. Sgt. Fagiana and Deputy Gray arrived on scene just before Deputy Harrison and had the offender, Aaron Fitzgibbon, detained in the front yard of the residence once Deputy arrived.

While speaking with the offender, he had a strong odor of an alcoholic beverage emitting from his person. Deputies spoke with the complainant/victim who stated that earlier in the night she and the offender with who she had a sexual relationship with at sometime were at a bar in Knox County and had been in an argument. The offender smashed the victim's phone and the bar staff escorted victim out to her vehicle to protect her from Fitzgibbon. While the victim and her ex-boyfriend, were on their way to the victim's house on Wilson Road,

Fitzgibbon followed them to the residence and was actively attempting to get inside the residence and walking around the property at the time they called 911.

While Fitzgibbon was pulling into the driveway, he ran over a raised garden causing damage to the vehicle and the victim's property. The keys to the vehicle were found in the offenders pocket.

Once Deputy placed Fitzgibbon in the back of his car, he became extremely belligerent and on two separate occasions the back door was opened to speak with him and he would attempt to exit the vehicle. He stated he was having difficulty breathing and EMS was notified to transport him to the hospital. Once EMS arrived on scene he began to argue and cuss at Paramedics and Deputies, and had to be restrained on a stretcher to protect himself and Deputies due to him being violent.

After being transported to Fort Loudon Medical Center, Fitzgibbon became so violent that he flipped the bed medical staff had restrained him to.

This did occur in Loudon County, Tennessee.

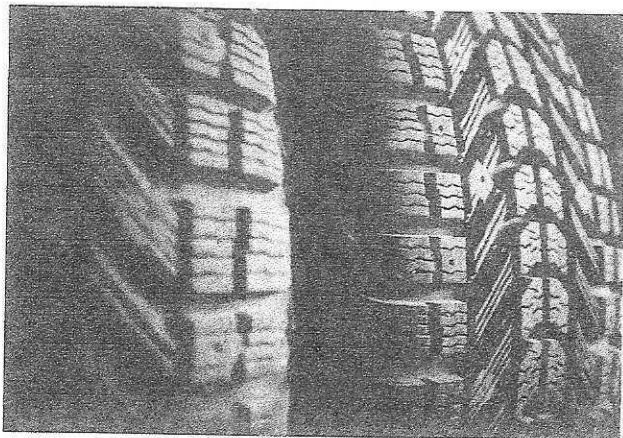

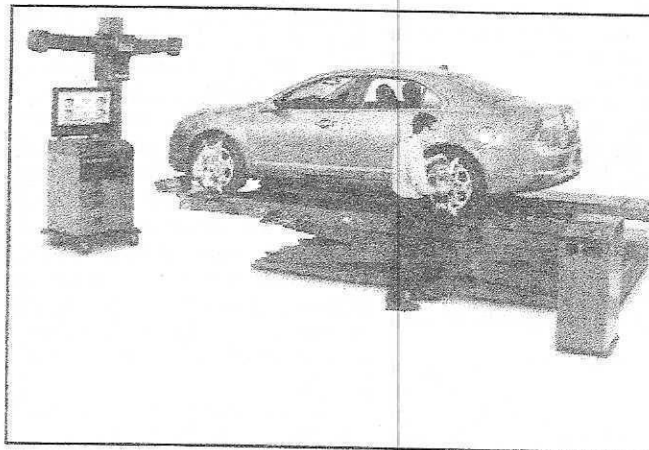

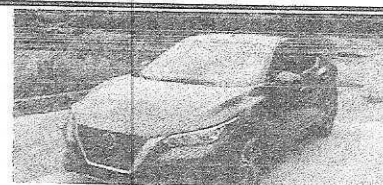
