Former Claiborne County Chief Deputy Clerk Stole More Than \$25,500

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Patricia "Diane" Heck, the former chief deputy clerk in Claiborne County. The investigation began after the county clerk reported questionable conduct involving the former chief deputy.

Heck stole at least

\$25,519.74 from the clerk's office between April 1, 2016 and April 19, 2019, when she resigned.

Investigators determined that Heck overcharged certain vehicle dealerships for the fees they remitted to the clerk on behalf of their customers. Heck assumed responsibility for calculating the fees for many such sales. She provided

falsely inflated fee amounts to dealerships and kept the excess amounts for her personal benefit.

In all, investigators identified 646 vehicle registration transactions submitted to the clerk's office for more than the actual amounts due the clerk.

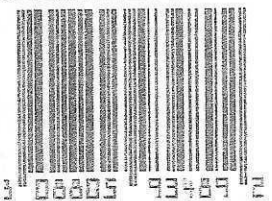

Debra Nykamp, 65, Blackberry Ridge Lenoir City, was charged with Evading Arrest, and DUI.

Deputy Harrison LCSO, along with Sgt. Fagiana attempted to traffic stop a grey Honda Accord at City Park Drive and Casa De Lago. The vehicle continued on Easter Ridge and took a right on Lakeview Road failing to stop. Deputies pursued the vehicle until it pulled in to the driveway at Blackberry Ridge. Deputy along with Deputy Bengel and Sgt. Fagiana exited their vehicles to make contact with the driver who continued to evade after being given many commands to stop. Once the vehicle came to a stop, the offender later identified as Debra Nykamp, refused to unlock the drivers door. Deputy Bengel was able to

climb through the sunroof and unlock the drivers door. While placing Nykamp in custody, she had a strong odor of an alcoholic beverage emitting from her person. 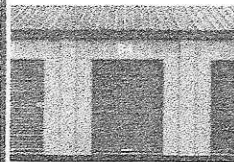

Officers with the City of Loudon were dispatched to Grove Street in reference to a Camren Beasley sitting outside in a silver car in front of the complaint's residence. Upon arrival Officer Law LPD, observed a male who Officer later identified as Camren Beasley sitting in a Silver Hyundai Elantra (GA Tag BNT-2176) directly in front of the residence in a parking spot. After running Mr. Beasley through Central Dispatch it was confirmed Mr. Beasley did have a no contact order of protection against him. Officer Law did witness on the victim's a phone call she had received earlier in the evening from Mr. Beasley. Mr. Beasley was placed under arrest and transported to the Loudon County Jail without incident. All the above occurred in Loudon City, TN.

CDC and Texas Confirm Monkeypox In U.S. Traveler

The Centers for Disease Control and Prevention (CDC) and the Texas Department of State Health Services confirmed on July 15 a case of human monkeypox in a U.S. resident who recently traveled from Nigeria to the United States. The person is

currently hospitalized in Dallas. CDC is working with the airline and state and local health officials to contact airline passengers and others who may have been in contact with the patient during two flights: Lagos, Nigeria, to Atlanta on July 8, with arrival on July 9; and Atlanta to Dallas on July 9.

Travelers on these flights were required to wear masks as well as in the U.S. airports due to the ongoing COVID-19 pandemic. Therefore, it's believed the risk of spread of monkeypox via respiratory droplets to others on the planes and in the airports is low. Working with airline and state and local health partners, CDC is assessing potential risks to those who may have had close contact with the traveler on the plane and specific settings.

Monkeypox is a rare but potentially serious viral illness that typically begins with flu-like illness and swelling of the lymph nodes and progresses to a widespread rash on the face and body. Most infections last 2-4 weeks. Monkeypox is in the same family of viruses as smallpox but causes a milder infection. In this case, laboratory testing at CDC showed the patient is infected with a strain of monkeypox most commonly seen in parts of West Africa, including Nigeria. Infections with this strain of monkeypox are fatal

in about 1 in 100 people. However, rates can be higher in people who have weakened immune systems.

Prior to the current case, there have been at least six reported monkeypox cases in travelers returning from Nigeria (including cases in the United Kingdom, Israel, and Singapore). This case is not related to any of these previous cases. In the United Kingdom, several additional monkeypox cases occurred in people who had contact with cases.

Background on monkeypox in Africa

Experts have yet to identify where monkeypox hides in nature, but it's thought that African rodents and small mammals play a part in spreading the virus to people and

other forest animals like monkeys. People can get monkeypox when they are bitten or scratched by an animal, prepare wild game, or have contact with an infected animal or possibly animal products. Monkeypox can also spread between people through respiratory droplets, or through contact with body fluids, monkeypox sores, or items that have been contaminated with fluids or sores (clothing, bedding, etc.) Human-to-human transmission is thought to occur primarily through large respiratory droplets. Respiratory droplets generally cannot travel more than a few feet, so prolonged face-to-face contact is required.

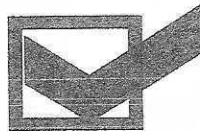

Theft

Heck also altered electronic or manual records in an effort to hide her misappropriation. In some instances, she used a white substance to conceal information on registration documents.

In July 2021, Patricia Diane Heck was indicted by the Claiborne County Grand Jury on one count of theft over \$10,000, one count of tampering with government records, and one count of official misconduct.

"I am pleased the Claiborne County clerk reported this information to our Office," said Comptroller Jason Mumpower. "I'm also encouraging the clerk to use this opportunity to improve operations within her office by ensuring cash drawers are reconciled with receipts each day and reviewing any unusual or questionable transactions."

Most monkeypox outbreaks have occurred in Africa. In addition to Nigeria, outbreaks have also been reported in nine other countries in central and western Africa since 1970. Monkeypox also caused a large outbreak in people in the United States in 2003 after the virus spread from imported African rodents to pet prairie dogs.

CDC poxvirus experts have been supporting the investigation and response to Nigeria's monkeypox flare-ups since 2017 when the disease re-emerged in Nigeria after a nearly 40-year stint with no reported cases. During 2017, CDC sent investigators to assist the Nigerian CDC and the National Veterinary Research Institute with tracing contacts of ill patients, providing diagnostic tests, training lab staff in country to safely test samples from suspect

monkeypox cases, providing diagnostic tests and capturing small mammals to test for monkeypox (which would help identify which animals carry the disease in nature).

Scientists at CDC labs in Atlanta have also provided laboratory testing, including specialized tests to identify people who may have had monkeypox and recovered, sequencing to trace outbreaks and phylogenetics to determine if clusters of cases were related. CDC continues to train Nigerian partners in how to

collect wildlife to test for which animals carry the virus in nature, helping to improve the country's ability to track monkeypox cases in people and interview community members about their interactions with local wildlife. CDC is also running trials in Democratic Republic of Congo to assess whether the smallpox vaccine Jynneos may help protect healthcare workers from contracting undiagnosed monkeypox infections from their patients.
