





Robert Walker, 47, Russell Hollow Road Maryville, was charged with Aggravated Assault x2, and Possession of a Firearm.

Deputy S. Mills LCSO, responded to a report of a possible shooting at Niles Ferry Road. Upon arrival, the alleged offender, who was identified as Mr. Robert Walker, had already fled the scene. Deputy then spoke with the victims. They informed Deputy that at around 3:00 PM today Robert came over and was heavily intoxicated. He was mean to a dog. Victims informed Deputy that he bit the dog and stated "I'm the alpha dog." He then was forced out of the residence by victim 1.

Victim 1then informed Deputy that he had come back approximately an hour later and was asking if he left his dog there. Victim 1 told Robert that he took his dog with him. Victim 1 said he was acting very intoxicated and even admitted that he was drinking. Both victims informed Deputy that Robert behavior had been abnormal all day.

Robert showed up one more additional time and this time victims heard him cussing outside the residence within his vehicle. Victim 2 informed Deputy that the altercation became physical and Robert produced a dark-colored semi-automatic

handgun. Victim 2 said that Robert did point the handgun directly at him and he looked down the barrel of the firearm. He said that Robert stated "fuck you" and fired the firearm. He said that he was on the passenger side of the vehicle when Robert fired the handgun directly at him. Victim 2 also stated that he was scared for his life and "scared to death." Victim 1 also stated that he was scared for his life. Victim 2 said that he was scared for victim 1life as well. After Robert fired the firearm he left the residence and drove away.

A check through the TN Criminal Justice Portal provided a possible address of Russell Hollow Road in Blount County. Deputy then arrived at that residence and took Mr. Walker into custody without incident. He had bloodshot, red, and watery eyes as well as having the odor of an alcoholic beverage emitting from his person. He informed Deputy that he had wrecked his car on the way back to his house because he took a curve too fast. He informed Deputy that he left his vehicle there and the best location he could give was that it was a couple of roads over. While arresting Mr. Walker Deputy did observe a box of .22 ammo laying in plain view within a shed at his residence. All of the above occurred in Loudon County, Tennessee.

Craigs Chapel Road Green- Jail. back, was charged with Man Sell/Poss. Of Controlled Substance x4, Mfg/Del/Sale or Poss. Of Meth, and Poss. Of Drug Para.

Investigators and deputies with the Loudon County Sheriff's Office conducted a traffic stop on Steven Ray Birchfield's vehicle for prior knowledge of Birchfield having an active warrant for his arrest. Deputies located Birchfield as the passenger in the vehicle and a female driver. Birchfield was taken into custody and searched incident to arrest. In Birchfield's wallet was a baggy containing gray powder which later tested positive as Heroin and Fentanyl Compound (Schedule I). Deputies located \$660 in US currency was located inside the wallet which was comingled with record-

ed controlled buy funds and seized. Birchfield was trans-Steven Burchfield, 51, ported to the Loudon County Investigators obtained written consent to search female and Birchfield's residence from the female. Approximately 0.44 grams of methamphetamine, 8 separate bags of marijuana and a marijuana cigarette totaling 14.49 grams, five 1 mg Clonazepam pills, three 1 mg Alprazolam pills, two 2 mg Clonazepam pills totaling 9 Schedule IV pills, a magnetic box with meth residue, four glass meth pipes, two digital scales with meth residue, 8 long guns and several boxes of ammunition were found during the search of the residence. Birchfield is charged with Man/Sale/Del or Poss of Schedule I Heroin, Man/Sale/Del or Poss of Schedule VI Marijuana, Man' Sale Del or Poss of Schedule IV, Possession of Methamphetamine and Possession of Drug Paraphernalia.
