Comptroller's Research and Education Accountability Team Wins Prestigious National Awards

Tennessee Comptroller Jason Mumpower is pleased to announce that his Office of Research and Education Accountability (OREA) has been honored as one of the nation's leading research and program evaluation teams.

OREA is one of two offices in the United States that has received the Ex-

cellence in Research Methods Award from the National Legislative Program Evaluation Society (NLPES). The award recognizes OREA's evaluation of the Tennessee Promise program by Lauren Spires and Kristina Podesta.

This is the first time that OREA has been recognized with this prestigious honor.

NLPES has also awarded the Office of Research and Education Accountability with a 2021 Certificate of Impact for its evaluation of Corporal Punishment in Tennessee. This work was also done by Lauren Spires and was honored for its "significant impact

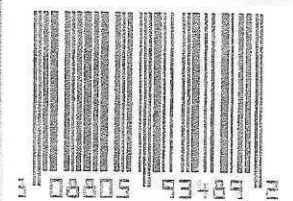

Deputy Harrison LCSO, was traveling on Highway 411 passing the Greenback Corner Market when he observed a white Ford pickup veer off onto the shoulder and continue driving half on the lane of travel and the shoulder. As Deputy got closer to the vehicle he could not see a registration plate displayed. Deputy conducted a traffic stop on the vehicle on Highway 411 at Thompson Bridge. Upon making contact with the driver,

Maston West, he became very nervous. Deputy had West exit and move to the front of his vehicle. While speaking with him, Deputy asked for consent to search the vehicle to which he declined consent. After this he asked, "can I call my girlfriend before I go to jail?" Deputy asked why he believed he was going to jail and he stated that he assumed he had a warrant out of an unknown county. At this time Deputy asked West for consent to search his person to which he did consent, and while doing so, Deputy recovered a small baggie in his front left pocket containing approximately one gram of methamphetamine. Loudon County Dispatch advised Deputy that West's license was suspended as of
