**5th DUI**

Steven Spahr, 45, Central Avenue Knoxville, was charged with DUI, Driving without a License, and Driving on Roadway Laned for Traffic.

Deputy Harrison LCSO, was dispatched to the area of I-75 south bound in reference to a possible impaired driver. The complainant stated a grey Jeep Liberty was failing to maintain its lane and driving in the middle of the interstate. The complainant observed the vehicle exit I-75 south bound at the 81 and made a right towards Highway 70. Deputy was traveling on Highway 321 just past Highway 70 when Deputy made contact with the vehicle as it almost struck the side of his patrol car as it was switching from the right to the left lane. Deputy got behind the vehicle and initiated a traffic stop on Highway 321 at Williams Ferry. While the vehicle was turning onto Williams Ferry, it almost struck another vehicle head-on that was stopped at the stop sign. Once the vehicle was stopped, Deputy made contact with the driver Steven Spahr who exhibited slowed speech and had the strong odor of an alcoholic beverage emitting from his person. Deputy had Spahr exit

the vehicle and while doing so he had trouble maintaining his balance. Spahr did consent to SFSTs and Deputy was able to conduct HGN and the instruction phase of the walk and turn before Spahr refused to continue testing. After a check of Spahr's Tennessee ID, Loudon County Dispatch advised his license was canceled and that he had an active failure to appear warrant out of Roane County. Deputy placed Spahr in custody and read him Tennessee Implied Consent to which he consented to a blood draw. Deputy transported Spahr to the Fort Loudon Medical Center where the blood draw would take place. While on scene, the ER staff were unable to collect a blood sample due to being unable to find an adequate vein. Deputy then transported Spahr to the Loudon County Jail where he consented to a breath test and gave two sufficient samples with a final result of .245g/210L. This did occur in Loudon County, Tennessee.

**Fraud**

were suffering and trying their best to make it through the pandemic, others chose greed," Assistant Special Agent in Charge of IRS-Criminal Investigation Brian Thomas said. "IRS-CI will continue to use its financial expertise to track and recommend prosecution of criminals taking advantage of a crisis."

The CARES Act is a federal law enacted in March 2020 to provide emergency financial assistance to the millions of Americans who are suffering the economic effects caused by the COVID-19 pandemic. Two primary sources of relief provided by the CARES Act were the Paycheck Protection Program ("PPP") and the Economic Injury Disaster Loan ("EIDL") program. PPP loans consisted of more than \$640 billion in forgivable loans to small businesses for payroll, mortgage interest, rent, and utilities. The EIDL program provided low-interest loans to business owners to pay for items like accounts payable and other bills that could not be paid as a result of COVID-19.

As stated in defendant's filed plea agreement, from April 2020 to June 2020, Howell fraudulently applied for four loans totaling \$154,700 through the PPP and EIDL programs. Howell submitted fraudulent applications under the names of two businesses that did not qualify for the COVID-19 relief funds that Howell sought. Howell submitted two fraudulent applications to financial institutions seeking PPP funds and two fraudulent applications to the Small Business Administration seeking EIDL funds. As part of his fraud scheme, Howell submitted false supporting records, including Internal Revenue Service documents, and made false statements about the number of individuals the companies employed, the revenue generated, and the wages paid. Howell also made false statements about the business entities and the intended use of the loan proceeds.

For example, according to the plea agreement, on April 1, 2020, Howell submitted an online application to the Small Business Administration in

the name of Advanced Strategy Holdings, LLC, seeking \$83,800 in EIDL funds. On the application and in the supporting documents, Howell submitted to the SBA in support of the loan, Howell claimed that Advanced Strategy Holdings employed four individuals, generated \$700,000 in gross revenue, incurred \$0 in cost of goods sold, and paid wages of \$440,000 in the twelve months preceding the COVID-19 pandemic. These claims were all false.

This case is the result of an investigation conducted by the FBI and the Internal Revenue Service - Criminal Investigation.

Assistant United States Attorney William A. Roach, Jr., who also serves as the Office's Coronavirus Fraud Coordinator, prosecuted the case.

On May 17, 2021, the Attorney General established the COVID-19 Fraud Enforcement Task Force to marshal the resources of the Department of Justice in partnership with agencies across government to enhance efforts to combat and pre-

vent pandemic-related fraud. The Task Force bolsters efforts to investigate and prosecute the most culpable domestic and international criminal actors and assists agencies tasked with administering relief programs to prevent fraud by, among other methods, augmenting and incorporating existing coordination mechanisms, identifying resources and techniques to uncover fraudulent actors and their schemes, and sharing and harnessing information and insights gained from prior enforcement efforts. ### DUI+

Michael Chastain, 24, Red Pond Road Sweetwater, was charged with DUI, Man/Sell/Del/Resale Sch. I & II, and Contraband in Penal Institution.

Deputy Eric Curtis LCSO, responded to a wreck that occurred on I-75 SB in Lenoir City, TN. Upon arrival, Deputy observed a silver and black Mazda 6 down the shoulder embankment with significant damage to the front end. Deputy made contact with the driver, Michael Chastain, who stated that he was the driver and did not have any injuries. Mr. Chastain was visibly upset but clearly capable of speech and had no visible injuries. The caller that reported the crash stated that they saw the driver reaching into the car and stuffing something into his pants. Based on that information and the nature of the crash, Deputy asked Chastain to perform Standardized Field Sobri-

ety Tests. Chastain's performance indicated that he was impaired, and he was placed under arrest for Driving Under the Influence. Deputy read Chastain his Miranda Rights and the Tennessee Implied Consent Agreement, and he consented to provide a blood sample. While the Mazda was being pulled from the ditch, an open air sniff performed by K9 Lt. M Watkins and his partner "Cain" indicated the presence of narcotics in the vehicle. The Mazda was searched but nothing was found. Deputy then transported Chastain to the Fort Loudon Medical Center and a blood sample was taken. Upon arriving at the Loudon County Jail, Chastain was asked by both myself and Deputy T Finger if he had any contraband on his person. Chastain stated that he did not. Based on the K9 alert and the suspect's obvious impairment, Deputy requested a strip search of the suspect. During strip

search by Deputy Finger, a small purple container was located in the suspect's underwear, containing a plastic bag and two paper receipts that had powdered substances inside. Deputy M Stanley was contacted and tested the substances with the True Narc device. The plastic bag with 2.2g of a white powdery substance was ruled as inconclusive. The receipt containing 0.7g

of a brown powdery substance was reported to be a Fentanyl/Heroin compound, and the paper containing 0.9g of a gray powdered substance tested as Fentanyl. All three substances were submitted to TBI for testing, and the suspect was also charged with Contraband in a Penal Institution and Felony Possession of Schedule I and Schedule II drugs.

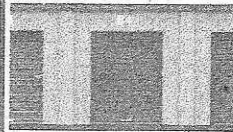

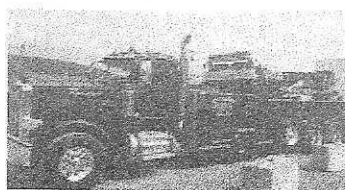

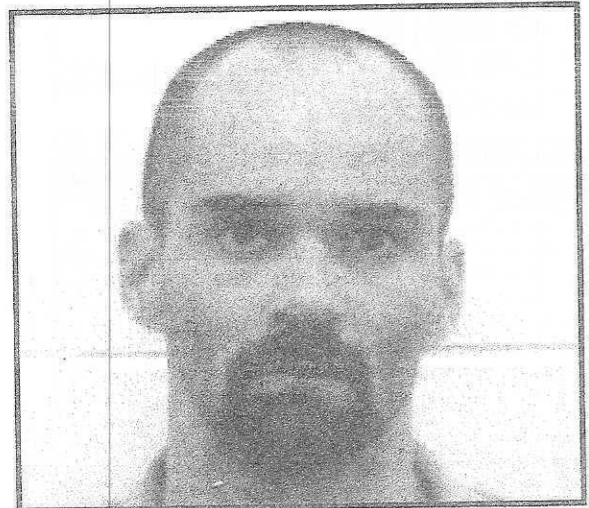

## Knoxville Man Sentenced To Prison For Defrauding COVID-19 Economic Relief Programs

James Waylon Howell, 39, of Knoxville was sentenced to 18 months in prison by the Honorable R. Leon Jordan, in the United States District Court for the Eastern District of Tennessee at Knoxville.

Howell pleaded guilty to engaging in more than \$150,000 in fraud related to the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act, and to committing money laun-

dering.

“This prosecution highlights the Department of Justice’s commitment to aggressively prosecute those who have defrauded these important programs enacted to provide economic relief to those who have suffered financially as a result of the COVID-19 pandemic,” said United States Attorney Francis M. Hamilton III. “Fortunately, the quick and capable work of our feder-

al partners permitted the recovery of a substantial amount of stolen funds.”

“Our office will continue to investigate those who fraudulently take advantage of Coronavirus aid funding that is available to help others during the pandemic, and bring them to justice,” said FBI Special Agent in Charge Joe Carrico.
