

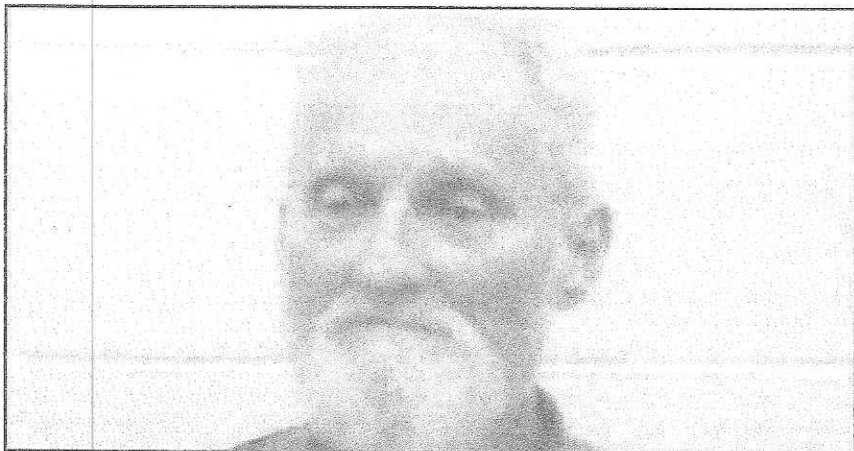

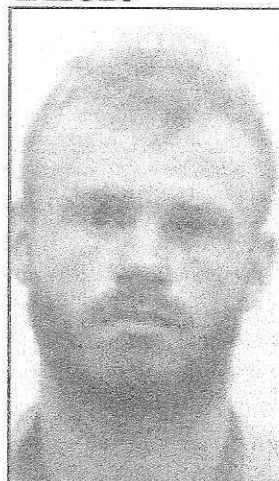

U.S. Attorney's Office For The Eastern District Of Tennessee Announces \$564,767 In Department Of Justice Grant Funding To The Knoxville Police Department To Support The Protection Of Children

United States Attorney Francis M. Hamilton III of the Eastern District of Tennessee announced today \$564,767 in Department of Justice grant funding to support the Knoxville Police Department, Internet Crimes Against Children (ICAC) Task Force.

The Internet Crimes Against Children Task Force Program (ICAC

program) helps state and local law enforcement agencies develop an effective response to technology-facilitated child sexual exploitation and Internet crimes against children. This help encompasses forensic and investigative components, training and technical assistance, victim services, and community education. The grant was awarded

to the Knoxville Police Department, Internet Crimes Against Children Task Force.

The program was developed in response to the increasing number of children and teenagers using the Internet, the proliferation of child sexual abuse images available electronically,

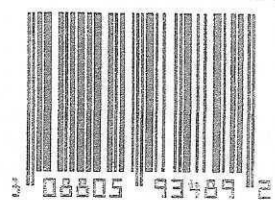

Mark Harper, 63, Dalton Avenue Monticello, was charged with Cruelty to Animals, and Public Intoxication.

Officer McGinnis LCPD, was dispatched to Highway 321 N (Walmart) in reference to an unwanted guest call. Upon arrival Officer made contact with (complainant) who stated the suspect (later identified as Mark Harper) was being very loud and berating customers coming in and out of the store. Officer then asked the suspect if he had any identification on him to which he stated no. When talking to the suspect Officer was able to smell a presence of alcohol on his breath as well as hearing him slur his speech. When asked if he had drank any alcohol

prior to then, the suspect stated that he had not. The suspect stated that he had walked to Walmart and that he was letting the people of this town know that "they aren't Jesus".

Officer then determined the suspect to be a danger to himself and others and placed him under arrest. After further investigation officers were able to locate a Minnesota I.D. to which he was identified as Mr. Mark Alan Harper. Officer then transported Mr. Harper to the Loudon County Jail without further incident. All the above did occur in Lenoir City, TN. Upon further investiga-

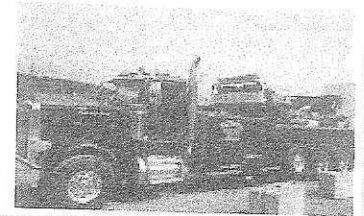
tion Officer was able to locate the truck in the Walmart parking lot, along with the dog inside of the vehicle with the windows up, and no food or water.

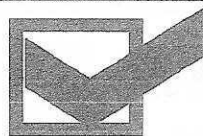

Gerad Hawkins, 46, Smallen Road Loudon, was charged with Domestic Assault.
