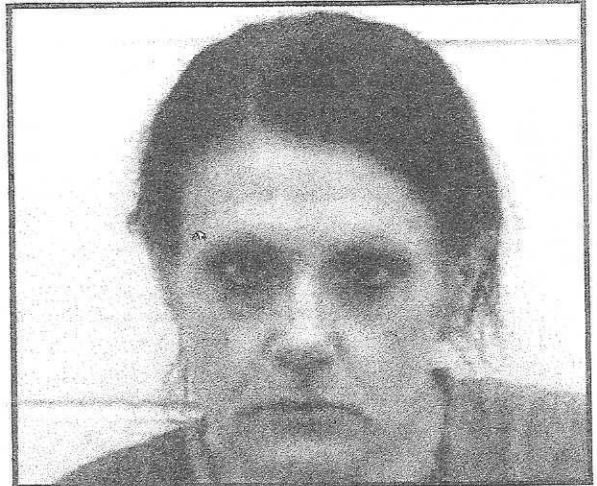

Comptroller Study Finds Tennessee Reconnect Program Increases Degree Attainment in Spite of Declining Participation

The Tennessee Comptroller's Office of Research and Education Accountability (OREA) has released a comprehensive evaluation of the Tennessee Reconnect Grant program. The report finds that program participants earned degrees at slightly higher rates than similar students, but that a decreasing amount of Tennessee

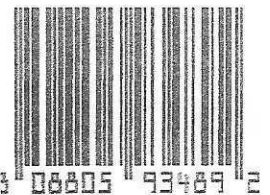
ans are applying for and participating in the program.

The Tennessee Reconnect Grant was initiated by former Governor Bill Haslam and passed into law by the General Assembly in 2017 as part of the Drive to 55 initiative. Adults who have not yet earned an associate or bachelor's degree may use the grant at a community college

or other eligible institution to pursue an associate degree or technical certificate free of tuition and mandatory fees. 11,648 adults received grant funding in 2020-21.

Comptroller analysts determined the number of applicants for Tennessee Reconnect has declined by 46% over

Dana Whitney, 29, Lakeside Route Ohio, was charged with Man/Del/Sell/Sch. II x2 & VI, and Light Law.

Officer Parmer LCPD, was on patrol when he observed a blue Ford Fusion, bearing Ohio tag JNV 5916, with the rear, driver-side brake light out. Officer initiated a stop on the vehicle at the corner of West Broadway and G Street. Upon exiting his vehicle, Officer could smell a strong odor of marijuana permeating from the vehicle. Officer made contact with the driver who was identified as 29 year old Dana Terease Whitney. Upon my speaking with Ms. Whitney,

Officer observed nervous behavior such as shaking hands and speech and failure to make direct eye contact. Officer asked Ms. Whitney about the odor of marijuana coming from her vehicle and she had first informed me she smoked a blunt approx-

imately 2 hours prior to our interaction, however, after getting her out of the vehicle and speaking with her, she stated she had just recently put her blunt out. Officer conducted a probable cause search of the vehicle based on the odor of marijuana.

Due to his search, Officer was able to locate approximately 35.84 grams of Cocaine, 95.22 grams of Methamphetamine, and 2 bags of Marijuana, approximately 28 grams each, all of which were believed to be packaged for resale purposes.

Each narcotic was bagged or packaged separately and were located in the vehicles dash board console. During investigation, Agent Fritts with the 9th Judicial Drug Task Force was able to confirm the narcotics via TruNarc. Ms. Whitney was then placed under arrest and transported to Loudon County Jail without incident.

The above did occur in Lenoir City, Loudon County, Tennessee.

Officer A. Lee LCPD, was dispatched to US Highway 321 in reference to a possibly impaired driver. The caller advised central dispatch that a green truck with a camper top had been driving erratically on the interstate, and struck a guardrail. The caller advised the truck had exited onto US Highway 321 and then turned into Loves Truck Stop. The caller provided a TN tag: DKY-590. Upon arrival Officer made contact with the vehicle and observed a male passed out behind the wheel. The vehicle was running and in gear. Once the driver, identified as Terry Johnson, was awake, Officer observed him to have slow and slurred speech, along with watery

eyes. Officer asked Terry to perform SFST, to which he agreed. Terry performed poorly on all tests administered. During the encounter, Terry admitted to consuming intoxicating beverages. Terry gave consent to search the vehicle which resulted in officers locating multiple open containers of alcohol. Prior to the search, Terry notified officers that there was a Hi-Point handgun in the passenger side floor board. Due to the totality of the circumstances, the Offender was taken into custody. The Offender was advised of the TN Implied Consent Law, to which he refused to provide a blood sample for analysis, and was subsequently transported to the Loudon County Jail without further incident. 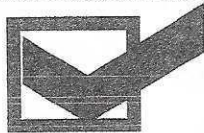

the past three years (2018-2020). During the same time, almost two-thirds of the Tennesseans who filled out an application did not become part of the program. These reductions were likely impacted by COVID-19, and a decline in statewide marketing.

The evaluation also showed that one in four students who entered the program lost their Reconnect grants because they did not meet program requirements. The majority of these students failed to maintain the required minimum of six credit hours per semester. When surveyed, community college administrators often cited work and family responsibilities as reason why students do not maintain enrollment requirements.

While the Reconnect Grant ensures students can attend college free of tuition and mandatory fees, it does not cover additional expenses

such as textbooks, supplies, and special fees. On average, students pay \$400 per semester for these costs. Some survey respondents noted students are often surprised to learn the program does not cover these expenses, and they decide not to enroll because of this.

On a positive note, analysts do believe Tennessee is currently on track to the meet the Drive to 55 goal, but more efforts may need to be made to keep the state on track.

The Comptroller's Office includes several policy options for the General Assembly and other stakeholders within its report. These include changes that could be made to increase applicants and the number of successful participants in the program. As of the fall of 2020, an estimated 4.9% of eligible Tennesseans have applied for the Reconnect Grant.
