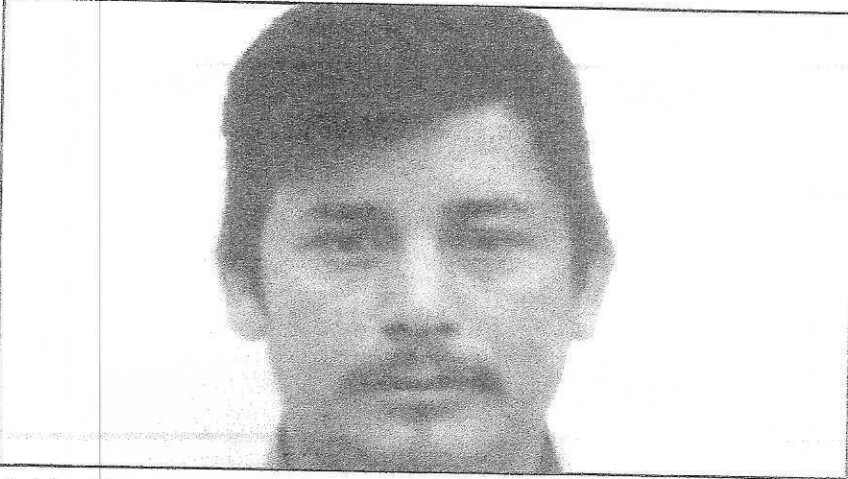

LIST: Here are the laws that take effect Jan. 1, 2023

When the clock struck midnight on Jan. 1, more than a dozen laws went into effect. Laws related to medical records, subscription service cancellations, early retirement for emergency communications personnel and mail-order pharmaceuticals are among some of the new laws that will be enforced starting in 2023.

The most notable law taking effect in January is "Dallas's Law," named for Dallas "DJ" Barrett,

who died after a fight with security guards at Dierks Bentley's Whiskey Row on Aug. 16, 2021.

The law revises the required training necessary for someone working as a security guard/officer, adding de-escalation techniques, safe restraint techniques, and emergency first aid/CPR training.

Prior to the law's passage, those hired as security guards by a "proprietary security organization" were exempt from those

Future Surge in Diabetes Could Dramatically Impact People Under 20 in U.S.

The number of young people under age 20 with diabetes in the United States is likely to increase more rapidly in future decades, according to a new modeling study published today in Diabetes Care. Researchers forecasted a growing number of people under age 20 newly diagnosed with diabetes during 2017-2060.

This expected upward trend may lead to as many as 220,000 young people having type 2 diabetes in 2060—a nearly 700% increase and the number of young people with type 1 diabetes could increase by as much as 65% in the next 40 years. Even if the rate of new diabetes diagnoses among young people remains the same over the decades,

type 2 diabetes diagnoses could increase nearly 70% and type 1 diabetes diagnoses could increase 3% by 2060.

Type 1 diabetes remains more common in U.S. youth, but type 2 diabetes has substantially increased among young people over the last two decades. Given this upward trend,

and stabbed victim in the neck and caused victim to have Defensive cuts on his left arm.

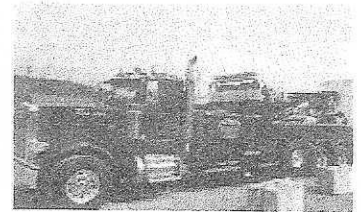

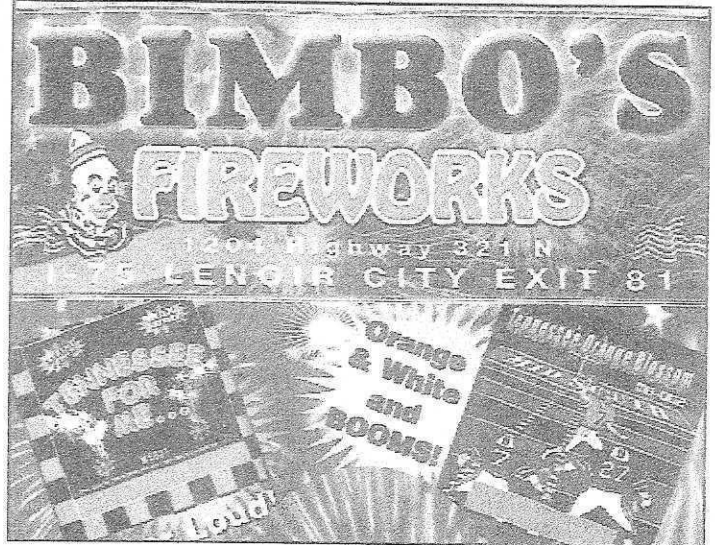
Yvonne Buchanan, 61, Clover Hill Road Maryville, was charged with False Report, and Misuse of 911.

Deputy L. Hawkins #911, was dispatched to 1844 Peterson Road in reference to a domestic. Yvonne Buchanan called 911 stating that her husband, victim, was trying to kill her. Deputy arrived on the scene and made contact with Mrs. Buchanan at the end of the driveway. She was in her car and appeared to be in distress. Mrs. Buchanan stated that she arrived at this residence to check on her dogs, and she was assaulted by the victim. When she approached the door the victim opened it and pulled her hair on the left side of her head. Multiple times during his encounter with her, she advised that she had an order of protection against victim, she also stated this in the 911 call. Mrs. Buchanan and victim are currently married and are in the process of di-

voice and Yvonne no longer resides on Peterson Road. She arrived at this residence on this date because she was contacted by an unknown male who had advised her that her dogs were loose. She could not remember the name of the male, but she advised it was not the victim who contacted her. Deputy and other units left her and continued to the residence to make contact with the victim. He denied her statements but advised she showed up intoxicated, requesting to see the dogs. He told her to leave multiple times and had security camera footage of the incident with audio. In the footage shows Yvonne asking to see the dogs, then the victim telling her that she has been drinking and does not assault her like she had stated. The footage also shows Yvonne standing still on the porch talking on the phone to dispatch. She yells, "He is trying to kill me, help me" multiple times. During this she is alone and the front

door is closed showing no threat of injury or death to her. Deputy placed Mrs. Buchanan into custody for False Reports and Misuse of 911 Emergency System based on the camera footage. During this Deputy asked her once more, "What side of your head was it that he pulled your hair?" she replied, "The left...right side".

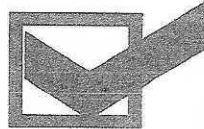
She stated shortly after that it was actually the left side of her head, changing her statement once more. Mrs. Buchanan pulled into a neighboring driveway, she appeared to be intoxicated as well. Her vehicle was towed from Peterson Road. All the above did occur in Loudon County, Tennessee.

certain training requirements; now all those hired as security guards in Tennessee will be required to show proof of that training.

DJ's autopsy revealed he died of asphyxiation, deeming the manner of death as a homicide. Seven people, including six Whiskey Row security guards, were indicted last December on reckless homicide and aggravated assault charges in connection with DJ's death. Additionally, four of the guards were not properly licensed at the time of the incident, according to court documents.

Other bills going into effect Jan. 1, 2023 include:

HB1195/Public Chapter 664: Requires a health insurance entity, a health services provider, or a healthcare facility to notify a patient of communication among the entity, a health services provider, and a healthcare facility concerning the patient's medical claim; requires a utilization review agent to notify the provider or healthcare facility, as well as

the enrollee, when additional information is needed for a prior authorization request. Per the new law, that communication must be given to the enrollee within two business days after that communication has occurred and must include a summary of said communication.

HB1652/Public Chapter 803: Requires a business that allows someone to sign up for a service or subscription online to provide the option to cancel the service or subscription online without additional steps; also creates certain exceptions to this rule, including FDIC-insured banks, NCUA-insured credit unions, local government services, state-regulated public utilities, the FCC or the FERC or businesses licensed by the Tennessee Department of Commerce and Insurance.

HB2416/Public Chapter 1001: Enacts the "Tennessee Abortion-Inducing Drug Risk Protocol Act." This bill requires any abortion-inducing drug to be provided only by a doctor in a medical

facility and cannot be provided through the mail. The law also requires that physician to set up a follow-up appointment around seven to 14 days after the administration of the drug to confirm the pregnancy is "completely terminated" as well as to "assess the degree of bleeding." The criminal penalty for violating this law will be a Class E felony and carries a fine up to \$50,000. There are also civil penalties for violations of the law, including malpractice action for actual and punitive damages; professional discipline for the doctor, including license suspension or revocation; wrongful death action background; injunctive relief against the doctor from doing it again. There is no liability for the patient per the law; only the doctor.

HB2597/Public Chapter 996: Authorizes an assessor property to display "UNLISTED" for the first and last name in the ownership field of an online searchable database of property when certain conditions are met. Those condi-

tions include: the property owner files a written request with the property assessor to have their name put as "UNLISTED" and the written request contains information identifying the property in question as the primary residence of the property owner. The law does not exempt the records from the open records laws.

HB2683/Public Chapter 819: Makes emergency communications personnel eligible for early service retirement when the employing entity has elected to offer this benefit; requires the employing entity to be responsible for 100% of any increased cost necessary to provide this benefit to the emergency communications personnel. The law applies to an emergency communications worker, public safety dispatcher, emergency communications telecommunicator or emergency call taker.

SB0905/Public Chapter 1104: Revises provisions governing the sales and use tax exemption

a total of 526,000 young people may have diabetes (including both type 1 and type 2 diabetes) by 2060. Comparatively, 213,000 young people in the United States had diabetes in 2017.

“This new research should serve as a wake-up call for all of us. It’s vital that we focus our efforts to ensure all Americans, especially our young people, are the healthiest they can be,” said CDC Acting Principal Dep-

uty Director Debra Houry, MD, MPH. “The COVID-19 pandemic underscored how critically important it is to address chronic diseases, like diabetes. This study further highlights the importance of continuing efforts to prevent and manage chronic diseases, not only for our current population but also for generations to come.”

In addition to the overall predictions, analyses of these data by race and ethnicity predicted a higher burden of type 2 diabetes

for Black, Hispanic/Latino, Asian, Pacific Islander, and American Indian/Alaska Native youth.

“Increases in diabetes—especially among young people—are always worrisome, but these numbers are alarming,” said Christopher Holliday, PhD, MPH, MA, FACHE, director of CDC’s Division of Diabetes Translation. “This study’s startling projections of type 2 diabetes increases show why it is crucial to advance health equity and reduce the widespread disparities that already take a toll on people’s health.”

There could be several explanations for the rise in type 2 diabetes, including the increasing prevalence of childhood obesity. The presence of diabetes in people of childbearing age might be another important factor, because maternal diabetes increases risk of diabetes in children.

People with diabetes are at higher risk for heart disease or a stroke, diabetes complications, and premature death than those who do not have

diabetes. Researchers are actively investigating ways of preventing type 1 diabetes and studies in adults have identified steps that can be taken to reduce the risk factors for type 2 diabetes. These findings come from the SEARCH for Diabetes in Youth study, funded by the Centers for Disease Control and Prevention and the National Institutes of Health.

for qualified farmers and nurserymen in regard to certain farm equipment and machinery used in agricultural operations. The law exempts farmers from sales tax on items and services used for agriculture production, including building materials, repair services, and labor.

SB2295/Public Chapter 1112: Makes various changes to the qualifications for certification as a medication aide by the board of nursing. Changes include stipulating prior experience in certain care facilities must be at least one continuous year or more; certain training requirements can now be completed via distance or virtual learning; and the passing grade required of standard examinations is now lowered from 85% to 75%.

SB2398/Public Chapter 785: Outlines a relative caregiver program for foster care; authorizes the department to implement an extension of the foster care program to provide services to youth transitioning from state custody to adulthood. This bill reimburses eligible relatives of foster youth to support the cost of raising the child. It also expands eligibility to ages 18-21 for foster youth transitioning from state custody to adulthood to access services, according to the Tennessee Senate Republican Caucus Deputy Press Secretary Zachary Clark.

SB2694/Public Chapter 1040: This bill revises provisions governing professional counselors. Starting Jan. 1, professional counselors will be required to have "completed coursework" specifically related to the "diagnosis, treatment, appraisal, and assessment of mental disorders" as well as completed two years of postgraduate supervised experience. The previous law specified counselors needed at least nine graduate semester hours and two years of post-master's supervised experience. Additionally, if someone is granted a temporary license, that license will now be valid for up to four years and be eligible for extension.

The 113th General Assembly will convene Jan. 10, 2023.
