Officer R. Miller, with the Lenoir City Police Department, was conducting traffic enforcement in the area of Highway 321 near Interstate 40 located in Lenoir City, TN. While conducting traffic enforcement in the area, Officer observed a gold in color Ford sedan traveling south on Highway 321. While observing the vehicle Officer noticed that the rear passenger side brake light was not functioning. A traffic stop on the Ford sedan was then conducted in the parking lot of

City, TN. As Officer exited his fully marked patrol unit to make my initial contact with the Ford sedan the front seat male passenger quickly exited the vehicle with a blue drawstring bag and appeared to be physically nervous. Officer advised the male to have a seat back in the vehicle at which time he did. Officer then made contact with the driver and a male passenger. While speaking with both subjects I could smell what appeared to be a faint odor of marijuana emitting from inside of the vehicle. As the male subject stepped out of the vehicle, Officer noticed a strong odor of marijuana emitting off his person and also noticed an abnormally large bulge in the front of his pants where the male stated "it was a little bit of

wet weed". Officer was able to recover the blue bag from the front of his pants. Contained inside of the blue bag was a McDonalds bag that contained a large amount of a green leafy substance believed to be marijuana. Oscar Lopez,38 Mincey Street Lenoir City, was charged with Domestic Assault x2.


Parmer LCPD, Officer along with officers from the Lenoir City Police Department, were dispatched to Mincey Street in regards to a possible physical domestic in progress. Upon arrival, officer made an approach to the residence and could hear shouting coming from within. While outside, looking through the window, Officer observed the assailant, identified as 38-year-old Oscar Lopez, with his arms raised at his children, shouting at them. Officer made entry into the residence, and observed Mr. Lopez to be heavily intoxicated, with multiple Budweiser cans laid around the kitchen. Officer separated Mr.

Lopez from the rest of the family members, and once separated, Lt. Dragon spoke with victim #1,who stated that her husband has been drinking heavily for the last 2 days. Victim 1 stated that vesterday, she and Mr. Lopez were in an argument, which turned into a physical altercation, however, she did not notify law enforcement. Mr. Lopez continued to drink, to which another argument then ensued. The argument led to a physical altercation, which resulted in victim 1 receiving multiple cuts and scratches on her person. During the altercation, Mr. Lopez, and victim #2, attempted to intervene, to which Mr. Lopez then pulled her by her hair. 

poral Wallen, Deputy Parks, and Davis attempted to make contact with the male and female at Mealer Road. As they approached, Deputy observed a male on a blue and orange motorcycle drive from behind the residence and across the neighbor's yard to the road. I attempted to get the attention of the male by flashing my flashlight at him. The male failed to stop and sped off onto Highway 70 towards Lenoir City. Deputy Parks attempted to locate the male but was unsuccessful. Corporal Wallen and Davis attempted to make contact with the female at the residence, but she refused to come and speak with them. Shortly after, the male returned to the residence. Deputy yelled at him to stop but proceeded to speed off again onto Highway 70. Officer Tatham from the Lenoir City Police Department advised he observed a blue and

orange motorcycle on the shoulder of Highway 321 and Highway 11. Officer Tatham advised a male ran off into the woods when he approached. The male was later identified as Daniel Langley. He was located and taken into custody. Deputy made contact with Daniel. Deputy read Daniel his Miranda rights and he consented to speaking with him. Daniel stated when he saw deputies approaching the residence, he feared he was "in trouble," so he fled the residence on his motorcycle. While speaking with Daniel, the deputy observed that he had very constricted pupils and was very lethargic with his movements. A search of his person did not produce any evidence of illicit substance use however Daniel did consent to conducting the standardized field sobriety test. Daniel conducted the

standardized field sobriety test in the Sally port of the iail. During the horizontal gaze nystagmus test, Daniel showed clues such as lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes and the onset of nystagmus prior to 45 degrees in both eyes. During the walk and turn test, Daniel showed clues such as failing to keep his balance during the instruction phase of the test, starting the test too soon during the instruction phase, missing heel to toe, and using his arms for balance. Daniel showed no clues on the one-leg stand test. Daniel also consented to conduct the advanced roadside impaired driving enforcement test. Daniel showed a lack of conversion in both eyes. Deputy observed Daniels's eyelids tremoring during the modified Romberg balance test. Daniel showed no clues on the finger-to-nose portion. From my training and experience, Deputy believe Daniel was under the influence of possibly a narcotic analgesic and a central nervous system depressant and was unfit to operate a motor vehicle safely. Daniel was charged with driving under the influence. Deputy read Daniel the implied consent law, and he denied consent to providing a sample. Daniel later stated he "would fail for dope." Daniel was also charged with driving with a revoked driver's license. This incident occurred in Loudon County Tennessee.
