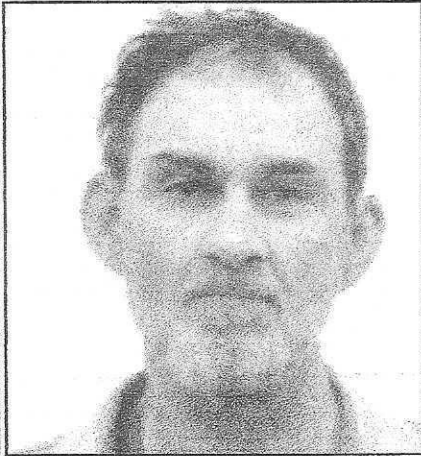

## Two Charged After Being Found in Closed Building

## Dental Provider And Associated Individuals Agree To Resolve Allegations Of Improper Billing Of TennCare

The United States Attorney's Office announced today that Dr. Michael Sawaf and his affiliated company Premier Dental Group PLLC of Knoxville, f/k/a Orthodontic Designs by Michael Sawaf, PLLC ("PDG"), have agreed to pay \$985,541 to resolve allegations that they knowingly and improperly submitted false claims for den-

tal services to TennCare in violation of the False Claims Act ("FCA") and the Tennessee Medicaid False Claims Act ("TMFCA"). Erin Ferdowski and Reja Ferdowski, both of whom were affiliated with PDG, also agreed to resolve similar allegations against them.

TennCare prohibits billing for services that are not provided, upcoding claims to

receive higher reimbursements to which a provider is not entitled, and billing for unnecessary services. TennCare also requires that dentists apply for and receive approval to participate in the TennCare program before billing for services rendered to beneficiaries. The credentialing process is intended to ensure

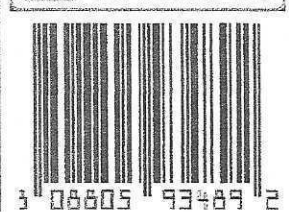

### Charged

Becky Viars, 53, Jim Hartsook Drive Lenoir City, was charged with Simple Possession x2, and Public Intoxication.

Timothy Crawley, 52, Prospect Church Road Loudon, was charged with Public Intoxication.

Officers with LCPD, were dispatched to (Walmart) on a possible missing child. As officer was pulling up, Walmart called back and stated the child had been found. Employees showed this officer the car the little girl had gotten out of. This officer knocked several times on the window of the

car in question to wake up a male (only occupant) sleeping in the drivers seat.

The male (later identified as Tim Crawley) had slurred speech and seemed confused and thought the little girl was in the car with him. LCSO Sgt. Cole (ARIDE Certified) arrived to perform field sobriety on Crawley and stated that Crawley was in fact impaired. Crawley was placed into custody for Public Intoxication. Inv. Yates arrived and found the child with her grandmother (Becky Viars) inside the store where Viars appeared to be on some kind of narcotic, very fidgety, couldn't stand still, and picking up/

moving backpacks on a shelf for no reason, giving signs of Meth use. Inv. Yates brought the child outside the store with Viars following.

Viars gave consent for Sgt. Espinoza to search her purse. Found in Viars eye-glass case was plastic cigarette pack plastic cover with what was believed to Meth and another plastic wrap with was appeared to the a full waffer of Methadone

in 3 pieces. It appeared to officers that Crawley and Viars was both was under the influence of narcotics, was a danger to themselves and the public and also the child. Both was arrested for Public Intoxication and transported to Loudon County Jail without incident. The child, Ariana Underwood, was transported to The Police Dept. where DCS was notified.

Jax Payne, 19, Cress Lane Lenoir City, was charged with Aggravated Burglary, Public Intoxication, and Vandalism.

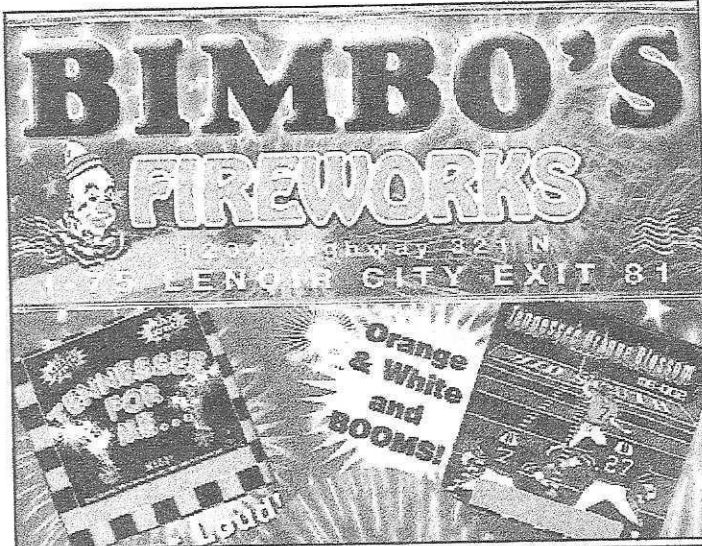
Dreamah Mahala, 19, D Street Lenoir City, was charged with Aggravated Burglary, Vandalism, and Public Intoxication.

Officers with the Lenoir City Police Department were dispatched to South Grand Street "Grand Furniture" in reference to a break in-in progress. The complainant stated he observed on his security camera two unknown individuals entering the building through the fire escape without his permission. Officer Law, and Officer LaForce made entry through the rear of the old police department to clear the building. Of-

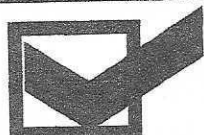
ficer Law located a female who he identified to be Dreamah Mahala hiding in one of the rooms, while conducting his investigation he could smell the strong odor of burnt marijuana, and the odor of an alcoholic beverage emitting from Ms. Mahala's persons. Officer LaForce then located a male who was later identified to be Jax Payne. Officer LaForce could smell the strong odor of an alcoholic beverage emitting from Mr. Payne. Both parties admitted to officers the consumption of alcohol prior to our encounter. It was determined through our investigation that both parties entered the building through the fire escape without the effective owner's consent. After both parties were placed under arrest,

the "Victim", identified a camping light that was in Mr. Payne's belongings. The victim also stated two of his security were inoperative after both individuals entered the building. After advising both parties of their Miranda warnings to which both parties waived

their rights and agreed to speak to the officer, it was determined both security cameras were damaged in an attempt to elude identification. Both parties were then transported to the Loudon County Jail without incident. All the above occurred in Lenoir City,

Corey Peacock, 33, Fox Lonas Drive Knoxville, was charged with Resisting Arrest, Indecent Exposure, and Public Intoxication.

Officer Sparks LCPD, was dispatched to the area of the Loudon County Marina, City Park Drive, in reference to a

possible intoxicated driver. The complainant, initially advised that a male was at Calhouns and was possibly intoxicated. A white male, later identified as Corey Peacock, matching the description of the registered owner of the pickup truck was seen walking on a dock within

the Marina. Sgt. A. Lee and Sparks, attempted to make contact with the male, while Sgt. A. Lee's blue lights were on. When Mr. Peacock heard officers speaking to him, Mr. Peacock pulled his shorts down to his ankles and exposed his buttocks. Mr. Peacock pulled up his shorts and continued walking to a boat. Verbal commands were given to Mr. Peacock numerous times to stop, to which he did not comply. Officers continued to approach Mr. Peacock and continued to give him numerous verbal commands to stop walking away. Mr. Peacock was attempting to get on a boat when officers reached him and finally made contact. Mr. Peacock smelt strongly of alcohol and appeared to have slurred speech. Believing Mr. Corey Peacock to be under the influence of alcohol, and being within close proximity

of a large waterway, Officer Sparks placed Mr. Corey Peacock into custody for Public Intoxication, Resisting Stop, Frisk and Halt for failing to comply with officer's numerous verbal commands, and Indecent Exposure for intentionally exposing his buttocks to officers in a space that was visible to the public. Mr. Peacock's reasoning for exposing his buttocks was that he does it often with his friends. Mr. Peacock stated that he had been at Calhouns for a majority of the day, and had drunk "a lot" of alcoholic beverages. Mr. Peacock also advised that he initially heard officer's verbal commands for him to stop walking, but ignored them because he felt that we were speaking to someone else. All of the above did occur in Lenoir City, Loudon County, TN.

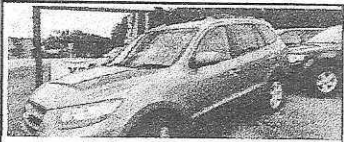

that beneficiaries receive the highest quality of care from competent providers who have been vetted prior to rendering services.

Dr. Sawaf owns and sees patients at PDG, a dental and orthodontics clinic located at 303 S. Concord Street, Suite 323, in Knoxville, TN. Erin and Reja Ferdowski operated, managed, and/or worked at PDG. The settlement resolves allegations that, from January 1, 2016, through December 31, 2020, PDG knowingly submitted, or caused the submission of, false claims to TennCare for payment relating to various dental procedures. The settlement also resolves allegations that, between August 14, 2019, and September 11, 2019, PDG knowingly submitted, or caused the submission of, claims for payment to TennCare that falsely identified credentialed dentists as the rendering provider for services that were actually rendered by uncredentialed

dentists who were ineligible to bill TennCare.

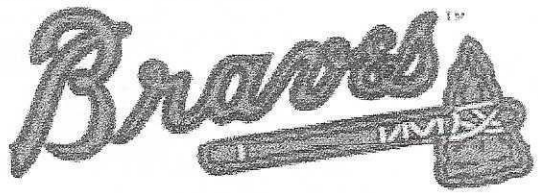
This settlement is the result of a collaborative effort between the U.S. Attorney's Office for the Eastern District of Tennessee, the Federal Bureau of Investigation, the Tennessee Attorney General's Office, and the Tennessee Bureau of Investigation. The investigation that preceded the settlement was prompted by a lawsuit filed in 2020 under the qui tam or "whistleblower" provisions of the FCA and TMFCA, which permit a private individual (known as a "relator") to sue on behalf of the government for false claims and to share in any recovery. The relators' share of the recovery in this case is \$182,325.

Assistant U.S. Attorney Joseph C. Rodriguez represented the United States.

The claims settled by this agreement are allegations only, and there has been no determination of liability.

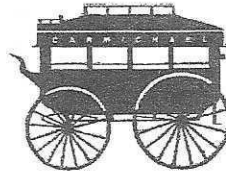

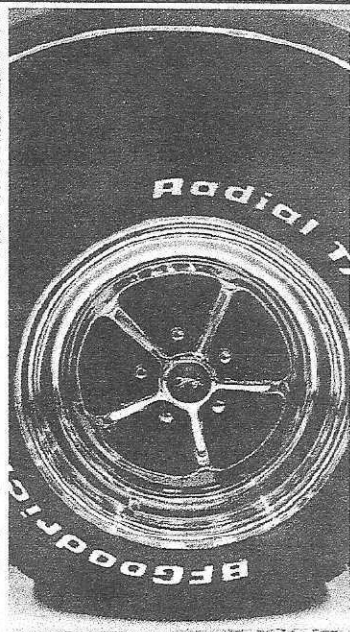

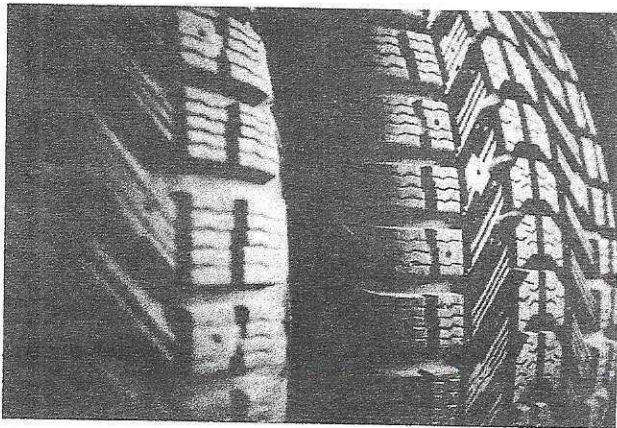
