HB 289 will Require Executions within 30 Business Days



TN HOUSE REP. LOWELL RUSSELL R - Vonore

113th GENERAL ASSEMBLY - 14th LEGISLATIVE

House Bill 289, sponsored by State Rep. Lowell Russell, R-Vonore, will require a sentence of death to be carried out within 30 business days of the conclusion of any appeals or post-conviction relief, if the jury unanimously determines that certain circumstances are met.

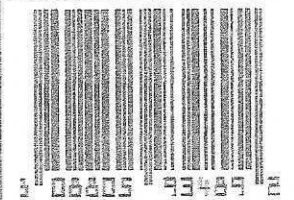

Investigators with the Loudon County Sheriff's Office Narcotics Unit executed a narcotics search warrant of a camper, in which Robert Young resides, located on the property of US 411. South, Greenback, Loudon County, TN. Investigators assisted by the Loudon County Sheriff's Office Patrol and K-9 Division made entry to the residence through the unsecured front door after multiple knocks and announcements. Investigators observed four males inside of the camper inside of a bedroom on the

right side of the camper later identified as Robert Young, Curtis Adam Summer, Robert E. Summey, and Clinton McMahan. Investigators secured all subjects and began search of the camper. Located in the bedroom labeled "A" where all subjects were located were several baggies and a spoon with a grey substance, which tested positive for Heroin, totaling a weight of 6 grams (Scan#2015,2016,2017). These were within reach of all subjects inside of the room. Also recovered from "Room A" were numerous loaded syringes, empty uncapped syringes, empty baggies containing drug residue and hundreds of empty bagges in various sizes which are used to package

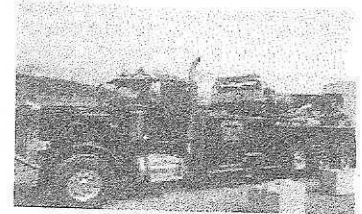


and distribute narcotics, digital scales with drug residue, and a baggie with 1 gram of a white powdery substance which tested positive for Cocaine (Scan#2012). Located in the living room area "Room B" of the camper was a small tub of dry oats and located inside the tub was a large baggie containing 19.5 grams of a grey substance

which tested positive for Heroin(Scan#2015). All subjects were taken into custody and transported to Loudon County Jail without incident. All subjects were charged with Man., Sell, Del. of Heroin (Schedule 1), Simple Possession of Cocaine (Schedule 2) and Unlawful Drug Paraphernalia. All the above did occur in Loudon County, TN.

During the walk and turn

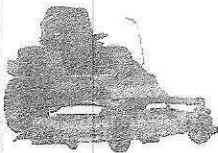

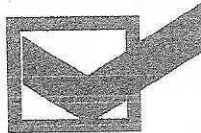



 contestable evidence that the defendant killed three or more victims with the use of a deadly weapon, used a deadly weapon on the grounds of a public school, or committed the offense of killing an on duty first responder, this bill would allow a jury to expedite the defendant's sentence of death. If the Tennessee Department of Corrections (TDOC) is unable to carry out a sentence of death by lethal injection, then the electric chair shall be used.

The bill passed in the House on March 13, 2022. Senator Janice Bowling is sponsoring the bill in the Senate and working it through the committee sys-

tem. If passed in the senate, and signed by the governor, this bill would go into law on July 1, 2023.

"These murders should be fast tracked to their execution for killing a first responder, killing anyone on school grounds or committing a mass killing", stated Russell.

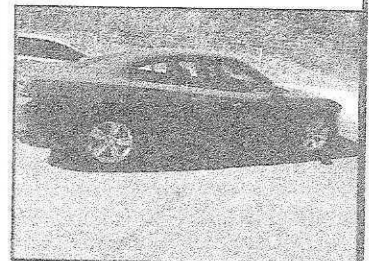
