Officer R. Miller LCPD, conducted a traffic stop on a white in color Honda sedan at the exit of Loves Truck Stop in Lenoir City, TN. The traffic stop was conducted in regards to the owner of the vehicle positivity being identified as whom Officer knew from prior knowledge was driving on a suspended Tennessee License status. Upon Officer approach to the vehicle, he noticed a strong odor of marijuana emitting from inside of the vehicle. Officer made contact with the driver, and the passen-ger, James Buzbee. While speaking with driver Officer noticed that her hands were shaky and also noticed that she continuously wanted to smoke a cigarette during Officer entire interaction with her. Officer had the driver then step outside of the vehi-

cle to speak with her further about a citation and about the odor of marijuana. Offi-cer then had BUZBEE exit the vehicle due to the odor of marijuana emitting from inside of the vehicle. Once BUZBEE was outside of the vehicle Officer then asked him if he would empty the contact of his pockets. BUZBEE proceeded by emptying his pockets on his own free will where Officer visually observed a glass pipe and a plastic bag containing a crystal-like substance believed be methamphetamine (9.69 grams) in his hand. BUZBEE was immediately placed under arrest. A probable cause search of the vehicle was then conducted where Officer located (5.93 grams) of a green leafy substance believed to be marijuana. While under arrest BUZBEE was mirandized where Officer then asked him about the crystal-like substance. BUZBEE advised that the substance was methamphetamine and

that the glass pipe was used to smoke methamphetamine with. BUZBEE also stated that he makes trips back and forth to Alabama to purchase methamphetamine. BUZBEE stated that he normally purchases half an ounce of methamphetamine which usually cost him \$150.00 in US Currency. Tru Narc confirmed that the crystal substance was meth.



Rachel Petty, 23, Grand Avenue Knoxville, was charged with DUI, Violation of Implied Consent, Driving on Roadway laned for Traffic, and Speeding.

Officer Parmer LCPD, was on patrol when he observed a red Toyota Corolla, bearing TN tag BJF1696, travelling E on W Broadway at a high rate of speed. While behind the vehicle, Officer paced it to be travelling 47-mph in a 30-mph posted speed zone. The vehicle crossed over the center line multiple times and

at Poplar Street and Bussell Ferry Rd, and made contact with the driver, identified as 23-year-old Rachel Pet-ty. While speaking with Ms. Petty, Officer observed her to have watery, glassy eyes, slurred speech, and Officer could smell a strong odor of an alcoholic beverage emitting from her person. Officer requested that Ms. Petty step out of the vehicle and stand at the front of his patrol unit, however, she struggled to follow basic instructions.

Officer asked Ms. Petty if she was willing to perform SFST's, to which she consentSmooth Pursuit, Distinct and Sustained Nystagmus at Maximum Deviation, and Onset of Nystagmus Prior to 45 Degrees. During the Walk and Turn Instructional Phase, Ms. Petty was unable to keep her balance and started too soon, twice; during the test, Ms. Petty missed approximately 7 heel to toe steps, stepped off the line approximately 5 times, stopped while walking, used her arms for balance, and made an improper turn.

During the One Leg Stand, Ms. Petty swaved while balancing, used her arms for balance, put her foot down, and counted to 6 seconds by the time Officer reached 30 seconds on the stopwatch. Ms. Petty was placed into my custody and read Tennessee Implied Consent, to which she refused to provide a blood sample for chemical testing. Ms. Petty was then transported to Loudon County Jail without further incident.

Glacia Goforth, 18, Allison Road Lenoir City, was charged with Domestic Assault.

Officers with LCPD, were dispatched to the Area of Allison Ln in regards to a possible domestic. An anonymous complainant called in and stated that she could hear arguing coming from above her apartment.

Officers arrived on scene but could not locate, or hear any ongoing domestic and cleared with no contact. At 01:03 hours, Officers were dispatched to the Casey's gas station for a possible drunk driver. Upon making contact with the female (Glacia Goforth) and further investigation and statements from her friends, Officers discovered that Glacia was involved in the Domestic that occurred on Allison Ln that Offices were unable to locate. Glacia stated that she and her friends went to her home (Allison Ln) and

got into a heated confrontation with her Uncle the victim who she lives with. Bradley Central High School Band Booster Club Member Indicted

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Crystal Lynn, who served as the concession manager for the Bradley Central High School Band Booster Club in Cleveland, Tennessee.

Investigators determined that Lynn misappropriated at least \$2,069.59 from the booster club by making personal purchases between September 2021 and De-

cember 2021.

The booster club's primary fundraiser is selling concessions during football games. As the concession manager, Lynn was responsible for purchasing concession items before each game. In addition to the concessions, Lynn also included personal items, including gift cards and clothing, with her purchases. She used a booster club check to make these purchases.

It should be noted that Lynn repaid the booster club \$2,069.59 on December 13, 2021.

In addition to Lynn's misappropriation, investigators also noted the booster club had other questionable and unsupported purchases totaling \$904. These purchases were made by other members of the booster club, but they were not adequately documented with itemized receipts or invoices. Investigators could not determine if these purchases were made for the exclusive benefit of the club.

In February 2023, the Bradley County Grand Jury indicted Crystal Lynn on one count of theft over \$1,000.

"Booster clubs must ensure they have adequate controls in place to safeguard money and property," said Comptroller Mumpower. "In this case, the booster club allowed some checks to be signed before purchases were made, and they did not maintain adequate documentation to support all purchases. These controls help reduce the risk of improper transactions."




