

Former West TN Probation Officer Stole \$2,757

investigation by the Tennessee Comptroller's Office, working in conjunction with the Tennessee Bureau of Investigation, has ultimately resulted in Tracy Boyd Jr.'s guilty plea on one count of theft over \$2,500.

Boyd worked as a probation officer for Tennessee Соптесtional Services West, Inc. (TCSW), which provides misdemeanor probation supervision and intervention services to various courts throughout West Tennessee. TCSW collects fees from probationers for the services it provides.

Învestigators determined that Boyd stole at least \$2,757 in collections from July 31, 2019 until his employment was terminated on August 26, 2019.

Boyd failed to receipt

and remit \$2,757 of the \$8,163 in fees that he collected from his clients. In some cases, he used an unauthorized receipt book to issue receipts to his clients. This was done in an effort to conceal his misappropriation.

On November 14, 2022, Boyd pled guilty to the indicted offense

Samuel Frazier, 40, Levi Circle Georgia, was charged with DUI, Evading Arrest, Violation of Implied Consent, Possession of Handgun while under the influence, and Driving on Roadways Lanes for Traffic.

Officer Eldridge LCPD, was traveling South on Hwy 321 when he observed a Nissan Versa (5Y3-4K7) traveling South on the Northbound side in front of the Kings Inn. A traffic stop was attempted on Town Creek Rd E and the vehicle failed to stop and began to increase its speed. The vehicle disregarded the 4 way Stop sign at Shaw Ferry and continued East on Town Creek, towards Ford Rd at a high rate of speed and all over the roadway. The vehicle then turned left onto Ford Rd, towards Hwy 70 while continuing to drive erratic, eventually turning right on Hwy 70 towards Knox Co.

The vehicle reached speeds of 90 mph and almost wrecked multiple times but eventually came to a stop at the Two Rivers Church in which Officers conducted a Felony stop.

Contact was made with the Driver (Samuel L. Frazier) and was immediately placed in custody at that time. Officers noticed a strong odor of alcohol emanating from Frazier and had bloodshot, watery eyes and appeared to be very lethargic.

Officers did locate an open Bahama Mama Cocktail in the center console. Frazier stated to officers multiple times that he just wanted to get away and that he was just diagnosed with Lung Cancer. A search of the vehicle also revealed a loaded Springfield XD 45 handgun (MG644430) located in the glovebox, 3 boxes of ammo, and 4 rifle mags.



ing any medications at the time. Sgt Pesterfield arrived on scene, they both went to the bedroom to speak with Rebecca. While speaking with her she did not make sense and then abruptly ran out the backdoor.

As Sgt. and Deputy followed Rebecca out the door, Sgt. stated he could smell the odor of marijuana in the bedroom. We spoke to Rebecca outside, where she continued to talk to people that weren't there. She was experiencing a mental health episode, and was a danger to herself and others inside the residence. Sgt. Pesterfield motioned for Deputy to go behind her and attempt to get control of her. She then started to resist and fell to the ground, then rolled onto her back at which point, she struck Deputy multiple times, knocking his mic off his vest. Sgt. Pesterfield and Deputy were able to place the offender in custody at that time.

The offender also returned with an active VOP warrant #2022-CR-134 out of Loudon County. Ms. Lo-

renz continued to fight them, causing Deputies to carry her to the patrol vehicle. While attempting to get her into the patrol vehicle the offender kicked Sgt. Pesterfield multiple times in the midsection. Derputy am charging the offender with assault on a first responder x2, resisting arrest, and Deputy served the active arrest warrant.

Michael Potter,66, Highway 95 Greenback, was charged with DUI, and Open Container.

Deputy Jackson LCSO. received a call of an intoxicated driver coming to an address of Highway 95 N, from Blount County, Deputy passed a vehicle matching the description, dark Grey Toyota Tacoma, on Highway

95, at Greenback Memorial Baptist Church. Deputy attempted to turn around on the vehicle, but he was unable to get behind the vehicle, due to a car between them. Deputy was able to catch up to the vehicle, as it was pulling into the driveway of Highway 95 N. Deputy verified that it was the vehicle by the TN registration 093BHKX. Deputy made a traffic stop in the

driveway, and witnessed a male exit the driver's side of the vehicle. The male subject was identified as Mr Michael Potter. Deputy asked Mr. Potter if he had anything to drink tonight and he denied that he did, however, while speaking to Mr. Potter, Deputy could smell the odor of an alcoholic beverage, which became stronger as they spoke. Deputy asked Mr. Potter to conduct Standardized Field Sobriety Tasks, to which he consented.

Mr. Potter performed poorly on the SFSTs (see notes). CPL. Wallen conducted ARIDE on Mr. Potter (see notes). Deputy Huskin, notified Deputy Jackson that there was an empty beer bottle in the vehicle, upon further inspection, Deputy saw three open Miller High Life bottles, one being half empty; all were within the

immediate reach of Mr. Potter. There was also an empty can of Smirnoff just behind the driver's seat.

Mr. Potter was taken into custody for DUI and Open Container. He was read TN Implied Consent, and consented to a blood draw. He was taken to Fort Loudon Medical Center for the blood draw, and subsequently to the Loudon County Detention Center.



of theft of property over \$2,500, among other unrelated offenses in the Madison County Circuit Court. He was given an effective sentence of four years on supervised state probation and ordered to pay restitution in the amount of \$2,741 to Tennessee Correctional Services West, Inc. at the rate of \$150 per month.

"We recommend that TCSW utilize a software

system that allows it to record collections, issue receipts, and reconcile collections with the amounts posted in its software," said Comptroller Mumpower. "We also recommend the Jackson City Court develop a written agreement with TCSW for the services the company provides to the court."






