The Tennessee Comptroller's division of Local Government Audit has launched a new resource designed to improve and emphasize the importance of good financial management within Tennessee's hundreds of volunteer fire departments.

"While volunteer fire departments provide essential services across the state, they are also prone to financial troubles including fraud, waste, and abuse," said Comptroller Jason Mumpower. "Many of these departments have been the subject of fraud investigations by my Office."

The first edition of the Volunteer Fire Departments Financial Reporting and Procedures Manual offers clear guidance to developing policies and procedures that help mitigate risks around activities such as fund-

raising, purchasing, the sale of surplus property, grant expenditures, and many more.

The new manual also reminds each volunteer fire department that receives government money of the requirement to file an annual financial report with the Tennessee Comptroller of the Treasury and each local government body

partment to report several past incidents of domestic violence. The victim stated son, 57, Lenoir City was she and James Epperson charged with Aggravated had been in a past relationship three years ago that lasted six months. The victim has repeatedly asked Epperson to move out of


her home, but he has refused. Epperson stays in the basement and has been told not to access the rest of her home.

The victim stated on September 19, 2024 about 1030pm, she arrived home and went to bed. About 130am the next morning, Epperson was drinking alcohol, made entry to her locked bedroom while she slept, argued about her whereabouts and threatened to kill her and subsequently himself. Epperson pointed a pistol at the victim while mak-


ing the threat. The victim feared for her life but was afraid to report the incident to law enforcement due to two past incidents where Epperson had fired shots inside the victims home coupled with threats made by Epperson if she involved law enforcement he would "shoot it out" with police. Epperson violated TCA 39-13-102, Aggravated Assault, by Intentionally and knowingly causing the victim to fear imminent bodily injury involving the use or display of a deadly weapon.



CDC Confirms 3rd Human Case of H5 Bird Flu in California

The Centers for Disease Control and Prevention (CDC) has confirmed a third human case of H5 bird flu in California. Like the two cases in that state confirmed last week, the person reported occupational exposure to infected dairy cows. To date, all three California cases occurred in dairy workers from three different affected farms with no known contact with each other, suggesting animal-to-human spread. Also consistent with the two previous California cases, the person experienced mild symptoms, including eye redness or discharge (conjunctivitis). None of the three cases has been hospitalized. The identification of H5 in people with exposure to infected animals is not unexpected and does not change CDC's risk

Justin Conley, 33, Avery Circle Lenoir City was charged with, Aggravated Assault.

Sgt. Rogers LCSO, was dispatched to a domestic disturbance at Avery Circle. Upon arrival Sgt. Rogers made contact with the victim, and witness, who both stated that Mr. Justin Conley arrived and became aggressive with the victim. During a heated verbal altercation Justin ran at the victim and hit her with a closed fist on the right shoulder and face. Justin also grabbed the victim by the throat and was choking her. The victim was able to run to the next room at which time Justin pushed her on the bed and began throwing things at her. He then grabbed the tv and stomped it before the witness, Justin's sister, grabbed him and stopped the altercation. Sgt. Rogers did observe the victim to be red and

bruised on her right shoulder, neck and face. Cpl. Wallen and Rogers arrived at Avery Circle, where Justin had fled to and took him into custody. Including this most recent case, 18 human cases of H5 bird flu have now been reported in the United States since 2022; 17 cases during 2024. CDC is awaiting 2 additional presumptive positive specimens from California for confirmatory testing.

CDC Lab Update on First Two California Cases


2.3.4.4b A(H5N1) viruses closely related to viruses detected in dairy cattle. The whole genome was sequenced from one of the two cases (A/California/135/2024) and was confirmed to be a B3.13 genotype virus. There were no genetic changes observed that are known to be associated with an increased ability to infect or spread between people or known to reduce susceptibility to antiviral medications. These sequences have been publicly posted in GISAID and have been submitted to GenBank. Sequencing from the third confirmed case is underway.

CDC continues to underscore the importance of recommended precautions for people with exposure to infected or potentially infected animals. People with close or prolonged, unprotected
