Jesus Torrez,28, Buffalo Drive Morristown, was charged with, DUI, Open Container, and No Driver License.

Cpl. Christina Wallen LCSO, responded to I-75SB near the Philadelphia exit in reference to a possible reckless driver. Loudon County Communications advised that the caller had observed a dark Chevy SUV all over the roadway and that the vehicle had abruptly pulled to the shoulder of the roadway. Cpl. Wallen did observe a gold Chevy Suburban on the shoulder of the road with

the hazard lights on near the 69-mile marker. Cpl. Wallen stopped to check on the occupants and discovered a single male occupant, later identified as Jesus Torrez (offender). As Cpl. approached the vehicle, Torrez had exited the driver's seat and was walking back to the rear of the vehicle. Torrez was very unsteady on his feet and his clothing appeared very disheveled with the zipper of his pants down. As Cpl. got closer to Torrez, he could smell a very strong odor of an alcoholic beverage coming from his mouth as he spoke and his eyes appeared

very bloodshot and watery. Torrez stated that his vehicle was out of gas, but he spoke very little English. Corrections Deputy Rivera was able to assist with translation via telephone. With Deputy Rivera's assistance, Cpl. Wallen asked Torrez to perform Standardized Field Sobriety Tests (SFSTs), and Torrez agreed.

Cpl. Wallen was able to conduct the Horizontal Gaze Nystagmus (HGN) test. Cpl. Wallen observed a lack of smooth pursuit, a distinct and sustained nystagmus at maximum deviation, the onset of nystagmus prior to forty-five degrees, and also vertical gaze nystagmus in both eyes. Cpl. was unable to conduct the Walk and Turn or the One Leg Stand for concerns of Torrez's safety as he was very unstable on his feet and it was unsafe to perform those tests on the side of the interstate for fear that he would potentially stumble into traffic. Based on observations of Torrez's physical condition, the smell of the alcoholic beverage, and Torrez's performance during the

HGN test, Cpl. concluded that Torrez was in physical control of a motor vehicle on a public roadway while under the influence of a drug or intoxicant that impaired his ability to safely operate a motor vehicle. Torrez was taken into custody without incident. While performing an inventory of Torrez's vehicle, Cpl. observed 5 open containers of 24oz Modelo Chelada brand beers in the front passenger floorboard of Torrez's vehicle. Torrez also does not possess a valid driver's license. Torrez was then transported to the Loudon County Detention Facility without incident and charged with TCA 55-10-401 Driving Under the Influence, TCA 55-10-416 Open Container Law, and TCA 55-50-301 Driving Without a License. Once at the Loudon County Detention Facility, Deputy Rivera assisted with translating the Implied Consent advisement. Torrez agreed to provide a breath sample. After 3 attempts, Torrez was unable to provide a sufficient sample for testing, and there were no measured results.

Pamela Lambert, 62, Oak Street New York, was charged with, Domestic Assault, and Misuse of 911 Emergency System.

Christina Wallen Cpl. LCSO, along with Deputy Trey Davis, responded to Cormorant Dr., Vonore, on the report of a 911 call for an unknown situation. Upon arrival, Cpl. Wallen made contact with Pam Lambert (offender) at the residence. Pam stated that she was the caretaker for her elderly mother the victim and that her mother had several medical issues. She also advised that her mother had left the residence and gone to the neighbor's house at Cormorant Dr., Vonore.

Deputy Davis and EMS personnel arrived on the scene and the Cpl. then made contact with the victim at the neighbor's residence. The victim stated that Pam does not live with her, but had arrived approximately 3 months earlier for a visit and never left. The victim showed Cpl. Wallen a visible bruise on her right hand and a fresh abrasion on her left ankle. The victim said that Pam had become angry for an unknown reason and attempted to make the victim go to bed by corralling the victim into her bedroom and forcibly taking victim's clothing off of her.

The victim was able to grab her bathrobe flee the residence and retreat to the neighbor's house for safety. Cpl. Wallen did observe that the victim was wearing her bathrobe at the time of her encounter with her. The victim further stated that Pam was "strong like a man" and was

able to easily overpower her. Based on the information provided, her observation of the victim physical injuries, and her fear of being alone Cpl. Wallen was able to determine that Pam was the primary aggressor. While speaking with the victim, Deputy Davis arrived at Cormorant Dr., Vonore. As Deputy Davis was informing Cpl. that he had advised Pam to not utilize 911 for non emergency matters, Pam called 911 again to request a supervisor immediately after being advised by Deputy Davis not to utilize the 911 system for non-emergency calls. Pam has called 911 for non-emergency reasons on 4 separate occasions over the past 48 hours. Deputy Davis and Cpl. then returned to Cormorant Dr., Vonore, and Cpl. Wallen took Pam into custody for TCA 39-13-111 Domestic Assault and TCA 7-86-316 Misuse of 911. Pam was then transported to the Loudon County Detention Facility without incident. All of the above did occur in Loudon County, TN

Guilty

Former Tennessee Wildlife Resource Agency (TWRA) Agent Travis Buchanan entered a guilty plea in Morgan County Criminal Court earlier today to theft for a several years long scheme of using his state issued card to make gas purchases for personal use. Travis Buchanan had worked as a Wildlife Officer for TWRA for nineteen years covering Morgan County where he lived with his family.

In February of 2023 TWRA officials notified their internal auditor that there appeared to be discrepancies in the amount of gasoline purchased for Bu-chanan's TWRA issued Ford F-150 pick-up truck. It was noticed that his gas purchases far exceeded the amounts needed to cover the mileage the truck was known to have traveled relative to the miles per gallon the truck was rated to achieve. The audit department examined records dating as far back as 2008 and confirmed the discrepancies. An internal investigation was begun by TWRA in March of 2023. This led to surveillance of Buchanan in the truck he had been assigned and confirmed that Buchanan appeared to be using a State of Tennessee credit card to purchase more gasoline than his truck would use, given the mileage that was reported by Buchanan.

District Attorney General Russell Johnson predicat-ed the case to the Tennessee Bureau of Investigation for further investigation. Additional surveillance was conducted that documented repeated trips by Buchanan to a gas station in Morgan County where he was observed pumping gasoline into multiple red five-gallon gas containers in the back of his truck. Buchanan used his state issued credit card to pay for this gasoline. This led to a search warrant being issued for the search of Buchanan's home where many

"We appreciate the dili-Buchanan's theft scheme of buying gas for personal use on the state issued card was confirmed. Detailed calculations were made, and the case case to its conclusion. It is was presented to the Morgan County Grand Jury on September 18th, 2023, resulting in an indictment.

As part of today's guilty plea to the theft charge, Travis Buchanan was sentenced to six years to be served on probation. He was required to make an immediate restitution payment by certified check to TWRA in the amount of \$46,000. As a result of the plea Buchanan has forfeited all rights to any pension funds and annuities that accumulated through the state retirement system. The truck that he was driving that had been held as evidence has been released back into the service of TWRA. Buchanan is forever barred from employment with the State of Tennessee.



District Attorney General Russell Johnson stated that the "TWRA worked diligently to verify the misconduct on the part of this officer who abused the trust that the Agency placed in him for so many years. It is a shame that someone would ruin an otherwise respectable career of lengthy service as a public servant in this manner on such a scheme. We are glad that through this plea immediate restitution was made as part of this plea agreement."

Assistant District Attorney General Bob Edwards handled the prosecution of this case for General Russell

Johnson's office.

(B) Sixty (60) days from the date the creditor received an actual copy of the notice to creditors if the creditor received the copy of the notice less than sixty (60) days prior to the date that is four (4) months from the date of first publication (or posting) as described in (1) (A); or

(2) Twelve (12) months from the decedent's date of death.




