David Morgan, Homeless Lenoir City, was charged with, Violation of Probation, and Mfg/Del/ Sale or Poss. of Meth.

Officer R. Miller, with the Lenoir City Police Department, was in the area of Simpson Road near a known homeless encampment attempting to locate a wanted subject. During the investigation officers came upon a tent in the woods.

Once contact was made with the tent officers made themselves known which time a female and male subject were visually observed through and opening of the tent. The officer was able to identify both the female and male subject inside of the tent due to previous encoun-

The male subject was identified as David Morgan, and the female was identified. During the investigation, the female and DAVID both advised that they had been staying in the tent for a couple weeks. A warrant check was then conducted on both the female and DAVID, where

central dispatch confirmed through the Loudon Countv Jail that DAVID had an active warrant for a violation of probation out of Loudon County General Sessions Court. Contact was made with DAVID. Once the officer advised DAVID of the warrant, he asked if he could change into warm clothes that he could wear while at the jail at which time the officer let him change. The officer visually observed DAVID remove a black coat from his body at which time the officer asked if he could search the pockets. DA-VID verbally consented to a search of his coat pockets at which time the officer located a small back container in his right coat pocket. Inside of the container was a small bag containing a crystal-like substance consistent with methamphetamine. DAVID was placed under arrest and transported to the Loudon County Jail without incident.

The approximate weight of the crystal-like substance believed to be methamphetamine along with the bag it was contained came out to be (0.85 grams).

Bryant Aguilera, 29, Mulberry Street Loudon, was charged with, Criminal Resisting Impersonation, Arrest x2, Assault, Poss. of Drug Para., Aggravated Criminal Trespassing, Evading Arrest, Criminal Trespassing, and Violation of Probation x2.

Deputy B. McCall LCSO, responded to Mulberry Street to serve a civil summons. Upon arrival, the deputy made contact with a female who stated that Bryant was home and that she would go get him. Mr. Aguilera came to the front door of the residence, at which time the deputy explained to him that he had paperwork for him from Monroe County Juvenile Court. Loudon County 911 Dispatch then informed the deputy that Mr.

Aguilera had two active warrants out of Loudon County Criminal Court for Violation of Probation (2018-CR-78 & 2023-CR-28) and was wanted out of Forsyth County, GA, for Violation of Probation. The deputy asked Mr. Aguilera to step out onto the porch, but he claimed to be someone named Martin and stated that Bryant had died in Chattanooga. Based on prior knowledge of Mr. Aguilera, I recognized him as Bryant and instructed him once again to step out of the residence. Mr. Aguilera then retreated into the house, exited through the back door, and ran into a neighbor's house. The deputy immediately called for backup and attempted to get Mr. Aguilera to leave the neighbor's house. Shortly after, additional officers arrived on scene, and Mr. Aguilera fled

from the neighbor's house, jacket pockets. initiating a brief foot pursuit. The deputy overheard Officer that Mr. Aguilera did not custody.



6 and that Kelley distributed this list - along with videos containing images of certain FBI employees identified on the list - to a co-conspirator as part of his "mission."

A cooperating defendant, previously pleaded guilty to his role in the conspiracy, testified that he and Kelley planned attacks on the Knoxville FBI office using car bombs and incendiary devices appended to drones. He also testified that the conspirators strategized about assassinating FBI employees in their homes and in public places such as movie

theaters.

At trial, the United States introduced recordings of the defendant calling for the development of a "course of action" related to his plan. In one such recording, the defendant gave the instructions to, among other things. "start it," "attack," and "take out their office" in the event of his arrest. Kelley was recorded stating: "Every hit defendant in this case was has to hurt. Every hit has to hurt.

"The safety of our men and women in law enforcement is of paramount concern," said United States Attorney Francis M. Hamilton III. "There

is simply no room in society for those who would engage in this kind of reprehensible conduct and threaten to assassinate FBI agents and others who are honorably serving to uphold the law. and this office will pursue all such threats against civil servants working for the public good."

"The danger posed by the very real," said Special Agent in Charge Joe Carrico of the FBI Nashville Field Office. "Today's guilty verdict is a culmination of the tireless efforts of our dedicated employees and the invaluable partnership we have with our law enforcement partners. The FBI remains steadfast in its mission to protect the nation from threats of violent extremism.

Assistant U.S. Attorneys Casey T, Arrowood and Kyle J. Wilson of the Eastern District of Tennessee prosecuted

the case with the assistance of Trial Attorneys Jacob Warren, Tanya Senanayake, and David Smith of the National Security Division's Counterterrorism Section. Valuable assistance was provided by the U.S. Attorney's Office for the District of Columbia.

The case was investigated by the Knoxville Joint Terrorism Task Force, which is composed of federal, state. and local law enforcement agencies. It was led by the FBI and involved the assistance of FBI offices from across the country.






