

Angelina Noce, 43, Dennis Drive Kingston, was charged with Mfg/Del/Sale or Poss. of Meth, Simple Possession, and Possession of Drug Para.

William White, 48, Dennis Drive Kingston, was charged with Simple Possession, and Poss. of Drug Para.

Officer R. Miller, with the Lenoir City Police Department, initiated a traffic stop on a Nissan Armada in the back parking lot of CVS in Lenoir City, TN for a window tint violation. Upon the traffic stop the windows registered at 16%. The driver of the vehicle was then identified as Angelina Noce and the rear seat passenger was identified as William White Jr. The officer then had NOCE step out of the vehicle to speak with her further about the win-

dow tint violation and citation. While speaking with NOCE the officer learned that WHITE was currently on state probation and noticed that he was nervous upon the officer initial contact with him. While conducting his business regarding writing my citation and running both drivers' licenses through dispatch, NOCE admitted to having a marijuana pipe in the front cup holder of the vehicle at which time she handed it to Inv. John Yates who was on scene assisting. The officer then had WHITE step out of the vehicle to conduct a probable cause search of the vehicle. During the subsequent search of the vehicle, the officer located a green cigarette carton inside of NOCE'S purse that contained her debit card with her name on it along with a clear bag containing a crystal-like substance believed

to be methamphetamine and a clear bag containing a cut straw which contained crystal-like residue believed to be residue from methamphetamine. The approximate weight of the crystal-like substance was (0.44 grams). Located in the trunk of the vehicle was a green bag that contained approximately (2.77 grams) of a

green leafy substance believed to be manjuana along with a metal grinder that was inside of a blue metal cylinder container. During the investigation both WHITE and NOCE were mirandized at which time they both stated they knew about the green leafy substance believed to be marijuana.

Theresa Morton, 55, Forest Heights Lenoir City, was charged with Mfg/Del/Sale or Poss. of Meth, and Tampering/Fabricating with Evidence.

Officer Parmer LCPD, was stationary on Creekwood Park Blvd when he heard a loud vehicle approaching him. The officer observed a white Honda Accord, bearing TN tag 638BGRT, traveling west on Creekwood Park Blvd and determined that the loud exhaust noise was coming from it. Once behind the vehicle, the officer observed it to have 1 operable registration light, however, it was positioned in a way that it was not illuminating any of the registration. The officer initiated a stop on the vehicle at Adesa Pkwy and Cotton Mill Blvd, where the officer made contact with the driver, identified as 55-year-old Theresa Morton. The officer inquired about the loud exhaust on the vehicle and Ms. Morton informed him that the vehicle was not equipped with a catalytic converter. While speaking with Ms. Morton, the officer observed her to show signs of nervous behavior. The officer went back to his patrol vehicle and ran Ms. Morton through Central Dispatch, to which the officer was informed that she had a suspended driver's license. The officer requested that Ms. Morton step out of the vehicle, and once out, the officer asked her for consent to search the vehicle, to which she consented. While searching the vehicle, the officer observed a small "dime" bag, containing a white, crystal-like substance, floating in-

side an open Coke bottle. The officer also located a cut straw, commonly used for ingesting narcotics, floating inside a foam cup containing a beverage. Upon further search of the vehicle, the officer located 2 more "dime" bags, containing a white, crystal-like substance, inside Ms. Morton's purse. The total weight of all 3 bags was 1.24 grams. Ms. Morton was mirandized, and

she stated that she had the Methamphetamine and the straw in her hand when the officer initiated a traffic stop, and when he went back to my patrol vehicle, she hid the narcotics and paraphernalia so the officer would not find it. Ms. Morton was subsequently arrested and transported to the Loudon County Jail. The above did occur in Loudon County, Tennessee



FBI, since laser strikes can distract or cause physical damage to pilots, he said. When laser beams hit cockpit windows, the glare they create can cause flash blindness, a condition in which vision is affected after exposure to the source of light, Gates explained. The FBI Los Angeles images below depict what that glare looks like from the pilot's perspective.

"The last thing that we really want as a society is for people flying helicopters or planes to be blinded any time, but specifically when they're trying to land and take off," Gates said.


The issue of laser strikes can also have a counterterrorism nexus. Sometimes, the FBI needs to determine whether someone purposefully aimed a laser at an aircraft in an attempt to bring it down, explained Supervisory Special Agent Melissa Ventresca. She leads the International Counterterrorism Squad at FBI San Antonio's satellite office in Austin, Texas,

which also covers Austin-Bergstrom International Airport.

The Science Behind the Risk Laser pointers don't need to be pointed directly into a pilot's eye to do damage, Gates explained.

"If you're on the ground aiming a laser pointer at a plane or a helicopter, it's not just that little tiny point," he said. Once a laser beam reaches the aircraft, cockpit windows reflect it, filling the space with blinding light. "By the time it reaches the cockpit and the pilot is looking out, that beam of light might be the size of a watermelon or a cantaloupe," Gates explained.

And, according to the FAA, laser beams-and their reflections—can be especially dangerous to pilots if they pop into their fields of view while they have their sights set on something far away-such as a run-

"Laser exposure is most hazardous when a direct laser beam, or its specular (mirrorlike) reflection, enters the pupil along the axis of vision when the eye is focused on a distant object," the FAA writes. "The energy density of the laser beam can be intensified up to 100,000 times by the focusing action of

The further the laser is from

an aircraft, the wider the light beam grows.

When FBI agents seize laser pointers used in these kinds of strikes, Gates says, they give the pointers to physicists and other laser specialists for scientific analysis. These experts then determine that laser's strength and chart out the relative diameter of its beam based on the distance between the laser pointer and the aircraft it targeted.

And because of how the human eye perceives light, green is the most dangerous color of laser that an aircraft can be struck with, an FAA brochure explains. The FBI most often hears reports of strikes by green and purple beams, Gates noted.

If an aircraft is hit with a laser, the best-case scenario would be a distracted pilot, which could still lead to "any number of errors," Ventresca said. But if a laser strike damages pilots' retinas and corneas, that could cause them to make "all sorts of other failures that could be catastrophic," potentially resulting in "a mass casualty event," she said

"If we can prevent one ca-

tastrophe, prevent one pilot from being blinded, that makes it worth it." Melissa Ventresca, supervisory special agent, FBI San Antonio

Investigating Laser Strikes

The first federal laser law was enacted in 2012, when Congress passed it as part of the reauthorization of the Federal Aviation Administration.


Before 2012, the Bureau pursued laser pointer investigations under a law forbidding "destruction of an aircraft," which Gates likened to "trying to smash a square peg into the round hole.

The 2012 federal statute makes it illegal for people to "knowingly" point a laser pointer's beam "at an aircraft"whether private, commercial, or military-or its flight path. Most importantly, it attaches consequences to this action: A monetary fine of up to \$250,000 and/or a federal prison sentence of up to five years. On top of that, the FAA's website notes that it "can impose civil penalties of up to \$11,000" each time someone aims a laser beam at an

"That suddenly gave us real teeth in enforcement," Gates said of the statute. "It made shining a laser pointer at an aircraft a five-year maximum penalty felony, which is a really big





Any appeal of the trial court's final disposition of the complaint or petition for termination of parental rights will be governed by the provisions of Rule 8A, Tennessee Rules of Appellate Procedure, which imposes special time limitations for the filing of a transcript or statement of the evidence, the completion and transmission of the record on appeal, and the filing of briefs in the appellate court, as well as other special provisions for expediting the appeal. All parties must review Rule 8A, Tennessee Rules of Appellate Procedure, for information concerning the special provisions that apply to any appeal of this case.




