

Two Eastern European Organized Crime Leaders Convicted of Murder for Hire Targeting U.S.-Based Journalist on Behalf of Iranian Government

Polad Omarov and Rafat Amirov to Kill Masih Alinejad in Exchange for \$500,000

A federal jury returned guilty verdicts yesterday on all five counts in the superseding indictment against Rafat Amirov, also known as Farkhaddin Mirzoev, and Rome, 46, of Iran; and Polad Omarov, also known as Araz Aliyev, Polad Qaqa, and Haci Qaqa, 40, of Georgia. The de-

Iranian Government Hired fendants were convicted of murder-for-hire and attempted murder in aid of racketeering charges, in a trial before U.S. District Judge Colleen Mc-Mahon. Amirov and Omarov are scheduled to be sentenced on Sept. 17.

"The Iranian regime's brazen plot to silence and murder Americans will not be tolerated," said Sue J. Bai, head of the Justice Department's

Justin Gooslin, 40,Glennleigh Court Knoxville, was charged with, DUI, and Mfg/ Del/Sale or Poss. Meth.

Cpl. Christina Wallen LCSO, along with Deputy Ryne Miller and Deputy Ransom Knight, responded to the area of Hwy 70 and Hwy 321 in an attempt to locate a reckless driver. The complainant advised that they were traveling behind a gray Lexus sedan that was driving recklessly and heading toward Hwy 321 on Hwy 70 near Wampler's Sausage. Deputy Miller was able to locate the vehicle and conducted a traffic stop at Bimbo's gas station. (See supplement for vehicle in motion and traffic stop.) Upon arrival on the scene, the deputy made contact with the offender, Justin Gooslin. Gooslin appeared very lethargic with slurred speech and delayed and/ or incomplete responses, his shirt was on inside out, and his travel itinerary accounts did not make any sense. Gooslin advised that he was coming from Clinton, TN to pick up his roommate, but he was coming from the Kingston area. Gooslin was not able to clearly answer when the last time he slept was, stating that he awoke at 0500hrs on this date and went back to sleep, but he was unable to recall what time he woke from his second slumber. Gooslin believed that it was around 2230hrs. Gooslin said that he was really tired and that

he had consumed a THC gummy just two hours prior to driving. The deputy requested that Gooslin submit to Standardized Field Sobriety Testing (SFSTs), and Gooslin consented. During the HGN, the deputy observed a distinct and sustained nystagmus at maximum deviation in the right eye, and onset prior to 45 degrees in the right eye. Gooslin was unable to perform the Walk and Turn after several attempts to give Gooslin the instructions, and Gooslin demonstrated difficulty with understanding and following simple instructions. When asked about the highest level of education that Gooslin had completed. Gooslin advised that he had obtained a Masters degree. The deputy then conducted Advanced Roadside Impaired Driving Enforcement (ARIDE) tests. During the Lack of Convergence test, both eyes began to converge, however, the right eye bounced down and back out. During the Modified Rhomburg, the deputy observed Gooslin swaying approximately 1-2 inches forward and back, and Gooslin had his eyes closed for 64 seconds. For the Finger to Nose test, Gooslin was unable to follow the instructions after multiple attempts to demonstrate and instruct the test. Based on Deputy Miller's account of his observation of the vehicle in motion, my observation of Gooslin's physical condition, Gooslin's admission to consuming THC gummies, and Gooslin's performance on the SFSTs and ARIDE tests, the deputy was able

to conclude that Gooslin was in physical control of a motor vehicle on a public roadway while under the influence of a drug or into vicant that impaired his ability to safely operate a motor vehicle. Gooslin was then taken into custody without incident. Gooslin was handcuffed behind his back and the cuffs were checked for proper fit before double locking to prevent tightening. Gooslin was read the Implied Consent Advisement form and he agreed to provide a blood sample for chemical testing. Gooslin was then transported to the Fort Loudoun Medical Center Emergency Department to complete the blood draw without incident. After the blood draw was completed, the deputy escorted Gooslin to the patrol vehicle for transport to the Loudon County Detention Facility. As Gooslin was entering the rear of the patrol unit, the deputy

observed a small baggie fall from the inside Gooslin's right pants leg as he lifted his leg to enter the vehicle. The deputy retrieved the baggie and noted that it contained a white crystal-like substance that is believed to be methamphetamine. Gooslin denied ownership or possession of the baggie and contents. Gooslin was then transported to the Loudon County Detention Facility without incident. Gooslin has been charged with violation of TCA 55-10-401 Driving Under the Influence and TCA 39-17-434 Possession of Methamphetamine. Gooslin does not have any minor children in his care who will be left unattended due to his absence. After transport, the deputy searched the rear of the patrol unit, and found no other contraband. All of the above did occur in Loudon County, TN.



National Security Division. "This verdict underscores the Department's commitment to finding and holding accountable those who threaten our citizens and our freedoms. With the great work of our prosecutors and law enforcement partners, we are now one step closer to justice."

For years, the Government of Iran has attempted to silence an outspoken Iranian journalist, author, activist and critic of their regime through any means necessary, including harassment, violence, intimidation, and even attempted murder," said Acting U.S. Attorney Matthew Podolsky for the Southern District of New York. "Chillingly, the plot to murder this Iranian dissident culminated over 6,000 miles from Iran, on U.S. soil, right here in New York, when a hitman with an AK-47 camped outside her home to kill her. I commend the career prosecutors of this office, and our law enforcement partners at the FBI's Counterintelligence Division for their tireless work in bringing these defendants to justice. This verdict should send a clear message around the world; if you target U.S. citizens, we will find you, no matter where you are, and bring you to justice.

The defendants participated in a brazen plot to kill an Îranian American dissident in New York who criticized the regime in Iran," said Acting Assistant Director Roman Rozhavsky of the FBI's Counterintelligence Division. Thanks to the good work of the FBI and our partners their plan failed. This verdict demonstrates the FBI will not tolerate Iran's attempts to threaten, silence, or harm American citizens."

According to court documents, Amirov and Omarov were high-ranking members of an Eastern European organized crime group (the Organization) who worked with other members of the Organization to attempt to kill Masih Alinejad on instructions from high-ranking members of the Islamic Revolutionary Guard Corps (IRGC). Alinejad has previously been the target of plots by the Government of Iran to intimidate, harass, and kidnap her for her work as a journalist, author, and human rights activist who has publicized the Government of Iran's human rights abuses around the world. As recently as 2020 and 2021, Iranian intelligence officials and assets plotted to kidnap Alinejad from within the U.S. for rendition to Iran in an effort to silence her criticism of the Iranian regime.

After these brazen efforts to kidnap Alinejad from the U.S. failed, the IRGC turned to Amirov and Omarov to locate, surveil, and murder her. Beginning in approximately July 2022, Amirov sent targeting information which he had received directly from IRGC officials in Iran—about Aline

jad to Omarov. In turn, Omarov communicated this information to Khalid Mehdiyev, another member of the ation who had been residing in . New York, so that Mehdiyev arveil Alinejad and murder her. In ..., Mehdiyev sent photographs and ideos of Alinejad's residence to Omarov, who shared these materials with Amirov and the IRGC officials who orchestrated the plot in Iran. Amirov and Omarov then arranged for



a \$30,000 cash payment to Mehdiyev, who used a portion of this payment to buy an AK-47 style assault rifle, two magazines, and at least 66 rounds of ammunition; as Mehdiyev boasted in electronic communications, a "war machine" he could use to kill Alinejad.

In late July 2022, Mehdiyev repeatedly traveled to Alinejad's neighborhood to surveil her. Mehdiyev sent reports of his surveillance to Omarov, who passed them to Amirov. On July 24, 2022, Mehdiyev reported to Omarov from Alinejad's residence that he was "at the crime scene." On July 27, 2022, Omarov told Amirov that Mehdiyev was ready to kill Alinejad, writing "this matter will be over today. I told them to make a birthday present for me. I pressured them, they will sleep there this night." On July 28, 2022, Mehdiyev sent Omarov a video taken from inside the car that Mehdiyev was driving with the assault rifle and a message reading "we are ready." Amirov sent an image of the interior of Alinejad's home to Omarov to be forwarded to Mehdiyev, writing "this is the house where she stays." As is the house where she stays. Omarov continued to update Amirov about Mehdiyev's readiness, Amirov cautioned Omarov "let him keep the car clean." When Mehdiyev subsequently drove from where he was surveilling the residence, he was stopped

after a traffic violation and, during a subsequent search of the vehicle, police officers found the assault rifle, 66 rounds of ammunition, approximately \$1,100 in cash, and a black ski mask.

After Mehdiyev was arrested and placed into custody, Omarov contacted Mehdiyev's mother and threatened to kill her and her other son if she did not locate Mehdiyev.

Amirov and Omarov were convicted on five counts: murder-forhire, which carries a maximum penalty of 10 years in prison (Count One); conspiracy to commit murderfor-hire, which carries a maximum penalty of 10 years in prison (Count Two); conspiracy to commit money laundering, which carries a maxi-mum penalty of 20 years in prison (Count Three); attempted murder in aid of racketeering, which carries a maximum penalty of 10 years in prison (Count Four); and possession and use of a firearm in connection with the attempted murder, which carries a maximum penalty of life in prison and a mandatory minimum penalty of

five years in prison (Count Five). The FBI New York Field Office Counterintelligence-Cyber Division and the New York FBI Iran Threat Task Force are investigating the case, with assistance from the New York City Police Department (NYPD) and the NYPD Intelligence Bureau. The

Department of Justice's Office of International Affairs provided valuable assistance. The Justice Department thanked the authorities in the Czech Republic for their assistance.

Assistant U.S. Attorneys Michael D. Lockard, Jacob H. Gutwillig, and Matthew J.C. Hellman for the Southem District of New York are prosecuting the case with assistance from paralegal specialist Owen Foley and Trial Attorneys Christopher Rigali and Leslie Esbrook of the National Security Division's Counterintelligence and Export Control Section.

The most frustrating part about this is that even the people you turn to for help will transform the situation into an even bigger mess. Instead of finding relief, you may find more complications and misunderstandings. Perhaps you need to take the situation into your own hands and deal with it yourself.




