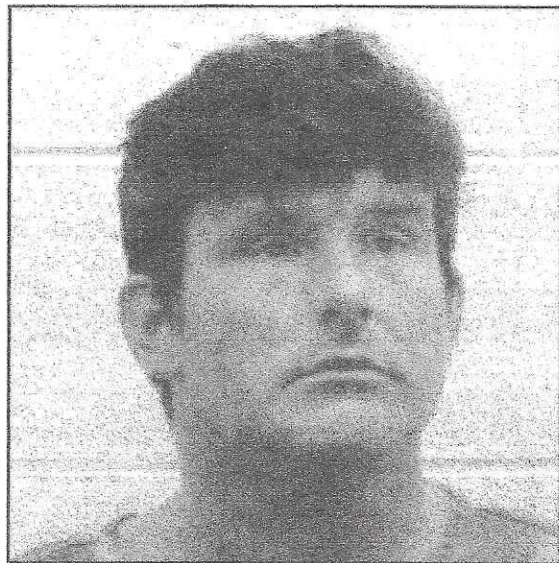

State Rep. Lowell Russell announces two local rescue squads to receive grant funding

State Rep. Lowell Russell, R-Vonore, announced two local rescue squads have received grant funding from the Tennessee Rescue Squad Grant Program.

The Monroe County Rescue Squad and the Greenback Emergency Rescue Squad were two of 95 rescue squads selected to receive grants totaling \$3 million in 2025.

“These grants help alleviate the significant cost of lifesaving equipment for rescue squads

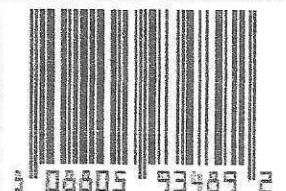

Brayan Corona, 20, River-view Road Lenoir City, was charged with, DUI, Violation of Implied Consent, Financial Responsibility, and License Required.

Deputy B. McCall LCFSO, along with Deputy K. Pood, responded to the area of southbound Interstate 75. Loudon County 911 Dispatch advised that the complainant reported a burgundy Chevy Camaro traveling southbound at approximately 80 MPH, swerving across the roadway and almost striking other motorists. The complainant also stated that the Camaro pulled over at mile marker 75, at which point the complainant continued on their way. Upon arrival, the deputy observed a Chevy Camaro matching the description given by dispatch, parked halfway on the shoulder and halfway on the grass. The vehicle's lights were off, and a male occupant was sitting in the driver's seat, holding the vehicle keys in his hand. Despite the activated emergency lights, the male was unaware of the deputy presence and had to be alerted by knocking

on the side of the vehicle. The male then opened the driver's door. Upon making contact with the driver, later identified as Brayan Jesus Gallardo Corona, the deputy immediately detected the smell of an alcoholic beverage emanating from the vehicle. Mr. Gallardo Corona also had red, watery eyes. the deputy requested his driver's license, insurance, and vehicle registration. In response, he handed him his Mexican passport. The deputy asked Mr. Gallardo Corona to step out of the vehicle for further investigation, to which he complied, although he needed to be redirected several times to follow his instructions. While speaking with Mr. Gallardo Corona, the deputy again detected the smell of alcohol on his breath. The deputy asked him how much he had to drink, but he denied consuming any alcohol. The deputy then asked Mr. Gallardo Corona if he could conduct Standardized Field Sobriety Tests, which he refused. During the stop, Mr. Gallardo's wife arrived on the scene and was on the phone with him throughout the duration of the investigation. Dispatch confirmed that

Mr. Gallardo did not have a valid driver's license and that the vehicle's insurance was unconfirmed. The deputy read Mr. Gallardo Corona the Tennessee Implied Consent Law, to which he refused. Based on the totality of the circumstances, the deputy placed Brayan Gallardo Corona under arrest for Driving Under the Infl-

ence, Violation of Implied Consent, and Driving Without a License. He was transported to the Loudon County Detention Center. The driver was also cited for Financial Responsibility. The vehicle was towed from the scene by James Towing. This incident occurred in Loudon County, TN

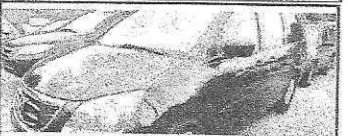

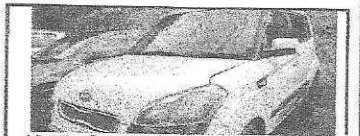

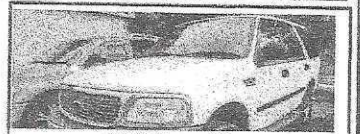

across the Volunteer State and I was thrilled to learn two of our own were awarded funding," Russell said. "Thank you to the State Fire Marshal's Office and the Tennessee Department of Commerce and Insurance for supporting our community."

The 113th General Assembly approved \$3 million in grant

funding to help Tennessee rescue squads purchase lifesaving equipment. Rescue squads provide a range of specialized services including extrication, structural collapse response and swift water rescue.

Awards are administered by the Tennessee Department of Commerce and Insurance (TDCI) and the Tennessee State Fire Marshal's Office (SFMO).

Grantees are able to purchase equipment for incident response and to protect the lives of rescue squad members.

The SFMO said they received 149 applications from rescue squads across the Volunteer State during the month-long application window. The applications were reviewed, scored and submitted to a seven-member

committee for the final award selection.

For information on the grant process and how to apply during the next application period, the SMFO asked squads to contact them at SFMO.grants@tn.gov to learn more.
