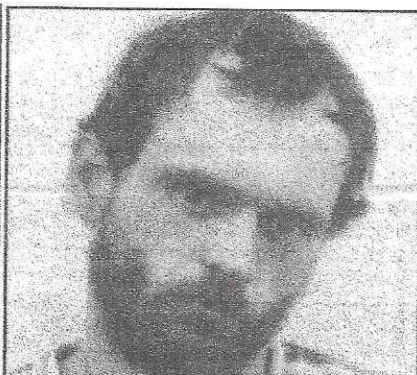

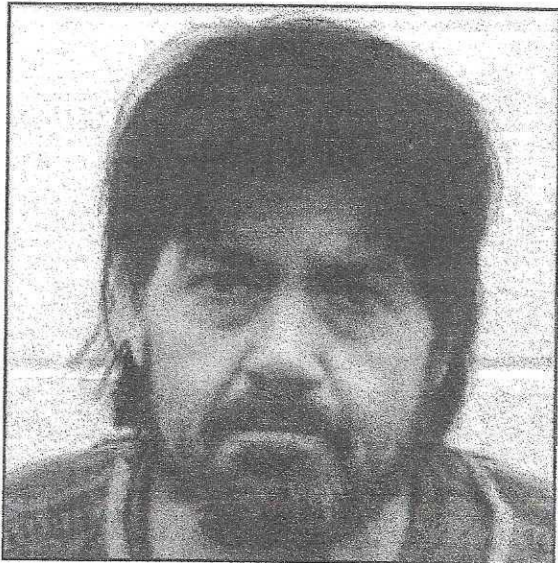

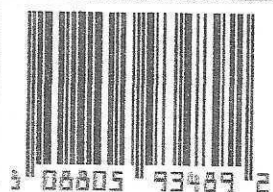

Patrick Vought, 27, Abbott Road Lenoir City, was charged with, DUI, Violation of Implied Consent, Simple Possession, Poss. of Drug Para., and Lights Required on Motor Vehicle.

Trooper M. Snyder THP, observed a silver vehicle with its driver side headlight out traveling on highway 70 near highway 321, while he was stationary on highway 70. The trooper initiated a traffic stop on the vehicle near Holbrook Ave. The trooper ask the driver for his license and registration, which he provided. The driver was identified as Patrick Vought. The trooper ask the passenger for identification, she denied having any but provided a social security number. Upon running the SS. number she was identified as Tabitha Degarmo, which showed her to have an active warrant out of Roane County. The trooper ap-

The trooper removed the needle and placed Tabitha under arrest, and placed her in his patrol vehicle. The trooper seen a bottle cap in a baggie with substance appearing to be drugs in the passenger door handle. A search of the vehicle trooper located a Hidden Hills Club THC vape and a Purple Urkle Indica THC vape in the glovebox, a burnt marijuana roach in a baggie on the driver side, a syringe, metal measuring spoon, cotton, a small gold spoon with burnt residue, and a small metal pipe in a purple bag near the rear passenger seat. Patrick was read the implied consent which he refused. Both subjects were transported to the Loudon County Jail. Once at the jail, Tabitha, was actively resisting deputies during the booking process, and refused to show the contents in her hand, jerking her hand away from deputies, and shoved her hand down the front of her jumpsuit attempting to tamper with potential evidence.

Daniel Palmer, 44, Lee Street Cleveland, was charged with, Mfg/Del/Sale or Poss. of Meth, Simple Possession, and Poss. of Drug Para.

Officer R. Miller, with the Lenoir City Police Department, initiated a traffic stop on a white Ford pickup truck in the area of Highway 321 near Trust Bank in Lenoir City, TN for the driver of the pickup truck not wearing a seatbelt. Upon the traffic stop the officer made contact with the driver, the front seat passenger, and the back seat passenger Daniel Palmer.

During the traffic stop the officer had the driver step out of the pickup truck to speak with him about a citation. During the time the officer was speaking with the driver regarding the traffic stop and citation the officer discovered that the driver was actively on state probation where the office gained verbal consent to conduct a search of the pickup truck.

The officer then had the passenger and DANIEL step out of the pickup truck. During the subsequent search of the pickup truck, the officer locat-

ed the end/bowl of a one hitter pipe which contained a burnt charred substance inside of it. The end/bowl was located in the back seat where DANIEL was sitting and had an odor of marijuana emitting from it. The officer then conducted a search of DANIEL'S person where he located a pipe which contained a brown resin and had an odor of marijuana emitting from it in his front left pocket. Located in DANIEL'S front right pocket was a metal can that contained a green leafy substance believed to be marijuana (approx. less than a gram). Located in DANIEL'S front right coin pocket was a bag that contained a crystal-like substance believed to be methamphetamine (approx. 1.31 grams) along with a glass pipe in his rear left pocket. The glass pipe located in his rear left pocket had a charred bowl and is commonly used to smoke methamphetamine with. DANIEL was placed under arrest and transported to the Loudon County Jail.

DANIEL was then read his Miranda Warning where he stated that he had used methamphetamine the majority of his life.

**Agg. Assault**

Bonifacio Severiano Campos, 33, Reeves Street Lenoir City, was charged with Aggravated Assault.

Officer H. Wilkes LCPD, responded to Wilson St in reference to a domestic. Upon arrival, the officer was presented with a language barrier and requested that Lt. C. Dragon respond to the scene to assist with translation. Officers made contact with the complainant, who was walking beside the residence and observed a female in distress on the front porch, later identified as the victim. With the assistance of Lt. C. Dragon, it was discovered that the victim boyfriend, later identified as Bonifacio Severiano Campos, arrived at the residence to drop off their child. While the victim opened the back door of the vehicle to retrieve their son, Mr. Severiano Campos drove the vehicle forward, causing the victim left foot to be run over by the vehicle. The victim stepped back with their son, and attempted to throw a rock at the vehicle while he was fleeing, but missed striking the vehicle. Officers observed bruising and swelling from the victim left foot, and subsequently requested that EMS personnel respond to the scene and evaluate her. Ultimately, the victim was transported to the Fort Loudon Medical Center for further evaluation per EMS personnel. Officers attempted to review doorbell footage or gather witness statements while on scene, but were unsuccessful. During investigation, Lt. C. Dragon was able to get Mr. Severiano Campos to respond back to the scene of the incident. Due to the aforementioned, the officer placed Mr. Severiano Campos into custody and transported him to the Loudon County Jail without further incident. Due to the totality of the circumstances, and their juvenile son being involved in this incident, a DCS referral was filed (#: 1507461294). All of the above did occur in Lenoir City,

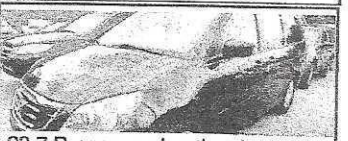

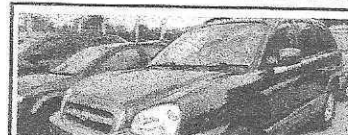

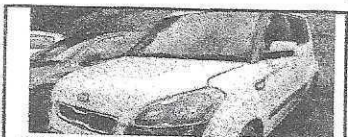

### Tennessee Guardsmen respond to Polk County Wildfire

At the request of the Tennessee Emergency Management Agency, the Tennessee Army National Guard is providing two UH-60 Blackhawk helicopters, from Knoxville's 1-230th Assault Helicopter Battalion, to support wildfire response in Polk County.

At approximately 8:30 and 8:45 a.m., CDT, both Blackhawk helicopters departed from McGhee Tyson Air National Guard Base to combat

wildfires just southeast of Turtletown, near the North Carolina border. The helicopters are focusing on areas of extreme terrain, difficult for ground firefighting crews to reach.

Each aircraft is equipped with a Bambi Bucket used to provide hundreds of gallons of water to fight fires and are prepared to deliver water from nearby water sources directly to the areas needed. They are also equipped to perform other missions to support first responders as

needed.

The Soldiers and aircrews of the Tennessee National Guard are prepared to support firefighting efforts as long as needed.
